# Maple WEEKEND

## Reed's Maple

DOWNSVILLE - Jody and Scott Reed opened a storefront on Knox Avenue, Downsville and retail pure maple syrup and maple products they produce with the help of their son Brett, and

grandchildren Brandon, Weston, Rylan and Toryn. Jody manages the well-stocked retail shop which offers maple products like syrup, cream, candy, hot sauce, barbecue sauce and sugar, in addition to other locally-sourced items.

Prior to opening the store in 2021, Jody frequented local farmers' markets throughout the year to sell maple products, in addition to retailing syrups in grocery stores around Delaware County. Opening the store was also an opportunity to promote and support the craftsmanship and creativity of her family and friends.

In addition to their maple products, they carry honey and bee's wax products from Ann Bussiere's bee hives at Shinhopple Farm, along with her natural soaps and skin care products, and homemade jams created by Janet Champlin. "I don't charge them anything to sell their products here," Jody said. "This is how it all started, us three."

Reed's Maple also stocks beaded art, bows, acorn jewelry, and carved gourd art, all locally made by friends and family. They also sell 10 types of cheeses from Country Pride Cheese in Harpersfield. "It's rare someone walks in here and doesn't find something that suits them," Jody said.


Their small business slowly continues to expand, Jody said, and credits Scott with being resourceful when it comes to repairing and replacing equipment, acquiring new equipment, and renovating their store. A hanging shelf that is used to hold maple products was once Scott's maple boiling pan, Jody said, and was repurposed as a piece that ties the homey, rustic look of Reed's Maple together. Scott currently manages 3,000 taps from the same sap bushes his grandfather tapped in the 1940s and 50s, Jody said, and has been making syrup since they first started dating over 35 years ago. "It's a generational thing," Jody said, and though their children are helpful, Jody and Scott's grandchildren are the ones who have real interest in maple syrup producing and selling.
