

## Fire up fellow football fans with smoked wings



### Virgil's Smoked Chicken Wings with Blue Cheese Dip

Serves 4

#### Blue Cheese Dip

- 2 cups blue cheese crumbles, divided
- 1 cup mayonnaise
- ½ cup buttermilk
- 2 teaspoons hot sauce
- 1 teaspoon Worcestershire sauce
- ½ teaspoon kosher salt
- ¼ cup finely chopped scallions
- ¼ cup finely chopped celery

#### Marinade

- ½ cup vegetable oil
- ½ cup hot sauce
- 4 tablespoons Virgil's Dry Rub (see below)
- 4 tablespoons granulated garlic
- 4 tablespoons granulated onion
- Juice of ½ lemon

#### Wings

- 8 large chicken wings
- 1/2 cup Virgil's Dry Rub (see below)

#### Sauce

- 10 tablespoons unsalted butter
- 1 teaspoon cornstarch
- 4 tablespoons white vinegar
- ¾ cup hot sauce
- ¼ teaspoon cayenne pepper

The Super Bowl is nearly here, and that means scores of football fans are readying themselves for a day spent fraternizing with friends and indulging in all of the great food that has become synonymous with the biggest day in American professional sports.

No football feast is complete without wings, and this year Super Bowl party hosts can satisfy their guests' needs for this beloved bar snack with the following recipe for "Virgil's Smoked Chicken Wings With Blue Cheese Dip" from Neal Corman's "Virgil's Barbecue Road Trip Cookbook" (St. Martin's Press).

1. To make the dip, combine 1 cup of the blue cheese, mayonnaise, buttermilk, hot sauce, Worcestershire sauce, and salt in the bowl of a food processor and blend on low until smooth.

2. Remove to a medium heat

mixing bowl and fold in the rest of the blue cheese, scallions and celery, being sure to break up the large blue cheese crumbles. Place in a covered container and refrigerate overnight.

3. Mix all the marinade ingredients in a large mixing bowl. Place the wings in a large container with a lid and pour the mixture over the wings. Toss until the wings are thoroughly coated. Cover and refrigerate for 2 days.

4. Preheat the grill or smoker to 245 F.

5. Spread out the wings on a sheet pan and wipe away any excess marinade. Sprinkle liberally with the dry rub, coating the wings all over.

6. Position the wings on the grill away from the direct heat of the coals or burners, and add hickory to the smoker, or hickory chips on the coals or gas burners.

7. Cook the wings for about 3 hours, flipping every 30 minutes (their internal temperature should be about 165 F when cooked).

8. While the wings are cooking, cut the butter for the sauce into 1-inch cubes and refrigerate. Whisk the cornstarch into the

white vinegar, in a small bowl.

9. In a medium sauté pan over medium heat, bring the hot sauce to a simmer and whisk in the thickened vinegar. Return to a simmer, cook for 1 minute, and remove from the heat.

10. Add the cayenne and slow-

ly wish in the cold butter. Keep warm until serving.

11. Remove the wings from the smoker or grill and put half of them into a bowl, cover with the sauce, and toss. Repeat with the remaining wings and serve on a platter, with the blue cheese dip on the side.



## Did you know?

1) Two teams are tied for the most Super Bowl titles, The New England Patriots and The Pittsburgh Steelers; who have won six Super Bowls apiece. The Dallas Cowboys and the San Francisco 49ers are close behind with five wins each.

2) Tom Brady has won the most Super Bowls, 7 total (2002, 2004, 2005, 2015, 2017, 2019, 2021).

3) There has never been a punt-return TD in Super Bowl history.

4) 49ers quarterback Brock Purdy was the 262nd and final selection in the 2022 NFL draft, earning him the nickname given each year to the player chosen with the last pick: Mr. Irrelevant.

5) Modern-day fans of the National Football League, which is one of the most popular and most-watched sports leagues in the world, may aspire to one day see their favorite teams play in-person in the Super Bowl. While there may be nothing stopping fans' favorite teams from making the big game, fans themselves might be priced out. According to Ticketmaster, the average price for a Super Bowl ticket in 2019 was \$3,295. But even that figure is something of a low estimate, as tickets to Super Bowl LIII between the New England Patriots and the Los Angeles Rams were only sold in pairs, meaning tickets cost closer to \$6,590, and that's before hefty service fees were applied. For many fans, that price is simply too high. But the average fan hasn't always been priced out of attending the NFL's annual championship game. In fact, History.com notes that the average ticket to Super Bowl I, which took place on January 15, 1967, at the Los Angeles Coliseum, was just \$12. Perhaps even more surprising to today's NFL fans? The inaugural Super Bowl did not even sell out.

6) Live sports can be wildly entertaining, giving viewers lots of ups and downs to enjoy (or endure). That emotional roller coaster has made live sports, and football

in particular, especially popular among television viewers. Data from Nielsen indicates that the National Football league was responsible for 45 of the 50 largest Nielsen-measured sports audiences in 2022. In fact, the top 32 events were all NFL games, with the 2021-22 College Football Playoff National Championship Game between Georgia and Alabama coming in at no. 33 among the year's most watched sporting events. Even the thrilling World Cup Final between Argentina and France was no match within the United States for the NFL, garnering 22.32 million viewers. By comparison, that year's Super Bowl between the Rams and Bengals attracted 99.18 million viewers. Curiously, despite baseball's designation as "America's pastime," Major League Baseball did not have a single game place among the 50 most watched sporting events of 2022.

7) January 15, 2024, marks the fifty-seventh anniversary of the first Super Bowl. Though it would be two more years before the name "Super Bowl" was used to characterize the game, what's now referred to as "Super Bowl I" was a competition between the Kansas City Chiefs of the American Football League (AFL) and the Green Bay Packers of the National Football League (NFL). Back then the game was referred to as the AFL-NFL World Championship Game, which most fans would agree does not have the same ring to it as "Super Bowl." The game was competitive in the first half, and the score was 14-10 in favor of Green Bay at halftime. But the Packers blanked the Chiefs in the second half, and the final score was 35-10 in favor of Green Bay. In a testament to just how different things were in 1967, two networks, NBC and CBS, were allowed to broadcast the game, each using their own announcers. Also noteworthy is the game was not a sellout, marking the only time that has happened in Super Bowl history.

## Repeat Matchup for Super Bowl LVIII

The Chiefs and 49ers will meet for the second time in the Super Bowl. The Chiefs won the first time, 31-20, in Super Bowl 54 in 2020.

### Here are seven other repeat Super Bowl matchups:

The Washington franchise and Miami Dolphins in Super Bowl 7 and Super Bowl 17.

The New York Giants and New England Patriots in Super Bowl 42 and Super Bowl 46.

The Philadelphia Eagles and New England Patriots in Super Bowl 39 and Super Bowl 52.


The San Francisco 49ers and Cincinnati Bengals in Super Bowl 16 and Super Bowl 23.

The New England Patriots and St. Louis/Los Angeles Rams in Super Bowl 36 and Super Bowl 53.

The Pittsburgh Steelers and Dallas Cowboys have played three times, in Super Bowl 10, Super Bowl 13 and Super Bowl 30.

The Dallas Cowboys and Buffalo Bills played in Super Bowl 27 and Super Bowl 28. It was the only rematch in consecutive years in Super Bowl history.

The Chiefs are only the third team to make four Super Bowls in a five-year span, joining the Bills, who went four straight years between 1991 and 1994, and the Patriots from 2015 to 2019.
