Attending farms will be asked to formally indicate their interest in participating in the project at that time by completing an Intent to Participate form, with an estimate of the manure they are willing to commit annually to the project services. Farms eligible for the project include those located in Delaware County or the NYC West of Hudson watershed with an existing manure storage structure (or storage structure to be implemented in the grant period), generating a minimum of 100,000 gallons of liquid manure or 100 tons of semi-solid/solid manure annually and have an up-to-date nutrient management plan. 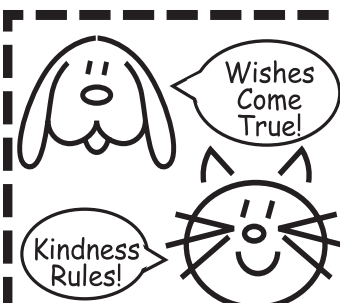
