Hearing scheduled for warehouse project

The Town of Montgomery planning board will hold a public hearing for the Draft Environmental Impact Statement (DEIS) of Project Sailfish on Jan. 7.

Located near Interstate-84 (I-84) and

the intersections of NYS Route 17K and 747, the project will turn 188 acres of vacant land into an approximately 1-million-square-foot warehouse with more than 1,000 car parking spaces and 225 truck trailer spaces, according to planning board documents.

The project also includes a wastewater

treatment plant for sanitary wastewater, a water treatment facility and water tank, stormwater management basins, accessory driveways, lighting, landscaping and signage.

The project requires a zoning map

Missing Pine Bush man found safe

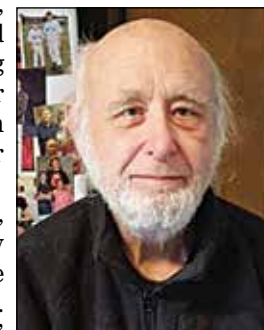
First responders and the Pine Bush community at large breathed a collective sigh of relief Sunday after a man suffering from Alzheimer's disease and reported missing a day earlier, was found safe.

William Scheinert, 79, had been reported missing early Saturday. Following a massive search, he was located Sunday morning in a house under construction near the Ulster County line.

"As reported, earlier today we were able to locate Mr. Scheinert," Crawford Police Chief Dominick Blasko reported on Facebook. "He was transported to ORMC in good condition."

"Locating him was a team effort and we were successful because of everyone's help," Blasko said. "Special thanks to the New York State Forrest Rangers, New York State Police, Orange County Sheriff's Office, Orange County Office of Emergency Management, Pine Bush Fire-Department Pine Bush Ambulance, and numerous police, Fire and search and rescue teams."

Blasko urged residents to sign up for the CodeRED notification system and "if you have an elderly person that needs monitoring for dementia or Alzheimer, contact the Orange County Office for the Aging for Operation Life Saver."

Montgomery horse farm awarded \$2 million grant



The Orange County Land Trust has been awarded a NYS Farmland Implementation Program Grant to protect a 152-acre farm in the Town of Montgomery. Willow Hill Farm is located on a bend in the Wallkill River off of Route 211. This grant will allow the Land Trust to work with the farm's owners to purchase a conservation easement that will protect the property for agricultural use. The easement will also help protect the water quality of the Wallkill River by preserving the forest along its banks. The grant award is for \$2,000,000, the maximum available through this grant program.

Walden thanks Larkin for his service

Just in time for Christmas, Walden received a present they've long been waiting to find under the tree. But in this case it wasn't Santa delivering the gift but outgoing New York State Senator William Larkin, who provided the village with \$300,000 in funding for its long-desired community center. Larkin secured the money as part of the State and Municipal Facilities Program (a SAM grant) and presented the funds to the village administration in the form of an oversized check at a ceremony on Dec. 13.

At the Village Board meeting five days later, the group expressed its gratitude towards Larkin, who is retiring at the end of the year, for obtaining a sizable chunk of the funds needed to make the community center a reality.

"Very grateful to Senator Larkin for his gift of \$300,000 towards the community center," Walden Mayor Susan Rumbold said during the meeting. "Someone asked where the rest of the money is going to come from, and I guess my answer to that is that Christmas is coming and if some kind soul would love to give me a diamond necklace I'm taking it even though I don't have the money right now to buy the earrings that match. So if somebody's going to give me a gift like that, I'm going to take it and be very grateful for it, and we will work on the rest of the funding. But thank you to Senator Larkin for his gift, I thought it was wonderful."

The village has been working for years to procure the necessary funds to build a new community center in James W. Olley Community Park that would serve as a gathering spot for local residents. The grant from Larkin should cover nearly half of the money needed to build the proposed center. "The senator has discretionary funds and he used part of those to give us the grant towards the community center," Village Manager John Revella said. "We know that the budget for the community center is around \$650,000, so we wanted to try to get around half. We know that we have some projects at work in the village that would be contributing parkland use funds towards the village, which should be enough to match and complete the project. It's not a matching grant, so if we can't we may have to bond for some of the funds towards it as well."

The village requested the funds from Larkin's office, and this time it came through after previous attempts to get state funding over the years have not been granted. The plans for the community center date back nearly a decade,

though the final details still have to be crafted. "We proposed it in our 2010-2012 comprehensive plan, it was in there in the park section," Revella said. "There's no final blueprints because we haven't spent that kind of money on it yet. We have the preliminary information of what it would be, what it would cost and the location."

The timeline for getting a shovel into the ground to start building the center still has to be hammered out, but according to the terms of the SAM grant, the earliest start date is still more than a year away. "The grant monies won't even be available until probably the spring of 2020," Revella explained. "So we're looking at a project in the spring or early summer of 2020."

During Tuesday's meeting, the board set a public hearing for its next session on Jan. 15 for Local Law No. 9 of 2018 to amend the Village Planning Board and the Village Zoning Board of Appeals mailing protocols. Under the current code, applicants must mail a notice of every appeal for a variance to the owners of certain designated properties by certified mail and also publish a notice of the appeal in the newspaper.

Under the amended law, which is still

being crafted by Village Attorney Dave Donovan to meet the board's requests, the village will take over the mailing process, as residents will no longer be obligated to send out the mailings themselves.

"Such notice shall be by first-class mail in envelopes which have been addressed and on which required first-class postage has been paid for and affixed by the applicant, to be mailed by the Board Secretary or other employee or of Officer of the Village who shall complete and file with the Board listing each address to which the notice was sent," the amendment to the code reads. All costs associated with the mailing shall be set forth in the Village Fee Schedule, as may be amended from time to time, and shall be borne by the applicant."

By streamlining the process and putting it under the village umbrella, the law is designed to save applicants time on money. The notices will be mailed at least 15 days "before the date of said hearing to the owners of all property abutting that held by the applicant in the immediate area and all other owners within 300 feet," the law states.

2018 IN REVIEW

Capital projects highlight a busy year

Infrastructure work throughout the region was the face of change in 2018.

The Wallkill Valley Times spoke with area town supervisors to get their take on the year that was just completed.

Water and walking trails in Crawford

The town of Crawford was busy this year with several projects, including aesthetic improvements and the advancement of the Dwaar Kill-Pine Bush Water Supply project.

The town completed a new walking trail with access points from Ward Avenue and County Road 17. The almost two-mile trail included two parking areas.

Town Supervisor Charles Carnes said the trail was paid for through a New York state senate grant from Senator Bill Larkin's office and town reserve funds.

The trail provides excellent views of the Shawangunk mountains and exercise for the town's residents, Carnes said.

The town park was improved with new bathrooms and an upgraded area for concerts.

The town highway department also obtained a new tractor/backhoe and new trucks.

The town passed a budget that stayed under the tax cap for the seventh year in a row, with a minimal tax increase of less than 1 percent.

The first phase of the Dwaar Kill-Pine Bush Water Supply System was completed, which includes the testing of three production wells at the Dwaar Kill wellfields. Carnes said two wells will most likely be viable for quantity and quality of water.

While the town did not receive the Environmental Facilities Corporation grant it needed to connect the wellfields to the Pine Bush water supply, Carnes said the town will evaluate how to improve their application and apply for the grant again in 2019.

"We didn't complete [the water line] but we're ready to go for 2019 to bring in actual construction," Carnes said.

In the meantime, Carnes said the town is evaluating the possibility of obtaining water from a private residence if the Dwaar-Kill project is cost-prohibitive.

Town government has other improvements planned for 2019 that will improve the town's aesthetics and attract businesses.

The town plans to construct a new youth field for residents and sports groups in the town park.

The town will open a Tourism and Small Business Center, which will attract and retain businesses and promote tourism. The center will allow new and/or existing business owners to contact a liaison that will connect them with all the town hall departments and feature information on nearby attractions and businesses.

The town also plans to revitalize Bullville with the help of a New York state senate \$125,000 grant issued through Senator Bill Larkin's office. Landscaping and lighting

improvements will beautify the area, hopefully attracting new businesses," Carnes said.

"Between the water loop, Bullville and that new field, that will keep us really busy," Carnes said.

New website in Gardiner

Gardiner town government has been hard at work this year with several building projects, new town board legislation and a zoning code audit.

"We have been very active," Town Supervisor Marybeth Majestic said. "There is lots to be done."

The town received a \$100,000 state aid municipal grant through Senator John Bonacic's office to redeck the Forest Glen Road bridge. Majestic Park received a new pavilion.

The town board passed a 2019 budget that stayed under the tax cap.

With the help of LACE photo media, the town recently launched a new, easier-to-navigate website.

The town board passed a local law that established the town planning board. The board also dissolved and created a new ethics law.

The town updated the sewer map so that new lots in the hamlet have sewer lot numbers, making it easier for developers.

The town recognized the need for an expansion of the hamlet sewer district, which is at capacity. The 2004 Master Plan notes that the sewer district needs to be expanded to allow economic development and growth in

the hamlet.

The town hired a firm to investigate the plant and make recommendations for next steps. Majestic said the town will attempt to find funding for the expansion in 2019.

"It's a big project that we have in front of us," Majestic said.

The town board began its zoning code audit. The town comprehensive plan recommends the town complete periodic reviews of existing uses, including tourism uses, and an evaluation of new proposed land uses in the zoning code.

Majestic said the code hasn't been reviewed since it was adopted in 2008.

The town board started the audit first with the code for tourist activities. The board passed a six-month moratorium on Dec. 11 for new applications for tourism-related facilities, allowing the board to review and revise definitions related to tourist facilities.

The board will also address ambiguity on accessory apartments in two and five-acre zones in its audit.

Majestic said the town board would like to regulate short-term rental units with a stand-alone law in 2019. The use could not have been anticipated when the zoning code was adopted in 2008.

The town also revived the Open Space Commission, a board that advises the town board in protecting undeveloped land and natural and cultural resources as defined in the town's Open Space Plan. The commission

will continue its work in 2019 and identify conservation easements in the town.

The town received funding from the Ulster County Transportation Council's Transportation Improvement Program to replace the Clove Road bridge. Construction on the bridge will be commenced in 2019.

In 2019, the town plans to finish work on the pole barn, adopt a fund balance policy and adopt a new finance software management package.

Winchell completes first year

Supervisor Rodney Winchell has had a busy first year in 2018.

Winchell began his term on Dec. 26, 2017. He replaced Michael Hayes, who had served as town supervisor for 10 years.

The first large project of the year was to secure town hall by fixing inoperable door locks and latches. A police officer was stationed at the front desk to increase security of the building and keep track of how many people are in the building in case of emergency.

The Winchell administration then set its sights on building 112, a vacant building connected to the town hall by a breezeway. The building had been vacant and in disrepair for years, with missing bathroom and ceiling tiles, piles of junk and a broken HVAC system. Twenty seven tons of debris were cleared out of town hall, eliminating fire and safety issues.

The administration also put out to bid roof replacements on both buildings at town hall this month. The defunct HVAC system on building 112 was removed on Dec. 12, which will allow the building to receive a new roof.

Winchell said he plans to complete interior construction in the Spring and have the building operational by the end of 2019 or early 2020. He plans to place the police department and an expanded courtroom in the first floor and expand the planning, zoning and supervisor's offices into the second floor. There will also be expanded meeting rooms in the second floor.

The administration completed the first phase of the Benedict Farm House renovation through interior demolitions. Located in Benedict Farm Park, the house had been in disrepair for many years.

The town replaced its older fleet with a new fleet of leased vehicles and installed new lights in the town hall parking lot.

The administration conducted an operational review of the town's financial policies and procedures with the help of accountants from RBT CPAs, LLC. After

finding \$9 million in cash spread out over several funds, the administration passed a budget with several new initiatives and no change in taxes.

"My main thing is keeping government small and efficient and keeping taxes down," Winchell said.

The review also prompted the creation of a town accountant and six new departments in the new budget: IT, cleaning, exterior maintenance, parks and recreation, finance and structural engineering.

The administration also appointed people to fill vacant positions on several town boards, including the ethics board, the planning board, the historic preservation commission, the conservation advisory council, and the zoning board of appeals.

The highway department received a new salt dome, replacing the previous dilapidated structure. The 6,300-square-foot structure can hold approximately 3,850 tons of salt.

Winchell said he wants to focus on water and sewer in 2019 by consolidating the various water and sewer districts in the town. A more cohesive, comprehensive water and sewer system will foster economic growth because it will make it easier for commercial businesses to build in the town.

"Water and sewer is a big issue," Winchell said.

The town engineer, Mike Aiello, Jr., is currently planning the complete replacement and expansion of the facility for the special district in Neelytown Road. The renovation will double the plant's current capacity from 150,000 gallons a day to 300,000 gallons, allowing new projects to hook into the plant.

The current plant is nearing capacity while six more projects will eventually be added to the facility. Construction is expected to begin in 2019.

New sidewalks in Wallkill

The Shawangunk town government was hard at work this year with several infrastructure improvements and town board initiatives.

Wallkill received sidewalk replacements at Bridge, Main and Center Streets, a \$1.5 million project that was the culmination of nine years of work. Completed in July, 95 percent of the project was covered through grants, Town Supervisor John Valk, Jr. said.

The town placed a septic system at the pavilion in Galeville park.

The police department hired two additional school resource officers.

The highway superintendent paved several streets, an on-going project in Wallkill.

"That's the goal for next year, to continue to do more," Valk said. "They were falling into disrepair."

The town passed a 2019 budget that stayed under the tax cap.

The town declared itself a Climate Smart community, a network of New York communities engaged in reducing greenhouse gas emissions and improving climate resilience. The New York State Department of Environmental Conservation provides financial assistance and guidance for local governments on best climate practices.

The town also started to update its comprehensive plan, a process that will continue into 2019. Adopted in 2003, the plan provides an overall direction for growth and development in the town. Once adopted, the plan becomes the legal basis by which the town creates or

amends its zoning code.

The town received a \$10,000 grant to complete the update. Valk said the plan will include a study of the hamlet of Wallkill.

"We're concentrating on that and what people want to see the hamlet grow as in the next few years," Valk said.

In 2019, Valk said the town will continue to complete capital projects in the town's parks. The town received a grant to put ceilings on the pavilions of Popp Park and Verkeerderkill Park. Opened nine years ago, the Rail Trail will also receive improvements.

"It's to maintain our assets so they don't fall into disrepair," Valk said.

Gardiner forming senior citizens committee

The Gardiner Town Board and the Gardiner Senior Resource Committee (GSRC) are searching for interested citizens to form a committee that will address problems facing Gardiner seniors.

The committee will address issues in transportation, housing, medical needs, shopping, recreation, safety and other issues. It will search for solutions consistent with the town's Comprehensive Plan.

"The main goal of the committee is to improve facilities and services to seniors in the Gardiner area, so that they will stay here and live in their homes for as long as possible," GSRC member Stephen Weir said. "We really want to tackle isolation caused by the lack of socialization."

Weir said one issue the committee might focus on is obtaining a senior center for the town, which currently doesn't have one. The committee might consider a grant for a space in the Gardiner Library or a separate building.

The committee will also focus on attracting medical professionals to the town, eliminating the need to go to Kingston, Poughkeepsie, Newburgh or Middletown. The town currently does not have a doctor or dentist.

The committee will also attempt to attract affordable senior housing and/or a small mall housing a grocery store, medical offices and more.

With many seniors not covered by Ulster County's Neighbor to Neighbor program—a transportation service that provides rides for seniors to medical appointments and shopping—the committee would like to attract a Gardiner-based taxi service.

Town Supervisor Marybeth Majestic said seniors are a wonderful asset to have in the town.

"Seniors are a really good resource in the town. They don't put any children in the school district, they have hours that there're willing to volunteer. They have a little bit of a disposable income," Majestic said. "So, it's nice to have them, but we'd like to keep them as well."

The GSRC was formed about 12 years ago to hold periodic forums concentrating on senior issues, such

as elder law, health and diet, recreation and exercise, volunteer activities, etc.

Weir said in the past few years, many seniors complained about the lack of some services in the area. The GSRC then queried 40 towns and villages of comparable populations as to what services they offered for seniors and compared those results to what Gardiner provides. The GSRC presented their findings to the town board, who agreed a committee was needed to find solutions for the problems facing seniors.

The GSRC is seeking volunteers who have experienced problems or obtained solutions in the areas the committee will tackle, such as Gardiner Area Business Associates, town board members, county officials, caretakers, home health aides, etc.

Weir said the committee is currently gathering members and will hopefully have its first meeting in March, after which it will break out into taskforces.

amendment to rezone 77 acres from an IB Interchange Business Zoning District to the I-2 Industrial Park-Major Access Zoning District. It also requires a lot consolidation of four lots to one and an area variance for parking space sizes.

The planning board concluded there may be significant environmental issues resulting from the project and adopted a positive declaration which reflects the need for a full EIS.

While the DEIS examined numerous environmental issues, it raised few major concerns.

The DEIS predicts no significant impacts to soils, wetlands, surface and groundwater resources, wastewater, flora and fauna, noise and air quality.

The site is ideally located for warehouse distribution due to its proximity to I-84, multiple state roads and Stewart International Airport. The document concludes the warehouse would provide economic development.

"The proposed action would service as a catalyst for economic activity. Its development is compatible with Master Plan goals and objectives. The Project Site location avoids conflict with incompatible uses. A substantial tax base would be created on what is now dormant land," the DEIS states.

The project would be isolated from other uses due to the road networks

surrounding the site, proposed setbacks from the road and the site's geography and topography. To minimize visual impacts and impacts on surrounding properties, existing natural vegetation along the boundaries of the site would remain and serve as a natural buffer.

The project will generate an increase in traffic, which will be mitigated by timing adjustments to several of the intersections with traffic lights. NYS Route 747 will be widened and a new traffic signal will be installed at the driveway accessing 747.

The project will generate an increase in stormwater run-off, which will be addressed through a Stormwater Prevention Pollution Plan.

The project will result in the demolition of the Arnot-Haber House, built circa 1820. A representative example of local Federal architecture, the cultural and historical significance of the house will be preserved through one or more mitigation measures such as historic signage, a written historic context report for educational purposes, or the salvaging of interior and exterior housing material for rehabilitation projects involving houses built in a similar style.

The full DEIS is available on Montgomery's website at townofmontgomery.com.

The public hearing will be at town hall at 7 p.m. on Jan 7. Written comment will be accepted until Jan. 17. Comments may be addressed to Suzanne Hadden, Town

Larkin wraps up a 40-year career in public service

T rue to his word, State Senator William Larkin was on the job on Dec. 31, his last day of a 40-year career in public office.

Prior to his farewell address at the Newburgh Armory Unity Center on Monday, he took some time in his modest New Windsor office to reflect on that career. During that time he compiled an impressive record of legislative and political achievements, one of which is the upcoming \$10 million overhaul of the Purple Heart Hall of Honor at the New Windsor Cantonment. He has also helped the many communities he has served in smaller but very impactful ways.

“Senator Larkin has served our country for more than 70 years with honor and distinction,” said Orange County Executive Steve Neuhaus. “\$40 million for SUNY Orange’s Newburgh Campus, more than \$10 million for the National Purple Heart Hall of Honor in New Windsor, more than \$20 million in capital investments for St. Luke’s Cornwall Hospital and millions more for local roads, emergency vehicles and other major infrastructure improvements for local municipalities. In addition to his role as a government official, Senator Larkin has served as a mentor to me and many other young leaders who will be ready to carry the baton in the years to come.”

Another milestone is helping the City of Newburgh battle poverty and increased educational opportunities at the Newburgh Armory Unity Center in partnership with philanthropist William Kaplan who credits Larkin for helping the Armory project succeed with funding. He helped secured more than \$2 million in funding for the

Mayor Torrance Harvey credits Larkin with being a loyal supporter of Newburgh’s renaissance. His largeness was one of many benefits his constituents came to enjoy with regularity during his long tenure in office.

“It’s depth of service and generosity of such a great man,” added the mayor.

“Bill Larkin is more than just a public servant, he is my friend,” said Lou Heimbach, former Orange County Executive. “His record of service will remain unmatched for the ages. Our community will sorely miss his experience as a government official but they will benefit from his future volunteer efforts in the years to come. During his time in Albany, Larkin served on countless committees during his time in the Assembly and Senate including Finance, Rules and Health. In the Assembly he served as Assistant Minority Leader Pro Tempore and in the State Senate served as Majority Whip and Deputy Majority Leader of House Operations. He also delivered millions in capital funding for projects and infrastructure investments that have been shaping communities in the Hudson Valley for the past 40 years in parts of Orange, Ulster, Rockland and Sullivan counties:

- \$40 million to establish SUNY Orange Campus in Newburgh.

- More than \$10 million to build, maintain and enhance the National Purple Heart Hall of Honor.

- More than \$100 million to support St. Luke’s Cornwall Hospital.

- \$1 million to refurbish existing education buildings on the campus of Mount St. Mary College in Newburgh.

- Secured tens of millions over the last four decades to support local municipalities, nonprofit organizations and businesses looking to create jobs and provide workforce development training. Funding secured for these projects helped to ensure that local leaders avoided raising taxes on their own residents to pay for costly infrastructure improvements.

“If you’re truly lucky, in the course of a public career you meet a few precious people who make the journey more joyful, more fun,” said Congressman Sean Patrick Maloney. “Sometimes they are not a member of your own generation or even in your own political party. Bill Larkin is one of the most honorable people I’ve ever met. He’s dedicated his entire adult life to the service of others – from the tropical islands of the South Pacific and snow-capped mountains of Korea – to the halls of the state capitol in Albany. Senator Larkin is a noble statesman and a happy warrior. Public servants like Bill Larkin shine brightly and light the way for cooperation and friendship even in an era when those essential values are vanishing. Because of his decency and warmth, we became true friends and partners in serving our neighbors. I’ll always be proud of that partnership. Senator Larkin has made an impact on every community he represents and his legacy will last for a century. Randy and I wish Bill, his wonderful wife Pat, and their children, grandchildren, and great-grandchildren all the best in this world.”

Prior to his life in politics, Larkin served in the U.S. Army. His nickname around his senate office was “The Colonel” after his final rank of Lt. Col. In the U.S. Army. He rose to command a unit of African American soldiers and was awarded the Legion of Merit medal in Korea, where his feet were badly frostbitten and still act up once

in awhile.

Though he still feels aches and pains from long ago, he considers them battle scars and he's proud of them. He also served in the Philippines, but one of his proudest moments of service to his country is the day he guarded the Rev. Dr. Martin Luther King Jr. on his march to Selma, Ala.

"I'm very proud of that," he says.

Initially elected New Windsor Town Supervisor in 1976, Larkin moved to the Assembly in 1979 and finally to the New York State Senate in 1990 after the retirement of State Senator Richard Schermerhorn. At 90, he says his mind is pretty sharp.

"I'll be 91 in February," he adds.

Larkin leaned forward to emphasize that his decision not to seek another term in Albany has nothing to do with some "mythical Blue Wave that some Democrats have wished for." On the contrary, he says, his final battle is with Father Time "and it's time that my wife Patricia and I enjoyed life together.

He can now focus on being a husband, father, grandfather and great-grandfather. Between them, Senator Larkin and his wife Patricia have eight children, seventeen grandchildren and two great-grandchildren.

There's enough on his resume to fill a book, and Larkin says he just might get around to writing it one day.

With the hoopla of retirement, Larkin remains straightforward and no nonsense, and those traits have served him well in his long and storied career in Albany. He leaves behind a 40-year legacy in public service and the gratitude of the many communities he has served and helped.

New York's population is shrinking

As we enter 2019, we learn that fewer people are entering the New Year in a New York State of Mind.

The New York Business Journal, among other sources, is reporting that the Empire State is leading the nation in population loss – more people are moving out of New York State than anywhere else.

In 2015, New York had a population of 19.5 million. By 2016 (the latest year available), it shrank to about 19.3 million, resulting in a net drop of 186,000 people. That leads the nation in out migration, followed, in order by Illinois, California, New Jersey and Connecticut. All five of these states have negative net migration rates.

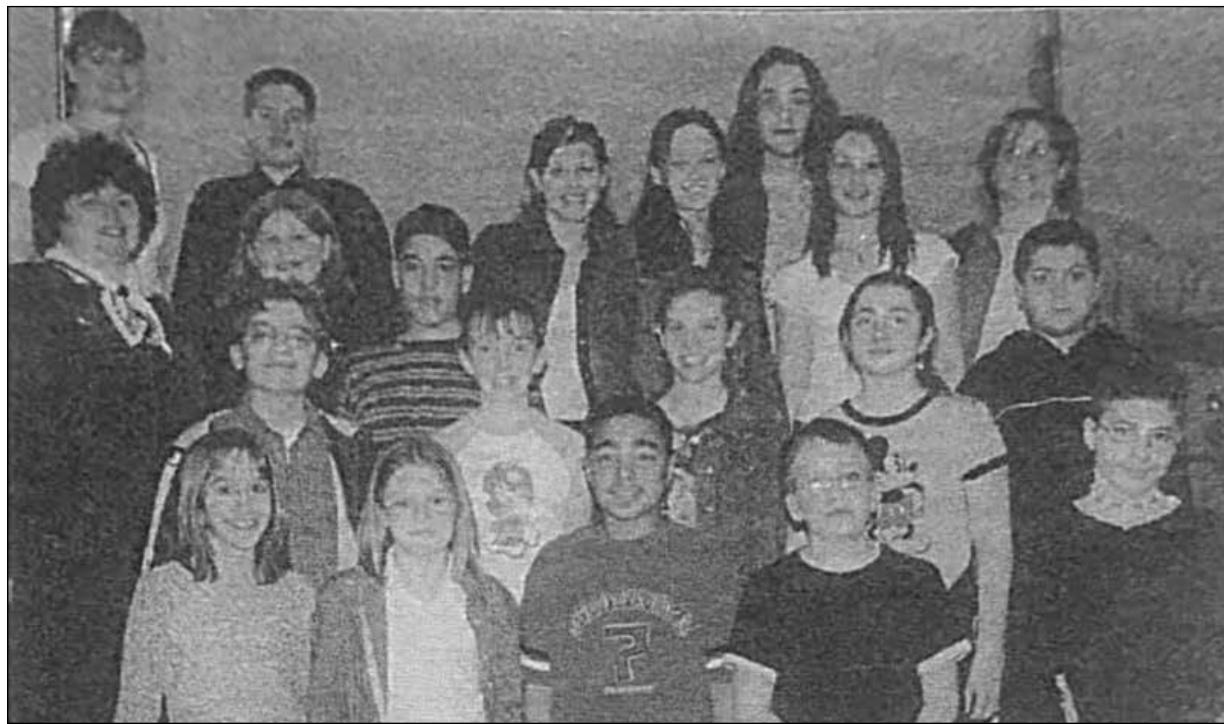
The loss has been attributed to many reasons. Gov. Andrew Cuomo blames the weather. Of those New Yorkers who have made more recent moves to Florida, the Carolinas or other states, Cuomo said their decisions were “climate based” or “based on personal reasons.”

Figures do back up that claim. States that have the largest population growth are all in the Sunbelt. They are, in order, Florida, Texas, Arizona, North Carolina, and Georgia. It has been suggested by multiple sources, that other factors lead to the southern migration, including lower taxes, more employment opportunities and affordable housing. Anything away from the harsh northern winters can offer reduced utility bills, which is also enticing.

It's true that we cannot do much about the weather, but perhaps our lawmakers can come up with more incentives for home and business owners to come up with energy-saving alternatives. And we can certainly do more to ease the tax burdens on property owners and the seniors who no longer want to spend their retirement years here.

There are better was to be Number One in the nation. This is not one that we will celebrate.

Channeling Fritz, the wood splitter

Fritz was German, as his name might imply. He lived in Walden on one of those streets up above First Street. I couldn't tell you which one. Sometimes my father dropped him off there after work. I would be in the car, a big 1950's car, black, and smelling of the farm, like hay, and to my mother's eternal chagrin, maybe some cow.

Fritz came to the farm to do odd jobs, splitting firewood, fixing equipment. He split a lot of firewood. He was a big man and wore a red and black wool jacket like lumberjacks used to wear, and he was fierce, and not approachable to a kid, but he was someone to watch. I would stand behind the big maple tree and watch him work.

If something went wrong, he swore like hell; words like "THUNDERBETTER!" or similar, or "HUFRADAMMER!" I can't recall everything. He was like Thor, or a man from a medieval village in a dark forest. And, of course, he was German. I was born six years after World War II ended. We were close to the war, much closer than we ever realized as kids. So I would ask myself: when did he come here? Was he a Nazi? How did he get out of Germany? Was he in the war? None of these questions

were ever answered, let alone asked. But imaginations were real, as kids, and all the movies were of war, and the world was a big funny place and America had enemies. So it was only natural to ask.

Fritz was good with tools and fixed many things around the farm and kept the tools clean and organized and all in their rightful place. My father needed a man like that because, like me, he hated fixing things he thought should be working without assistance, especially if, recently, it had just been fixed, and surely things should run forever, and damn, we just don't have time for this fixing stuff.

I remember a big red tractor with a pulley wheel on it (I guess before power take-off), and from the wheel, a long belt ran to a large, rusted, table saw with a big wood cutting, sawmill-type blade, like Poppies' Olive was always seemingly soon going to be cut in two pieces with, spinning, for cutting firewood. This is going way back in my memory banks so there is fog, but the setup was near the corner of the house near the breakfast room and under the big maple which was damaged by Hurricane Donna in 1960. Pop started the tractor and the long belt ran the saw and Fritz cut the logs and then split the wood and stacked it on the back porch overlooking the river.

Fritz did not work there steadily, nor for long stints, but there was always the sense he was there before me, and that there was a history, and probably some heavy drinking and, even so, a fair amount of respect for the man's strength, and his ability to fix broken things -- perhaps everything but himself.

From Fritz, I like working wood, splitting it,

stacking it, setting it aside for the future. I don't have Fritz with me today, but I do have a nice woodsplitter my father gave me years ago when he figured out I am just crazy enough to heat my house (for the most part) with wood. I keep it well covered, and I like it best when I can use it standing up. It has two positions. When splitting very big chucks, you are on your knees slinging the logs around. And for smaller stuff, you can lift it is as you see it in the photo. Winter has different chores. Fritz was there. It's so hazy now, and I have noticed, once you write about it, or someone, everything associated with that memory becomes even hazier in the future, like you have used up the memory and now you have less inside yourself. So goodbye Fritz.

Orange County, CSEA reach tentative agreement

Orange County Executive Steven M. Neuhaus and CSEA Orange County Unit President Rosemarie Kukys announced on Wednesday that a tentative contract agreement has been reached between Orange County and the Orange County Unit 7900 of the Civil Service Employees Association (CSEA).

"Over the past five years, my administration has worked hard to develop a professional working relationship between the County and its largest union, resulting in good faith negotiations that led to a contract settlement that fairly represents the views of both the County and the CSEA," Neuhaus said. "This is an equitable contract for County Government and for the employees of County Government."

The current CSEA contract was set to expire on December 31st of this year. The County and the union met eight times over the past seven months in an effort to come to an agreement prior to the end of the existing union contract. CSEA is Orange County's largest employee union representing approximately 1,840 Orange County Government and SUNY Orange College employees.

The terms of the contract include a

five (5) year agreement in which the major focuses were salaries and benefits. The wage portion of the settlement is as follows: 3 percent in 2019; 2.75 percent in 2020; 2.5 percent in 2021; 2.25 percent in 2022; 3.25 percent in 2023. Under the terms of the agreement, newly hired County employees will be paying 12 percent or 14 percent of the NYSHIP health insurance premium, depending on their respective classification grade.

"We're pleased to bring what we feel is a fair and equitable agreement back to our membership for a vote," Kukys said. "The fact that we were able to come to an agreement quickly and without complications is a testament to work both CSEA and the County have put into building a stronger labor-management relationship."

The County negotiating team consists of: Steven M. Gross, Commissioner of Human Resources; Wayne Booth, Director of Operations and Cost Control; Langdon Chapman, County Attorney; Sharon Worthy-Spiegl, Deputy County Attorney; Tamara Hunter, Deputy Commissioner of Human Resources for Employee Relations; Molly O'Donnell, Personnel Management Technician; Jennifer Robles, Personnel

Management Technician; Deb Slesinski, Deputy Budget Director and Colleen Kennedy, Benefits Administrator.

The agreement is considered tentative

as the union and the County Legislature must both hold a vote to ratify the agreed upon terms

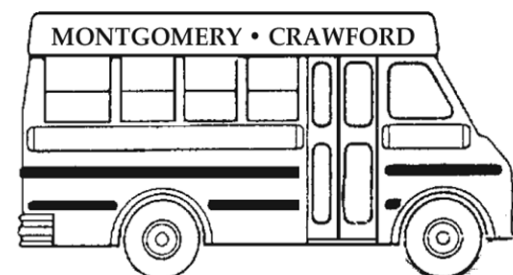

Here's Lucy!

Therapy Dog provides comfort at Pine Bush Library

Two little girls settled onto the carpet at the Pine Bush Area Public Library and pulled out colorful children's books. Ava, 7, cracked open "Puppy Love," and began reading aloud to Lucy, a therapy dog. The mottled-brown dog laid down at Ava's feet, as if hanging on to the child's every word.

Lucy takes part in a library program in which children read aloud to her. Children develop their oral reading skills without the fear of being criticized, as they might be in front of a teacher or classroom.

"Lucy does not judge," Children's Librarian Vicki Ducham said.

Children who participate in the program can read to Lucy in 15-minute blocks with their own book. Owner Joe DeJong also supplies a pop-up book filled with treats, a favorite for Lucy, who sniffs out the goodie-filled compartments.

An American Kennel Club (AKC) certified therapy dog, Lucy also visits patients at Castlepoint and Montrose Veteran's Affairs Hospitals. At Montrose, DeJong sets Lucy loose in the Post-Traumatic Stress Disorder (PTSD) unit to wander among the patients.

Studies show that therapy dogs in hospital settings reduce stress, anxiety and pain; decrease blood pressure and heart rate; increase happiness; and provide a distraction from painful procedures and situations for both hospital patients and their loved ones.

"[The patients] say that it's best part of their day; they really enjoy it," DeJong said.

However, people haven't always been kind to Lucy.

Lucy, then named Cookie, was chained to a tree for weeks without shelter, food or water as a puppy. Her collar became imbedded in her neck so severely it created a seven-inch wound, three centimeters deep.

DeJong's daughter was working at the animal hospital that took Lucy in. When she met the lovable dog, she called her father.

"She called me up and said, 'Dad, you're taking this dog.' And I did because when your little girl says something you say yes," DeJong said.

DeJong, who has a brain injury, trained Lucy to be his service dog. Lucy completed the AKC's Canine Good Citizen training as part of her therapy dog certification, a program that teaches dogs good manners at home and in the community.

"She's my little buddy, she goes with me all over," DeJong said.

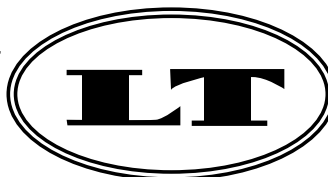

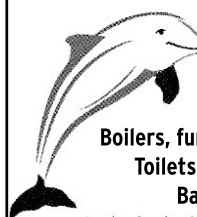

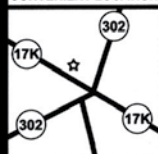
