## Medline to drop tax suit against Town of Montgomery

Town of Montgomery Supervisor Brian Maher announced last week that Medline Industries has agreed to drop their current tax challenge in State Supreme Court filed in Orange County against the Town of Montgomery seeking an 80% reduction in their assessment totaling over \$1 million in tax revenue.

“When I first saw the lawsuit and what Medline was looking to do the numbers just didn’t make any sense to me,” said Town of Montgomery Supervisor Brian Maher. “I asked local Medline representatives to have a meeting without attorneys to see if we could talk through how they were calculating their numbers. They seemed to be asking the town to change their assessment to even less than it was as vacant land. Senator Bill Larkin always taught me to just bring everyone into a room because often times people tend to be saying the same things but talk past each other.”

Maher said Medline’s consultants had interpreted their tax bill in a way that led them to believe their value per square foot was more than double neighboring warehouses currently residing on Neelytown Road. It was made clear by town officials that this was not the case. Once this was shown

## Pine Bush strikes school bus deal

### Instructional schedule to return to regular times

At the November 23 Board of Education Meeting, the Pine Bush Central School District Board of Education approved an agreement with transportation company Orange County Transit to run 16 bus routes for the remainder of the 2021-2022

school year. Earlier this year, the Pine Bush Central School District moved 16 bus routes from Birnie Bus Service to Orange County Transit following driver shortages and transportation issues.

Superintendent of Schools Tim O. Mains explained the New York State Education Department allowed the

district to have 30 day contracts, which later extended to 60 day contracts, for the routes which are set to expire on December 4. The district posted a Request for Proposals (RFP) within the first 30 days for those 16 runs and there was only one bidder, Orange County

# Orange County Chamber makes a move to Maybrook

The Orange County Chamber of Commerce will soon re-locate its headquarters to a historic Maybrook address.

“After our last Village Board Meeting, I received a phone call from Heather Bell-Meyer. She is the President of the Orange County Chamber of Commerce,” Mayor Dennis Leahy reported at last week’s Village Board meeting. “They will be officially moving the Orange County Chamber of Commerce Office to the Village of Maybrook and residing at the Blake House (the former Ms. Claire’s Montessori) on November 30. They plan on hosting a Grand Opening planned in the spring of 2022. This is positive news and I’m hoping to have more in 2022!”

The main office was previously located at 40 Matthews Street in Goshen.

“We are so pleased to be finding a new home at the historic John Blake House in Maybrook. We will have our own building to welcome visitors which will also allow us to offer office space to

Transit, who is currently responsible for the runs.

The fee for the runs is higher than Birnie Bus Service's rates, but the approval was met with optimism by school district officials. "Thanks to the skillful work of our Assistant Superintendent for Business we were able to get that bargained down-still extremely high, but a little better. So we're

recommending with the amended figures provided to us by the owner of Orange County Transit today, that you approve the contract for the remainder of this school year," explained Mains. The RFP does give the district the option to extend that agreement beyond this year.

"I want to be clear that at these rates we will exceed our transportation budget, but in the view of your senior leadership here at the district - we believe

that it's essential that we execute this contract even at the higher prices to be able to guarantee that our kids can get back and forth to school," shared Mains. With the approval of the agreement for the 16 bus runs, Mains said he will be able to return Pine Bush's instructional schedule to the regular times beginning this week.

in writing and explained to Medline representatives they agreed to drop their tax challenge.

"After speaking with Supervisor Brian Maher and his team it seems as though we have cleared this matter up," said Medline spokesman Dmitry Dukhan. "We believed that the square footage value was nearly double that of other warehouses in the town which we

did not believe to be fair. Supervisor Maher and his team clearly showed us that this was not the case. It seems that this was an honest communication error that was corrected with a simple phone call. We want to thank Supervisor Maher for his leadership and dedication to clearing this matter up, avoiding needless attorney fees for both sides."

State Senator James Skoufis (D-Woodbury) welcomed the news last

week. "Make no mistake: this positive outcome was not the result of some epiphany that the company's high-priced accountants realized four months after filing their frivolous challenge," Skoufis. "This outcome was the direct result of local stakeholders holding Medline's feet to the fire and calling out their second egregious attempt to steal from taxpayers."

Skoufis, last month referred a criminal complaint to the Orange

County District Attorney's office alleging numerous "misrepresentations" made by Medline officials including the company's declaration that they would move out of Orange County if they didn't receive sought-after financial incentives.

"Medline tried and failed to strongarm the taxpayers of Montgomery," Skoufis said. "Together, we fought back, and now Medline must pay their damn taxes."

future members was for us to move our main office location and add a new satellite office as well."

For the Chamber, the move marks a return to the Town of Montgomery. Following the merger of two chamber organizations in the late 1990s, the chamber constructed an office building on Scott's Corners Drive. In a downsizing move several years ago, the Chamber sold the building to Girl Scouts Heart of the Hudson, and moved its headquarters to Goshen.

In addition to the new main office location, the Orange County Chamber of Commerce will now have a satellite office at 380 Broadway in the City of Newburgh. The single office space is made possible by generous donation from William A. Smith & Son, Inc. who has been a long-time supporter of the Orange County Chamber of Commerce.

This satellite office will be open on Mondays beginning mid-December and additionally by appointment based on the needs of the community. The chamber will be hosting a ribbon cutting to mark the occasion for this satellite office on December 14 at 4 p.m., all are welcome to attend.

"This is a sign of growth and provides us with

the ability to greater extend our reach throughout Orange County and beyond," Bell-Meyer said.

The John Blake House, likely the oldest house in Maybrook, dates back to the late 18th century. It was part of a larger homestead built by John Blake, a deputy sheriff of Ulster County (which at the time included the present day Town of Montgomery). He would later serve as an Orange County Sheriff when the line was redrawn and then serve 15 terms as Town of Montgomery Supervisor, according to Wikipedia.

As Maybrook grew, the Blake farm was broken up into smaller and smaller parcels, owned by others. The house would undergo renovations in the 1820s and 1840s, the latter adding a kitchen wing to the rear. When the village transformed into a railroad town in the late 19th century, the house was home to workers building the nearby connecting spur off the Erie Railroad main line later used by the New York, New Haven and Hartford Railroad.[4] The front porch was added sometime in the 20th century.

In 1984 it was added to the National Register of Historic Places as a well-preserved example of the kind of home built by settlers of English descent in the early years of the Federal style of American architecture.

A Grand Opening celebration for the Maybrook office is being planned for the Spring of 2022 which will also be open to the public for attendance. # Town budget includes raise for reluctant supervisor

The Montgomery Town Board approved its 2022 spending plan last month with a 4-1 vote, as Town Supervisor Brian Maher was the only dissenter.

"I am voting 'no' because I do not support a 10 percent raise for me. I am very happy with the pay that I get right now," Maher said.

The budget includes a 10 percent raise for the supervisor, who is due to collect a salary of \$79,514.60, up from the \$72,000 he is currently receiving.

"I understand what the town board did, they're not thinking of me they're thinking of the position," Maher said,

adding that he knew the salary when he first ran for the job two years ago. He was just re-elected to his second term last month.

During the budget discussions, Deputy Supervisor Ronald Feller said he had done research, noting that the average salary of supervisors in neighboring towns was about \$109,000, compared with \$72,000 in Montgomery, and he proposed an increase to about \$90,000.

Councilwoman Kristen Brown countered with a plan for an incremental increase of about 10 percent each year for the next three

years, which translated into an increase of the supervisor's salary to \$79,514 in the budget for next year.

The budget also provides salaries of \$19,950 for the deputy supervisor and \$16,800 for each of the three remaining council members. Those are all part-time positions. Two town justices will receive \$29,243.76 each, while the town clerk will receive \$79,331.62 and the Highway Superintendent is due to collect \$89,250.

The total town budget for next year is \$13,814,384.90. Maher said the budget will result in 0.5 percent decreases for the "A" fund (\$9.4 million), which

includes taxes assessed to residents of the three villages; the "B" fund (\$4.9 million) which is assessed only to residents living outside the three villages and the highway fund (\$2.9 million).

"I thank you all for your hard work," Maher said, addressing the board.

Brown, who did join the other council members in voting yes, did express one concern.

"I would like to see the ambulance corps increased by \$50,000," she said.

The Town of Montgomery Volunteer Ambulance Corps is currently budgeted to receive \$150,000.

"In 2020 we all experienced so much screen time, including our children, and some of it was forced. But now, on an average school day, kids are still absorbing more screen time than ever," said Alayne Eisloeffel of Tri-County Prevention Coalition.

"We know screen addiction is real. We know studies have been done to show social media is detrimental to teens mental health and well-being. It's time to talk about it. It's time to see what we can do about it," Eisloeffel continued.

If you or your child have an iPhone, did you know you can go to settings, then screen time to see exactly how many hours, yes hours, are spent staring at the tiny screen? Overall screen time average, not just on cell phones is about 7 ½ hours per day.

Studies, research, and statistics abound to show that screen time has increased, for children and adults,

since the pandemic. However, the concerning part is those numbers don't seem to be decreasing as life returns to more in-person and in the classroom activities. How much is too much? When is it an addiction? What can be done?

# Guilty plea announced in 'monkey fist' assault case

Orange County District Attorney David M. Hoovler announced that on Wednesday, November 24, Justina Ferguson, 46, of Middletown, pleaded guilty before Orange County Court Judge Craig Stephen Brown to Assault in the Second Degree in connection with an assault on her former boyfriend and a woman in a Town of Wallkill hotel room.

Prosecutors alleged that August 15, 2020, at about 1 a.m., the defendant, who was accompanied by others,

tricked hotel staff into giving her room information and a key to the room where her former boyfriend was staying. An Orange County Grand Jury had charged Ferguson with assaulting her former boyfriend, as well as a woman who was sleeping in the room.

At the time that Ferguson pleaded guilty, she admitted entering her former boyfriend's room and assaulting the woman with a weapon consisting of a knotted rope containing a weight. The assault

was recorded by one of the individuals who had accompanied Ferguson to the room. The weapon, which is commonly called a "monkey-fist," is designed to be used as a flail. The woman suffered a serious headwound as a result of the attack.

Ferguson faces up to seven years in State Prison and three-years post-release supervision when she is sentenced on February 17, 2022.

# Patriots and Spies

## Local author captures the region's role in the Revolutionary War

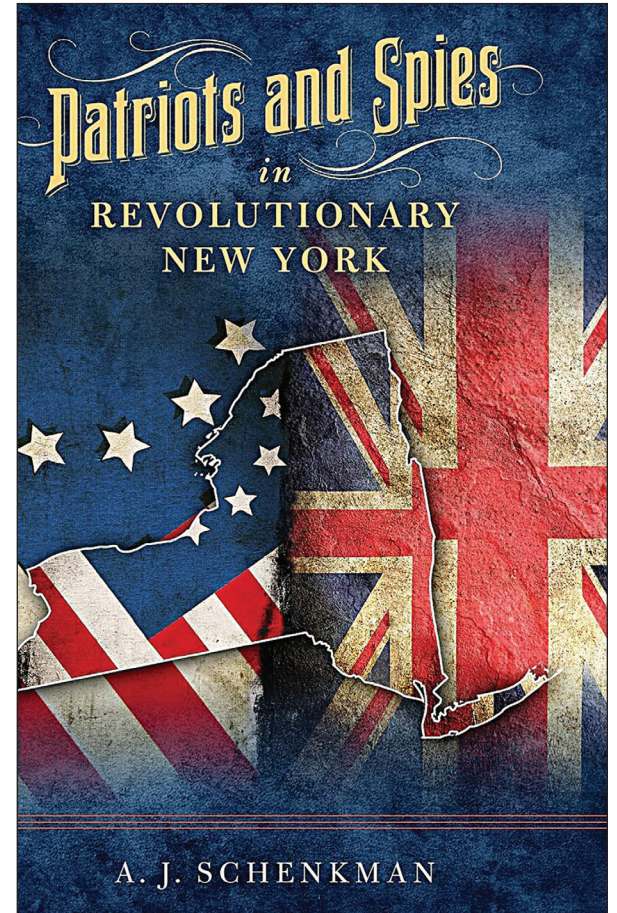

A. J. Schenkman, a local historian and teacher, has been writing about the history of the Hudson Valley for some time, and his latest book centers around the American Revolution and the role played by the American revolutionary patriots and British loyalist Tories in the area. It is called *Patriots and Spies in Revolutionary New York*, and while it also deals with the conflicts on Long Island and the Mohawk Valley, the stories about the parts played by those loyal to King George III and those fighting for the independence of the colonies in the mid-Hudson Valley were most interesting to those of us living in the area.

Newburgh had several instances of trouble in those times and not always between rebels and Tories. Lieutenant John Sullivan arrived in Newburgh in August, 1779, with a troop of horse soldiers and promptly told his men to let their horses go free in a pasture owned by a certain Elnathan Foster of Newburgh while the troops spent some time in the village for a few days. However, Mr. Foster did not take to having his meadow disrupted by some cavalry horses since he had rented the property out to the Continental army for cattle grazing, and Sullivan had

put the horses there without compensation or even without getting Foster's permission. The Lieutenant was brought to the court room of Justice Abel Belknap, located in an upstairs room of Weigand's tavern (which today is undergoing restoration) on Liberty Street near the Old Town Cemetery, and Foster presented his complaints of trespassing and damage to the field for which he was requesting compensation. Judge Belknap agreed with Foster and told Sullivan to pay for the damages and to vacate the property. Sullivan did neither, claiming the hardships of war and the needs of his calvary. Sullivan stayed in Newburgh for some time causing disruptions of all sorts and ignoring the reprimands of Judge Belknap. Eventually Sullivan left for Pennsylvania and became involved with the Pennsylvania Mutiny of 1783, where a militia of soldiers demanding back pay surrounded the State Capital in Philadelphia where Congress was meeting. Fearing for their safety, the congress retreated to Princeton and asked General Washington for assistance. Washington sent 1500 soldiers to put down the rebellion and the crisis passed. The ringleaders of the mutiny were "a derranged army Captain named Henry Carbery" and the hot tempered John Sullivan.

One instance of a capture of a Tory spy happened in New Windsor due to the the confusion of the two Generals on the opposite of the war named Clinton: General Henry Clinton of the British Army and General George Clinton of the American forces. It seems that after the destruction of Forts Montgomery and Clinton on the Hudson, a message was sent to Gen. Burgoyne in Saratoga by British General Henry Clinton via a carrier, Daniel Taylor, who carried the message hidden in a small silver bullet. Taylor was dressed in civilian clothing and was on his way north from Fort Montgomery when he came upon a cluster of soldiers in New Windsor dressed in British uniforms. As the author writes, "Little did he know, that these soldiers had stolen British uniforms and had not changed. The guards who asked Taylor to stop were, in fact, Americans dressed in British uniforms. Fooled by the uniforms and believing they were members of Sir Henry Clinton's troops, Taylor responded: 'I am a friend and wish to see General Clinton.'" He was then escorted into the presence of the American General George Clinton. Upon sensing the confusion, Taylor immediately took out the silver bullet from his pocket and swallowed it. Gen. Clinton, however, saw what he had done and demanded that Taylor drink an emetic or face disembowelment! Taylor had to take two doses before the silver bullet

emerged and the message revealed. Taylor was arrested as a spy and eventually hanged.

Schenkman's book is filled with interesting and well researched stories taken from files in the Library of Congress and the New York State Archives and other sources. He has worked in Newburgh at Washington's Headquarters and also at the Cantonment in New Windsor. He is currently the Town of Gardiner Historian while also teaching social studies in the Wallkill School District. He has written several books and articles in addition to this one, and the books are available on Amazon. The book is published by Globe Pequot.

# Neuhaus urges residents to prepare for winter

Orange County Executive Steven M. Neuhaus and Commissioner of Emergency Services Brendan Casey encourage residents to begin preparing for winter, which officially begins on December 21.

“Severe winter weather conditions often arrive early in Orange County,” Neuhaus said. “If you haven’t already, I urge families to take steps now to prepare for the winter months ahead. You should also check on your elderly neighbors, friends, and relatives to make sure that they are safe and have the supplies and medications they need during the winter.”

Casey said that the first steps residents can take is to review their family emergency plan, determine what supplies they should have stored to be prepared for any emergency, and be aware of local weather conditions.

“The leading cause of death and injuries during winter storms is transportation accidents,” Casey said. “Residents should think safety first during a storm. Before going out on the road on wintry days, residents should listen to the local media reports for the latest road conditions. You should

remain aware of weather advisories and follow all instructions in the event of an emergency.”

According to Casey, a primary concern during the winter months is the potential loss of heat, power, telephone service, and a resulting shortage of supplies if storm conditions continue for more than a day. He said that residents should always have the following items available:

- Flashlight(s) and extra batteries
- Battery-powered portable radio or NOAA Weather Radio to listen to weather forecasts and receive emergency information

- A three-day supply of food that does not require cooking or refrigeration, i.e. canned goods, dried fruits, protein bars

- Bottled water (one gallon per person per day)

- A one-week supply of essential medicines and baby items

- First aid kit and supplies
- Extra blankets and sleeping bags
- Fire extinguisher and smoke detector (test units regularly to ensure they are working properly)

- ICE Melt and snow shovels

At least a half a tank of gas in all vehicles

In the event of a power or heat

outage, up to date shelter information can be found by calling the United Way’s 2-1-1 service.

## Remembering the Day of Infamy

**A** dwindling few Americans were alive 80 years ago when America entered World War II.

The Japanese attack on the U.S. Naval Fleet at Pearl Harbor – America’s “Day of Infamy,” in the words of President Franklin D. Roosevelt – claimed 2,345 American lives while much of the U. S. Pacific Fleet was crippled and nearly all of the U.S. airpower in the region was destroyed. FDR, the next day, asked Congress to declare war on Japan. Three days after that, Germany and Italy formally declared war on the U.S., all of which signaled this nation’s entry into World War II.

Our images of that day come mostly from archive photos, Hollywood, and The History Channel. The black and white footage shows the smoldering USS Arizona on its way to a watery grave. As of 2013, 2,000 to 2,500 survivors were thought to be still alive, according to Eileen Martinez, chief of interpretation for the USS Arizona Memorial.

Many more of us have vivid recollections of the 9-11 tragedy as a day that both terrified us and shaped America as a nation, but it was December 7, 1941 that thrust America into the global role it still serves. That’s why we mark the day by tossing a wreath into the nearest body of water.

It’s also a day for Veterans organizations to remember their fallen comrades.

While some 4,000 people tour the site of the Pearl Harbor attack each day and 1.5 million visit the USS Arizona Memorial annually, the dark moment in history fades farther into memory. We owe it to that Greatest Generation that came before to keep that memory alive. Out of that awful day came the struggle, heroism and sacrifice that defined that generation and made America great.

We must never forget.

# The joy in completed tasks

**A**fter the last garlic clove was in the ground, I rounded up the troops and we landed in our favorite local Irish pub for late afternoon pints and nachos and chicken fingers.

It was all delicious including the comfort of knowing the garlic for 2022 was in the ground and that we had done everything we humanly could to make it a success. We prepared the ground to a fluffy, plantable soil. We quick-soaked the cloves in a 75 to 1 hydrogen peroxide solution to mitigate possible pathogenic conditions. We soaked the cloves in hot-kelp-powder water to jumpstart the roots. We struck into the soil, under the cloves, bone meal for phosphorus for bulb growth, and blood meal for nitrogen to generate future leaf growth. Strong leaves, charge strong bulbs -- it is hoped. We spaced our cloves ideally to insure equality of nutrients and sunlight.

All in. We count as we go. We have a system. As we work across the field we write down, in a spiral notebook, the number planted in each row. At the end of the day, we gather at the truck tailgate and add up the number of cloves. We guess the count, then we add. It's interesting, inspirational. Keeps us coming back.

Not surprisingly, our best day was our first day – 4518 cloves planted, by hand. My job usually ends up being dropping the seeds in handfuls of five or so, every step across the field, and hoeing in the planted cloves after all else is done. I like to handle the hoe because then I can be secure in knowing their depth – not too deep to not emerge, not too shallow to be pushed from the ground by the frost. Then, a light tap with the broad edge of the hoe to compress the top of the row. When we

were about ¾'s done, we had a nice rain which, while keeping us from our task, helped the newly planted cloves settle in and take root.

The weather cleared, the road dried (just enough) and the planting continued. Some days were bright and sunny, and we could see Sam's Point up in Cragmoor glinting Shawangunk conglomerate, high in quartz crystals. Other days were windy and chilled and grey and real November, short and grey like a Nuthatch.

We planted 17,668 hardneck garlic cloves, almost all from my own stock. We added two new varieties this year: a purple-stripe called Marjean, and a rocambole, Russian red. The Russian red is my own seed and was taken from my Mystery brand because I was able to decipher the genetics of the variety by the bulbils, or young, high stem

seed-like bulb clusters all hardnecks grow. Each variety has distinctive bulbils and over time you know how to tell one from the other. Our old standbys are German red and Carpathian. We also plant limited numbers of White Continental, Music, and our own Mystery. It's called Mystery because we don't know what the hell it is!

OK. The 2022 garlic is in the ground. Task complete.

Or is it? We like to mulch our garlic field with woodchips down the walking rows with leaves on the garlic cloves rows themselves. We are about half done. Need more woodchips. Need a drier road, some time to work on the road. When one task is done, another transcends its obscurity and off we go.

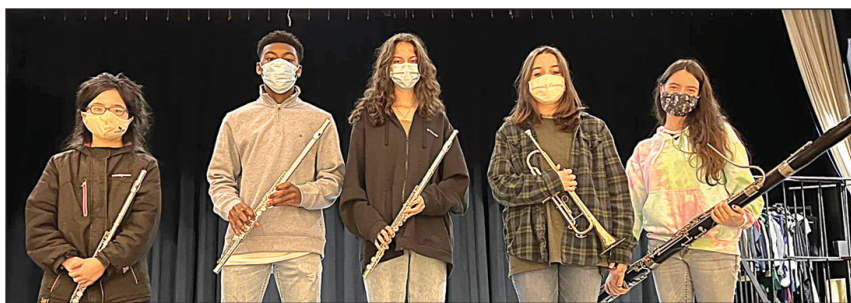

# Wrestlers look to complete a full season

Wallkill coach Anthony Ng described Futia as a “scrappy wrestler” who is looking to have a statement season in his junior year. While he brings smiles and levity to the Wallkill wrestling room, he’s all business when it’s time to compete and practice.

Betcher is a senior captain, expected to compete at 215 pounds and he has been close to the podium. A quiet leader, Betcher is always looking for a challenge. He’s also a “no nonsense” competitor.

“He’s always looking for a challenge and looking better than everyone as he enters his senior campaign,” Ng said. “We are grateful for his work ethic and leadership.”

Marco Martini was unable to finish his freshman year due to a shoulder injury, but he is looking to have a breakout season in 2021-22.

“He is on another level regarding hard work and mental fortitude,” Ng said. “His calm demeanor, coupled with his calculated approach to situations will be an asset to him individually and our team moving forward.”

Marco Futia, Rocco’s younger brother will join the team and is expected to compete at 102 pounds, while Viktor Banda has worked hard over the pandemic to get himself ready for the season.

Ng said the Panthers are excited for competition and hopeful to get a full season in.

“We hope to keep improving as individuals to come together as a team,” Ng said. “We hope to win a league title and peak during postseason competition.”

Pine Bush competed but had a difficult COVID-19 season, running a 0-6 season.

They will compete this year without Dylan Burgos, who graduated. The Bushmen will return Braydon Pennell, Devin Greer, Brooke Tarshis, James Duffy, Richard Urena, Saul Abregu, Daniel Trojahn, Joseph Longobardo and Logan Pennell.

Braydon Pennell is a returning sectional place winner and Brooke Tarshis wrestled all offseason and competed in the wrestling tournament in Fargo, N.D.

The Bushmen have two wrestlers – Gregory Florin and Nathan Vondebenn – and a new coach in John Petrofsky,

The Valley Central Vikings will be led by youth as junior Raysean Johnson has 498 points through his freshman and sophomore years. And one of those years only had six games, putting Johnson on track to reach 1,000 points before he graduates.

He averaged 21 points, eight rebounds, five assists and three steals per game.

“Raysean Johnson is the best two-way player VC has had in a few years,” Valley Central coach Frank Nutt said. “He is a lockdown defender and offensively he can shoot, attack and finish at a high level.”

Nutt is also in his second year coaching the Vikings and this would be his first normal season at the helm.

Assisting Johnson in the backcourt will be Jurrell Taylor, who averaged nine points, and two steals, and Nutt said they will be the engine the Vikings will run on. They will also be the Vikings' two main scoring options.

Henri Pothier will bring size and shooting to the starting lineup. Nick Demaris also is returning, and Nutt said he will, and he along with newcomers Rubin Sims and Javen Griffith, will bring size and toughness to the team.

“(Johnson and Taylor) are looking to create for others as well as create a dynamic pair that will make it hard to defend VC,” Nutt said.
