School mask mandates remain

Pine Bush and Valley Central discuss frustrations

The Pine Bush Central School District and Valley Central School District Board of Education meetings were filled with conversations last week as concerned parents, community members and district officials weighed in as mask mandate concerns continue to be at the forefront for school districts across New York.

“One of the things that we need to consider on a daily basis is that our school district is required to follow state laws and regulations,” said Pine Bush Central School District Interim Superintendent of Schools Donna Geidel. “That being said, the Board of Education and I fully recognize that differing perspectives on mask wearing exist within our school community and our nation. Neither perspective is wrong. However, it’s important for everybody to acknowledge that some parents and staff feel that not wearing a mask is an acceptable risk while others feel that wearing the mask is a simple and effective mitigation

UNFI, Dunkin projects on the move

The Montgomery Planning Board covered a lot of ground at their recent meeting, where they approved Hydrovac, a hydro excavating business coming to Ridge Road; closed the public hearing for United Natural Foods (UNFI); discussed variances for a proposed cell tower on Stone Castle Road; and even addressed the possible relocation of the Dunkin Donuts on Route 208.

UNFI

It’s been a rocky road for UNFI, but the end seems to be drawing closer with the closure of the public hearing

last Monday.

The board discussed some outstanding issues including the possibility of replacing the current signs along Neelytown Road with “no stopping” signs and the selection of rooftop utilities, which have to be at a lower decibel level than what was originally approved for Crossroads.

Hydrovac/Jeslin Orange

Hydrovac finally achieved approval at the Planning Board meeting last week, concluding a journey that began several years ago. Two years after making their initial proposal, the company decided to greatly expand their project, adding an almost mirror

image of development on the east side of Ridge Road, a road that cuts directly through their property.

Most notably, the expansion included a drying area for excavation debris or spoils, which raised concerns. Last October, the applicant “abandoned all development plans” for the lot as well as the “beneficial use determination process” and refocused on the original buildings they were seeking.

The project’s approval is for a contractor office and storage use on the 41 acre lot on the west side of Ridge Road, with a 33 acre lot on the east side remaining vacant. The applicant

Walden celebrates a piece of its history

John R. Hays was a Civil War hero and a prominent Walden resident in the 19th century. While his Maple Street home was added to the National Register of Historic Places some time ago, it would take another two decades for a marker to cement that designation and ensure its builder's place in history.

On a chilly Friday afternoon, friends, neighbors and Walden officials gathered on the sloping lawn of 45 Maple Street in the village for the dedication of a historic marker. The two-story clapboard house has been the home of Nancy and Dave Ohlmer for the past 31 years, but looks much as it did for more than a century prior to their arrival in Walden.

Hays was born in Walden in 1840 and served with then-Captain Thomas W. Bradley, another Walden native, in the 124th New York Volunteer Infantry Regiment, better known as the famed "Orange Blossoms", during the Civil War. He saw action in many important battles of the conflict, including

Chancellorsville, Fredericksburg and Gettysburg. After being wounded, he was honorably discharged as a lieutenant and returned home.

Upon his return to Walden after the war, he served as the agent for the Wallkill Valley Railroad. He built the house in 1874 on a rubble stone foundation, according to Wikipedia. Clapboard siding gives way to a decorated frieze and bracketed cornice at the roofline, it notes. The mansard roof is shingled in modern asphalt that resembles the slate that was originally used. A small barn in the rear of the property has since been converted into its garage, but retains most of its original finishings. In 1900 the rear wing was added to the house, the only substantial revision to its original design.

Hays would later serve as postmaster, fire chief and owner of a clothing store. He was active in veterans' affairs, including raising money for the Civil War monument in the center of the village. When he died

in 1912, the village mourned the loss of "one of its foundational stones," a phrase repeated Friday by Mayor John Ramos.

The Ohlmers have spent much of the past 31 years researching his life and Walden's history.

"I think (it was) his commitment to the community," Nancy Ohlmer said when asked what, besides his Civil War record was the most impressive quality of John R. Hays.

Dave Ohlmer noted that Walden's history is very rich and transcends many eras, from its early days when mills harnessed the Wallkill River, through its role in the Civil War, to the industrial revolution and beyond.

The blue and yellow marker, installed by the Walden Department of Public Works, is courtesy of a grant from the William G. Pomeroy Foundation, which offers grants in support of historic marker programs across America. Since 2006, it has funded more than 1,600 signs across the United States.

Crawford's new highway dept weathering the winter

It's no surprise the weather is unpredictable lately. The Crawford Highway Department knows this all too well, and the crew has been working hard in recent weeks due to wind and ice storms ripping through the area. Highway Superintendent John Yarosz brought to the Crawford Town Board's attention at their monthly meeting, that his crew's multipurpose bucket truck is unsafe and is not performing the way it used to. With winter sticking around for a few more weeks, Yarosz' goal is to keep the department running smoothly.

"Our truck now is just not safe. It's from the year 2000, and it may not pass inspection. Getting a new truck is really a safety issue at this point, and this new 2023 model will be running like new in 20 years' time," said Yarosz.

The highway department is responsible for year-round maintenance on all roads, plowing snow, trimming trees, and several other unsung tasks they perform day in and day out. Since John Yarosz assumed the superintendent

role in January of 2022, his main focus is safety, and a new bucket truck would benefit the crew immensely.

"We are using this truck two-thirds of the year cutting trees, not to mention hanging wreaths during the holidays. The new truck has a longer reach, and it would vastly speed things along," Yarosz said.

A new bucket truck means more efficiency and more productivity, not to mention the amount of money which will be saved when the crew won't have to call an outside tree removal service. Yarosz is still relatively new at running the Crawford Highway Department; getting elected in November, and assuming the role in January. Since taking over operations from former superintendent Larry Marshall, he holds nothing but positivity for the future, especially with the board approving the request for the new bucket truck.

"Our guys are so important. They've really all been great. All throughout the year, they're maintaining the equipment, and they're always out and about making the town the best it can

be. Repairing roads, clearing snow, our guys are the best around. With this new truck too, things should go a lot smoother," Yarosz explained.

Three other surrounding Highway Departments purchased the same bucket truck that Crawford just got approved for, Montgomery being one.

"We've borrowed Montgomery's truck a few times, and boy does it really make a difference. It's better all around with new technology, and will make our crew's day a whole lot easier. It's definitely a big investment, but worth it in the long run," said Yarosz.

A new bucket truck is not cheap, but it's something Yarosz believes will benefit the Crawford highway department for the better. The new model which just got approved costs around \$190,000, and with supply chain delays and COVID-19 still altering shipment and assembly times, the new truck won't be seen on the roads until mid-2023.

"As long as our guys are safe and can get the job done without having to worry about their safety, that's all that matters," said Yarosz.

New town board member

Along with benefits for the Crawford Highway Department, a new face will be seen on the board from here on out. Councilwoman Angelina Jadrossich was appointed on Thursday February 17, taking the place of Kelly Eskew who was elected Orange County Clerk in November. Eskew officially resigned from the town board at the end of December, and Jadrossich is now eager to get to work.

"These are extremely big shoes to fill. Kelly did so much for the town, and it's really an honor to be sitting in her place," said Jadrossich.

Angelina Jadrossich has been working with the town of Crawford for two years as the Vice Chair of the Republican Committee, and prior to that, she was with the Highway Department.

"Politics is my path. It's something I'm very passionate about and it's the way to my future," explained Jadrossich.

Medline trucks continue to be an issue in Montgomery

Despite assurances that it wouldn't happen, Medline trucks continue to pass through the Village of Montgomery.

Mayor Steve Brescia, at a recent Montgomery Village Board meeting, reported on a 29-minute meeting with a Medline representative that apparently resolved nothing.

"Legally we can't fine them for their trucks going through the village," the mayor said, adding that Routes 211 and 17K are state roads.

"It was a somewhat spirited conversation with them for half an hour," added Village Attorney William Frank.

The new warehouse is located outside the village limits, and the project was approved by the Town of Montgomery Planning Board, but those approvals specifically addressed the issue of truck traffic in the village. The Montgomery Planning Board, as lead agency for the project, adopted a New York State Environmental Quality Review (SEQR) statement on April 28, 2020. The findings statement, on page 38, notes that "the village already experiences considerable truck traffic and some village residents have voiced concern regarding various impacts that occur as a result of that traffic." Comments received ...indicated that the unrestricted flow of Medline traffic would exacerbate these impacts and would adversely affect business and quality of life in the

Village of Montgomery.

The findings statement specifically directs the company to install signs at its truck driveways prohibiting trucks from turning right out of the site (towards the village) or left into the site from Route 416. "If those measures do not satisfactorily enforce compliance," the statement adds, "Medline will randomly station a security person on the site driveway opposite Canning Road to intercept entering violators and to report existing violators for as long as necessary to achieve compliance."

"The signs you are referring to were promised over a year ago," Don Berger of Residents Protecting Montgomery noted. Berger said he was also told six months ago that the signs would go up when he addressed the issue with Town of Montgomery officials.

Brescia noted that some Medline deliveries go to the Montgomery Nursing Home, a route in which passage through the village is unavoidable. He asked the Medline rep if those deliveries could be made in a smaller truck rather than a tractor trailer.

Frank reminded the village board that they do have legal recourse if the company doesn't resolve the issue. That resource would be to "go after them" for violating a condition of the site plan approval granted by the town planning board.

Crawford awarded grant, loans for water project

Town of Crawford has been awarded a \$2.3 million grant, plus a low-interest loan from the state for a clean-water project.

The announcement, part of a statewide round of funding, was made last week by the State Environmental Facilities Corporation

In addition to the \$2.3 million grant, the Town of Crawford will also receive \$711,329 in short-term, interest-free financing and \$1.4 million in short-term, market-rate financing for the construction of two production wells and a water treatment building, and installation of some 6,100 linear feet of water main to connect the treatment facility to the distribution system.

"We want to recognize all of the time and effort put into this project by Supervisor Charles Carnes, the Town Board and our grant writing team," noted the town's Facebook page. "The process of writing this grant took an incredible amount of work, and included years of research, data collection, and supporting documentation."

DEC to monitor Tin Brook water

The Town of Montgomery Conservation Advisory Council (CAC) has received word last week that two segments of the Tin Brook will be monitored by the New York State Department of Environmental Conservation as part of its 2022-23 Hudson River Estuary Program Stream Segment monitoring program.

Patricia Henighan, CAC Chairwoman, said the Tin Brook was one of only four streams selected for the program. The others were the Quassaick Creek, the Taghkanic Creek (Columbia County) and the Punch Book (Dutchess).

"With the increase in major industrial projects along the 17K corridor, this will be an important way to measure any deterioration of water quality that can also affect the Walden well fields," Henighan said.

Henighan said the first logical site for monitoring would be the point where the Tin Brook crosses 17K near the Amazon entrance. This would serve as a measure of the impact from the Amazon waste water treatment plant and runoff from the Amazon parking area.

The second recommended monitoring point is where the Tin Brook crosses NYS Rt. 52 near the intersection of Berea Road and St. Andrews Road. This is a critical point as it is downstream of the industrial properties on Stone Castle Road and the wastewater treatment outflow from Holiday Park. It is also a significant point as it is just before the Tin Brook flows into the aquifer for the East Walden well field on Route 52. This second location is important as this area is included in the Wellhead protection overlay which is part of the proposed updated zoning for the Town of Montgomery.

Henighan said the DEC's decision would also help

the CAC's proposal to create Critical Environmental Areas on the Tin Brook and Beaverdam Brook Aquifer. A Critical Environmental Area is a geographic area with unique or exceptional characteristics. Local governments are authorized to designate CEAS under State Environmental Quality Review (SEQR) regulations.

Maybrook incumbents run unopposed

When Maybrook voters go to the polls on Tuesday, Mar. 15, they will find all village board incumbents running unopposed.

Mayor Dennis Leahy, Deputy Mayor Robert Pritchard and Trustee Daryl Capozzoli are all running for re-election to two-year terms each. There is no official opposition.

Voting is noon - 9 p.m. at the Maybrook Senior Center in Veterans Memorial Park.

Walden mobile home park looking to upgrade

Representatives of Walden Glen LLC, a mobile home park at 132 North Montgomery Street in the village were due to return to the village zoning board of appeals (ZBA) this week in search of a favorable determination that would allow for larger, but fewer, lots in the park.

The owner of the park is seeking a variance from the village code two permit property units to have a minimum side-yard distance of 14' 6" - from the property line, when 50 feet is currently required. It's part of a larger plan to redraw the lot lines within the park.

Attorney John Cappello told the ZBA that single mobile home units are no longer preferred. Double-wide units are now the preference.

"What we are proposing is less non-conforming than what is presently allowed," Cappello said.

The park, which is Walden's only mobile home park has been in existence since "prior to 1975," according to its ZBA application. In March 2001, prior to the current owners purchasing the property, the Walden Building Department confirmed at 53 trailer sites existed, though most of the lots were not occupied.

In 2003, the owners sought to replace the single-unit lots with lots large enough to accommodate double-wide mobile homes, with the number of sites proposed to be reduced from 53 to 43.

A representative for Walden Glenn told the ZBA that only 12 of the units in the park are currently occupied, and that there have not been more than 14 over the past "four or five years."

A public hearing before the ZBA last month had been adjourned until Feb 23.

Walden to honor Sam Wright

He was a star on the Broadway page and a patron of the arts in Walden. Now Sam Wright's adopted hometown is looking to honor his legacy.

The Walden Village Board is considering a proposal to rename Albany Avenue - the village street in which he lived - as "Samuel E. Wright Way."

"I've known Mr Wright," said Mayor John Ramos. "I've sat on his porch a number of times, watching cars go by."

Wright, who co-founded the Hudson Valley Conservatory of the Arts with his wife Amanda, lived on Albany Avenue near the entrance to Bradley Park. He passed away in May of 2021.

The village board directed Village Manager John Revella to contact the 11 families that currently live on Albany Avenue to solicit their input. The village board will discuss the matter at its March 1 meeting, beginning at 6:30 p.m. Anyone with any comments or concerns is invited to come to the meeting, or contact Revella at 845-778-2177, ext 1500 or email him at manager@villageofwalden.org.

Walden to meet with ambulance consultant

Timothy Egan, the Town of Montgomery's newly-hired ambulance consultant, will visit with the Walden Village Board on March 1 as talks aimed at bringing the village of Walden into the new ambulance district continue.

The Montgomery Town Board formally created the ambulance district on February 10. The initial district map includes the villages of Montgomery and Maybrook, but not Walden, which has not voted to opt in. At that same meeting, the town board also approved an agreement with Lighthouse Networks Inc. for consultant services related to the town's Emergency Medical Services (EMS) and the corresponding ambulance district, at a cost not to exceed \$7,500 annually. Walden officials, as well as Maybrook Mayor Dennis Leahy, had urged the town to hire a consultant as part of the process.

Though not part of the initial Town of Montgomery Ambulance District, which officially goes into effect in 2023, Walden officials have stressed that village residents will not be without ambulance service and that they are continuing to study the ambulance district proposal and are also looking at other models, including the Town of New Windsor and the Plattekill EMS Service.

"I firmly believe we are giving this 110 percent," said Mayor John Ramos. "We are not taking this lightly."

will construct two structures, a 16,642 square foot building and a 5,000 square foot building.

The hours of operation for the business will be 7 a.m. to 7 p.m. during the week, 8 a.m. to 5 p.m. on Saturdays and no operation on Sundays or legal holidays except on limited instances during emergencies.

In addition, the truck operators for the business may only travel at a maximum speed of 20 mph on Ridge Road, which is 10 mph less than the posted speed limit.

Dunkin Donuts

The owners of the Dunkin Donuts located on Route 208 near McDonalds have purchased the vacant parcel next door and are looking to relocate their franchise to the new location.

The property was originally slated to become the home of a restaurant—part of the Devitt family subdivision project around 2010 that also saw the creation of the Holiday Inn—but there have been no takers.

Now, blessed with the problem of too many customers, the owners of

the Dunkin Donuts are seizing the opportunity.

“What we’re proposing is a dual drive thru, a dual order board situation,” said Ross Winglovitz, engineer for the applicants.

The new location will no longer exit onto Route 208, but will instead exit onto Goodwill Road. The building will be 2,680 square feet.

Planning board member Cheri Zahakos asked fellow board members if a new traffic study should be done for the parcel, given that the traffic generated by the Dunkin Donuts will be more intense than was anticipated for a restaurant.

“It’s getting very congested and it’s getting to the point of concern, I think,” said Zahakos. “Should we request a study so we understand the impacts of something like this?”

Winglovitz admitted that the applicants will of course want to grow their business with more customers, so it is possible that the new location will have more traffic than the first, but he believes it will be better handled.

“The benefit being, with the much longer queue, and the location of the drive-thru, we won’t have anyone

backing up into 208, which does happen occasionally,” said Winglovitz.

Members of the board noted that it is more than an occasional occurrence and when an unknown new business takes over the former Dunkin Donuts location, it “could compound the traffic.”

Winglovitz said that “gridlock situations” are occurring, but he feels their plan will solve the issue, as it enables them to have 20 cars in the queue, which is “significantly more” than any other drive-thru that they have, or project he’s worked on. He also does not believe that any new user for the old building will generate as much traffic.

The applicants plan to stay with the trademark architecture of franchise, with earth tone colors and their pink and orange signage. They would add a sign next to the existing hotel monument sign.

The proposal will return before the board at their next meeting, where they anticipate tackling SEQRA, and in the meantime the applicant and board members will work on various issues including looking into traffic accidents at the location, architectural

renderings, the project’s proximity to Goodwill Church and other items.

Cell Tower

The planning board also discussed a proposal by Verizon Wireless to construct a cell tower on Stone Castle Road. The proposed tower would be 155 feet tall and situated very close to the road. Verizon is seeking variances from the ZBA and the planning board was asked to send their recommendation to the ZBA prior to their meeting on Feb. 22.

After discussing the project and its “major visual and potentially harmful impacts” the board agreed to send a letter to the ZBA asking if the tower “could be lower in height and situated on the site to avoid” those impacts.

The planning board decided to table their comments on proposed amendments to the town’s zoning law, noting that the town board had moved forward with amending and did not wait for their comments that they had been preparing. The planning board plans to discuss the proposed amendments at their workshop in advance of the hearing on the proposed new local law.

strategy.”

Geidel explained that she, along with the Board of Education, understands that the mandatory mask wearing has had a negative impact on many students. She went on to say the district is hopeful that New York State Governor Kathy Hochul and the New York State Department of Health will recognize that the cases in the community and schools have lessened and respond by ending the mask mandate in schools. Geidel shared that she attended a Zoom meeting earlier in the week with Senator Mike Martucci and Senator James Skoufis through the Orange County School Boards Association to advocate for local scholars and educators. The discussion went well and the message was loud and clear what local schools want in place.

“We had representation from every district in the county and let me tell you what our message was to our senators. It was very clear. It is time for parent choice when it comes to masks

in school. During the Zoom meeting, it was also requested the Governor and the Health Commissioner provide reasonable, achievable metrics based on regional positivity rates and not tied to vaccination status,” Geidel shared.

In addition, Geidel spoke about the difficult part for school districts when information is given on a Friday evening and districts are expected to get the message out in a timely fashion. “So we made it clear to them that they have damaged the trust between school members and superintendents and our school board and parents. We have no control over when they make these announcements, but we did make it very clear in this instance that we cannot abide by that anymore,” she said.

After working with Senator Martucci and Senator Skoufis, Geidel said change is not expected for another few weeks which is frustrating for all parties involved at the district level.

Pine Bush Board of Education President Gretchen Meier thanked families and staff for their continued

patience and respecting the people that may have a differing view than they have. “We have a lot of passionate community members that come to these meetings to share their frustrations with the continued mask mandate. We have an equal number of families that don’t want the mask mandate lifted. So even when the mask mandate is lifted masks will still be optional and I would like to urge people to teach your children to respect the kids that may still be wearing a mask because that’s going to be their choice just the same as it will be the choice of the people who don’t want to wear the mask and that’s a very important lesson here,” she said.

Meier encouraged families to show up, write letters, make phone calls and contact their local political leaders, “That’s how change happens and we’re doing everything we can from here.”

Valley Central School District officials, parents and community members echoed the cries and frustration of their counterparts in Pine Bush. Superintendent of Schools John Xanthis shared a letter from area

superintendents to the New York State Department of Health Commissioner Dr. Mary Bassett with those in attendance. The major concern being ongoing mandatory masking and protocols. The letter requested clear guidance and achievable metrics for districts. “I know people are as frustrated as we are with the masks and we’re hoping for some relief. We’re still hopeful,” he shared.

“I’ll just say it’s been a long road. We’ve had suffering with all of the different mandates and I think we’re all tired and ready for this change,” said Valley Central Board Member Diana Revoir.

On the February 14 agenda, the Valley Central School District voted to approve a resolution to modify the Reopening Plan developed by the District. By adopting the resolution, the Valley Central Board of Education authorized the Superintendent of Schools to modify the District’s Reopening Plan to state that masks will only be mandated if there is a legal requirement in place at the time.

GNSO to present 'Concert of Concertos'

The Greater Newburgh Symphony Orchestra (GNSO) will perform a special concert on Saturday, February 26 at 4 p.m. at Aquinas Hall on the Mount Saint Mary College campus in Newburgh. This "Concert of Concertos," under the direction of Maestro Russell Ger, will feature the works of composing giants Dvorak and Prokofiev performed by two soloists accompanied by the GNSO orchestra.

"A concerto is any piece for solo instrumentalist and orchestra," said Ger. "One of the hallmarks of a concerto is the dialogue between the group (orchestra) and the individual (soloist). Sometimes it is cooperative, sometimes competitive and sometimes an outright confrontation. All these shades will be on display, embodied very differently by the two composers."

This special concert represents the third year of a unique partnership between the GNSO and Moxart, Inc., a Philadelphia-area non-profit organization whose mission is to provide musicians with opportunities that would otherwise not be available. Moxart's Concerto Program enables accomplished, non-professional musicians to play a concerto with a fine orchestra. After their great success in Philadelphia, Moxart continued to expand by reaching out to the GNSO in the Hudson Valley.

"After the great success of our inaugural collaborations with Moxart," Ger continued, "we are thrilled to present this program. The two works on display this year couldn't be more different. Dvorak's only Piano Concerto (soloist Alan Murray) is one of the most beautifully lyrical ever written. The composer's gift for melody was envied even by the great Brahms, and here it is on full display.

The piano is so fully integrated into the fabric of the piece that it is more like a symphony than a show piece for the piano. Prokofiev's Piano Concerto No. 3 (soloist Mo Xu) from 1921 is bold and energetic, forged in the heady afterglow of the Russian Revolution. It moves from gentle melancholy to quirky variations to a powerful finale that is a kind of off-kilter march parody that ultimately gives way to a gorgeously Russian soaring melody before its brilliantly vivacious conclusion."

Shawangunk discusses short-term rental law

Although a public hearing on Feb. 17 was held to discuss three proposed zoning laws in the Town of Shawangunk, the law that would allow short-term rentals within the town's boundaries took center stage at the Town Hall.

Six members of the public gave their views on the merits of all three local laws. But not surprisingly, Local Law No. 3, which seeks to regulate the location and operation of short-term rentals in the town, drew the vast majority of the comments from a modest turnout.

After the public had finished providing its input, Supervisor John Valk said the board would keep the hearing open for two more weeks to give town residents more time to provide feedback on all three local laws.

Valk was surprised more people didn't show up to give their input at the hearing, particularly since the proliferation of short-term rental properties had sparked controversy in neighboring communities.

"I just want to hold it (the public hearing) open because it seems like there should be more people with an opinion," Valk said. "I thought there would have been more."

Valk thought the feedback from town residents would be helpful to the Town Board in the long run, however.

"I was pleased that everybody read the law differently and came up with the same comments," he said.

Adrienne Gelfand-Perine asked whether short-term rental owners were required to live on the property.

"It can be either or," Valk explained. "If they don't live on the premises, it's a little bit more of a review process. That's what we're planning for. But if you're going to live on the premises, all you have to do is register for an inspection with the building department."

In response to another question, Valk said short-term rental owners are required to report owning their rental to the Ulster County Finance department so the county could collect an occupancy tax. It is currently 2.0 percent.

Pine Bush real estate broker Richard Parzoch told the board that he thought the short-term rental law was too restrictive.

"I think some of this is excessive," Parzoch said. "I understand we're trying to protect the public and make everybody behave conscientiously and be a good neighbor. But this is very, very bureaucratic and overburdensome I think."

Though the proposed short-term rental law has a section that says events at the property should not create "excess noise," Andy Ghiorse felt the language needed to be strengthened.

"Noise is very subjective," he said.

Ghiorse said electronically amplified music or speech should not be heard past the property lines of neighboring residences.

Richard Barnhart encouraged the board to adopt all three local laws. But he was worried about too many short-term rentals locating in the town, particularly those without landlords on site.

"I think the Town Board should set a limit on them," he said. "That limit can be adjusted at various times, so that we're not inundated with too many of these things. And we should have a direct line to whoever the ownership is."

The other two local laws drew little comment from the public.

Local Law No. 1, which is known as the "Lot Line Adjustment" law, will establish procedures and requirements for allowing lot line adjustments and natural subdivisions in the town. One of its goals is to minimize the costs to landowners who are seeking simple adjustments to property lines.

Local Law No. 2 is described as the "Accessory Dwelling Unit" law. The intent of the law is to streamline procedures and requirements for allowing accessory units within the town.

New board member Alex Danon told the Wallkill Valley Times after the meeting that he felt the board

would make some revisions to the local laws after hearing public input. But he seemed to think all three would eventually pass, including the short-term rental law.

"It's already happening," Danon said. "Any towns that try to fight it are swimming against the current. It's here. It's not a bad thing. We need the tourism money. And one of our biggest draws is tourism. People coming up and enjoying nature, which we have. We need to take advantage of it, but we need to make sure we do it properly."

Valk set no deadline to bring the three local laws up for a vote.

In other news, Councilman Adrian DeWitt proposed rates for the town's six-week summer camp at Verkeerderkill Park that will run from July 5 through Aug. 12. The board voted 4-0 to charge a fee of \$575 for town campers and \$650 for out-of-town campers.

A \$25 discount is available if payment is made before May 1.

DeWitt said the camp has room for 80 to 100 participants.

The board voted 4-0 to approve the purchase of a new police vehicle for \$48,072 following a request from Police Chief Gerald Marlatt.

Saint Patrick's Day Parade Committee member Anne Barnhart confirmed that the annual parade will begin at 2 p.m. on March 20 at the Middle School.

DA urges pay raises for police

Orange County District Attorney David M. Hoovler, last week encouraged Orange County's municipalities to take steps to raise the pay of their current police officers, and to offer higher salaries to potential future officers in their police departments. That action is necessary to stem the loss of qualified officers to agencies in other counties or out of the policing altogether.

"Our local police officers are the front line in protecting our citizens," said District Attorney Hoovler, "and are usually the first responders to all types of emergencies, including medical emergencies. We count on them for a variety of services, over and above their duties in investigating and preventing crime.

"Unfortunately, increased demands on policing and salaries that don't

keep pace with those demands and with the cost of living have resulted in many officers retiring from policing and leaving the profession for more-lucrative opportunities in other fields. Even those that stay in policing often leave local agencies for higher-paying positions in other counties or states, or in federal or state service. The same is, unfortunately, true of prosecutors and all others involved in protecting the public safety."

"I realize," continued Hoovler, "that municipalities have to keep an eye on their budgets. But in doing that, municipalities should put a priority on salaries for police. Public safety demands that we recruit, train, and retain the best police officers available, and only through an increase in their salaries can we accomplish that."

Celebrating the life of Sojourner Truth

It is fitting that during Black History Month, the Ulster County Legislature has chosen to honor one of its most prominent historical figures, by declaring that it will permanently designate November 26 as Sojourner Truth Day.

The face and the voice of Sojourner Truth are interwoven into the rich history of Ulster County and the Hudson Valley and in the birth of the American Civil Rights movement.

Sojourner Truth was born Isabella Baumfree, more than 225 years ago, to enslaved parents in the Town of Esopus. Around the age of nine she was separated from her parents and sold several times before claiming her freedom in 1826—one year before New York's law to abolish slavery was to take effect. After Truth's enslaver failed to honor his promise to free her, she carried her infant daughter Sophia on an 11-mile walk to freedom over the Shaupeneak Ridge.

In 1828, she became the first Black woman in the United States to win a lawsuit against a White man when she took her enslaver to court for illegally selling her 5-year-old son to an Alabama slave owner. The landmark case resulted in Truth being reunited with her son Peter.

Inspired by the belief that God was calling on her to travel and preach about the causes, she chose the name Sojourner Truth in 1843. Her prolific speeches against slavery had made her a leader of the women's and civil rights movements.

The date of November 26, which this year falls during Thanksgiving Weekend, marks the anniversary of her death in 1883. Advocates have chosen to commemorate her life on November 26 because the date of her birth is unknown.

Sojourner Truth dared to speak out, risking her life in the cause of freedom. She lives on as an inspiration to all people of color, to women and girls and to all who seek and stand up for the cause of freedom.

An unexpected convergence

Over the week I experienced a serendipitous convergence of two recent column subjects. In “The Falling Houses of God” I wrote about the troubling state of practical affairs faced by the Shawangunk Reformed Church, a beautiful 18th century stone building on Hoagerburgh Road: a new roof, an extended overhang, stonework repair, repointing, cable work, etc.

In a second column, this one about my father’s would-be 101st birthday, I mentioned the two of us worked together building, once upon a time, for the Shawangunk Valley Conservancy, an

exact replica of the carriage house found at the Quaker Meeting House in Cornwall. Back when the country was young, practitioners parked their buggies in the shed while in church. Is it a church? I guess not. It’s a meeting house. That sounds like an establishment where you drink copious tankards and start a revolution. Yet, when you enter the meeting room there is nothing but icon-less white paint and robin egg blue pews and a firm settling in of peace. The Quakers are noted pacifists and declared their neutrality during the Revolution. This week, the two stories – state of the Shawangunk Church and the building of a carriage shed – converged.

I received an email from Peter Phillips. It was forwarded to me through my editor. The name sounded familiar, but I couldn’t place him until we met in Cornwall at the meeting house. In fact, I couldn’t place him then either. He refreshed my memory by telling me twenty years ago I had built a set of stone steps for him at his residence in Thompson Ridge – the old Bucky Andrews Farm. “I think of you every time I walk up the steps,” he convivially conveyed. “So nice of you to say,” I said.

Peter asked me to take a fulsome gaze at the leaning carriage shed and see what needed to be done, if not to restore it, then to at least stabilize the noble structure. On the drive over, there was a blinding snow squall with more to come, but while we conducted our investigations the snow dropped off and the wind calmed itself. The Quaker Meeting House was built in 1791; the carriage shed some years after, c.1795. The shed is 80 feet long, with 5 fifteen-foot bays. It is 25 feet deep and has

a massive front overhang creating 6 to 7 of those feet. It is this big overhang, with no direct ground posting, causing most of the building’s stress. (See photo.) The beams, sill plate and posts are hand hewn. The rafters were cut with a two-man straight saw, not hewn, and not cut in a sawmill with a round blade. What nails I could find were hand-forged. The building is held together with wooden pegs. Not bad for 230 years.

The building is folding in on itself, wanting to tip forward to rest the overhang on the ground. The main framing posts are set on the ground, not stone, and their bottoms have softened allowing the building to shift downward. This tips the back wall forward into the building. Most of the rafters were never nailed and have pulled away from the back roof sill beam which runs the length of the building in the back. The central back post which supports this beam has rotted away. There is evidence the roof leaked at this point for many years. The east end wall needs new siding boards. The east end central support beam which carries the roof beam (“Raise High the Roof Beam, Carpenters” J.D. Salinger) appears to be eaten away by insects, but a full inspection is warranted. A solid rod of good intentions holding the back beam to the central main post, spins, is not tight and has no effect. A cable running from the front overhang through the back wall to a tree stump to keep the front of the shed from moving forward, is useless as the tree is now dead and cut off and the stump like powder in a blunderbuss. The roof, originally cedar shingles, has tin shingles flapping in the breeze. These are the issues.

The fellowship, if I can call it that, has a

membership of some thirty families. The tithing barely covers the upkeep, the mowing, the repairs of graves in the quaint, adjacent hillside graveyard. Like the Shawangunk Reformed Church, this site is on the National Registry of Historic Places. Also, like the Shawangunk Church, adequate upkeep of these national treasures is far beyond the pecuniary capabilities of the congregation. What’s to be done? The federal government and the state of New York must begin to put together a coherent program of recognition and funding for the stabilization and restoration of these irreplaceable historical buildings, regardless of religion. A National Registry of Historic Places deserves a publicly-funded trust for Historic Properties. We are two and one-half centuries out from the original construction of these charmed buildings. It will be a disgrace and black mark on our generation to allow them to return to the earth without a fight during our stewardship.

the Kraft Food Co. At 18 he joined the Navy and served 2 years as a Sea-Bee stationed outside of Sasebo, Japan during the Korean War. He returned to the states in 1953 and went to study at the University of Washington in Seattle. After 2 years of that-combined with his military service-he felt he had "lived enough" to know he was ready to make his own way.

During those years away from home Pete wrote letters frequently to his parents. His father's admiration and pride in his son's writing - he could see his talent - combined with his business connections through Kraft- eventually helped Pete land a job at the J. Walter Thompson Advertising Agency (JWT), in Canada, in 1956, where in 1960 he made history as the agency's youngest Vice President (and again in 1965 at the NY branch)

Thus began his lifelong career in advertising, marketing and design...fueled by his fierce passion for integrity, creativity, research/history, generosity, and his fundamental curiosity and love of people and their lives and the stories they can tell - bringing all that together.

Eventually Pete transferred to JWT-NYC in 1965. In 1973, a few years after leaving JWT, Pete became a founding partner, chairman and creative director of Mathieu, Gerfen & Bresner, famous for bringing Perrier's sparkling water campaign to the U.S. After a partnership with The Bloom Agency from 1981-1991, Pete once again started his own agency Pete Mathieu & Associates and moved his residence and business up to Montgomery.

NYC was not only the cradle for his professional success through the early 90s, it was also the backdrop and the literal ground below his feet for his training for running at least a dozen marathons and countless other races. His natural drive and passion to work hard and play hard spilled over easily into this discipline. And to be in a city that he loved! His agency helped promote The Perrier

10K Series, and he played a minor role in helping Fred Lebow promote the NYC Marathon in its early days. Bringing this passion to Montgomery, he was the driving force in creating and organizing the General Montgomery Day Super 8K Race in 1991 and to this day it remains one of the area's most successful races.

Pete had many friends and made many more while living in Montgomery. He is known for his generosity to friends and family; for his parties, large or small, sometimes with a theme-e.g. his Saturday before Thanksgiving "Friendsgiving Party", inviting guests to bring a side dish that "meant" Thanksgiving from their family recipes or menus. Also, Pete was known for his love of the Village and the Town of Montgomery and for his love of his country - Pete held a deep pride for his fellow veterans and almost always wore his Veterans cap when going out and loved the conversations it would start and his landmark house was always bedecked and flowing with multiple American flags. When not running he loved his early morning walks through the village or hiking "The Gunks" at Mohonk Preserve.

He continued, into his early 80s, to work or volunteer his time and expertise either for a client or a good cause that he took to heart, or for town issues and events, including:

Hudson Valley Cancer Resource Center-he was a founding member of its executive board, Orange Regional Medical Center, Orange County Firefighters Museum, Orange County Office of the Aging. He helped brand the "March With Us" Memorial Day parade in Montgomery. In 2015 he was nominated Grand Marshal for the General Montgomery Day Parade.

He knew how to enjoy his life and he made a point to share that joy.

Also well-known are his loves of golf, cooking, eating, drinking tequila, swearing, flipping you his middle fingers, and his fury if you tried to touch, let alone look at, any of his NYTimes crossword puzzles which he worked on daily, in ink!

He is survived by his son Robert Mathieu and his daughter Christa Mathieu in the US, and in Canada by his brothers Richard Mathieu and Jackson Mathieu including their wives and families, also by his beloved cousins living up and down the American west coast.

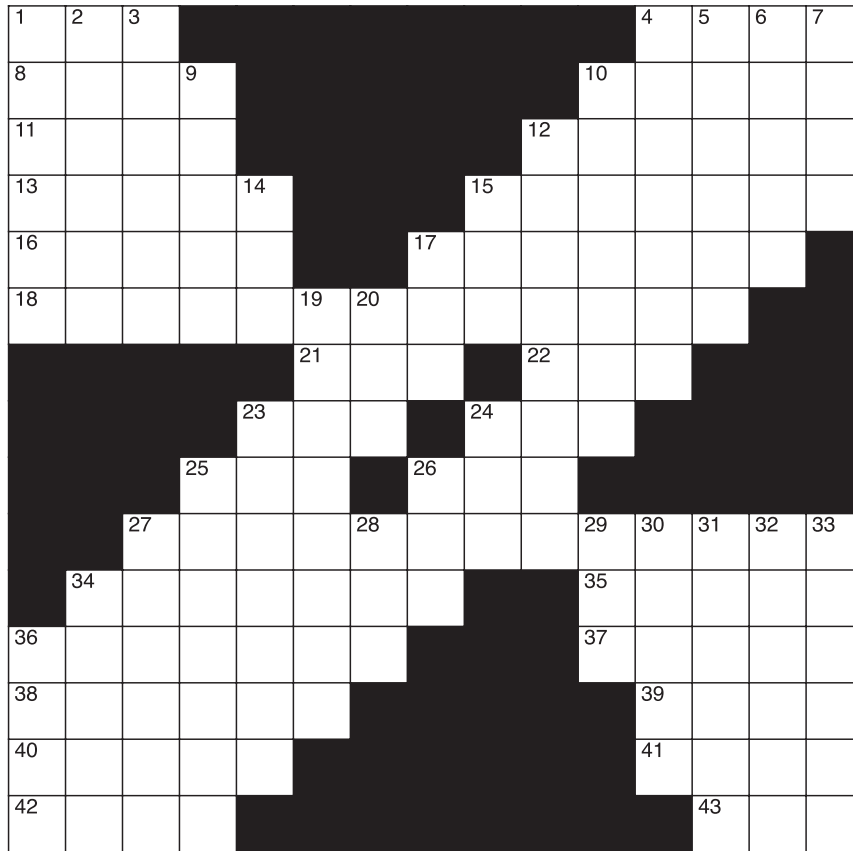

Five local wrestlers head for state tournament

Five area wrestlers will get their first taste of the highest tournament in New York State when they hit the mat for the New York State Public High School Athletic Association Division I tournament on Friday and Saturday at the MVP Arena on Friday and Saturday.

Valley Central's Luke Satriano (102 pounds) and Nick Weeden (110) became the first multiple Vikings to go to states since the mid-2000s when they won the Section 9 championship in their respective weight classes.

"I'm on the stat team and I'm excited to be with my boys (Nick and Sebastian)," Satriano said. "I'll see where that takes me."

The other three – Valley Central's Sebastian Vidacovich (126), Wallkill's Rocco Futia (118) and Pine Bush's Brayden Pennell (189) qualified for the

tournament by finishing second, or in some cases true second.

"It's a good feeling," Vidacovich said. "I feel like I've wrestled hard this season, and I feel like I definitely deserve to go. I put in a lot of work over the off-season. I wrestle year-round. So, I feel like this is right where I want to be."

Under the new system, Section 9 had two automatic qualifiers in a system based on how many points a section scores during the tournament on a three-year average. Sections 8 (Nassau County) and 11 (Suffolk County) are at the top of the list so they send three wrestlers.

Section 9 is in the middle of the pack

and gets to send two.

"The better you do, the more chance you have of getting those three qualifiers," Section 9 coordinator Jeff Culty said. "So, if we run off a string of two or three years in a row with a lot of placers, we might knock off one of the Section 8 or 11 teams and be able to bring our top 3 instead of top 2."

Under the old system, which Culty designed, was based on a points system, and every coach and chairman had to make sure every point was calculated correctly. It got messy.

"We had parents suing us because they said we missed a point or something like this and they're arguing with

the criteria," Culty said. "So, we decided the better way to do this is wrestle your way in. Every kid who's going to the state tournament this year knew what match they had to win to get to states. If they won the match, they're going; if they lost the match they're not."

Futia placed third in the sectional tournament, and pinned Minisink Valley's Sofia Macaluso to clinch his berth in the tournament. Pennell placed second but had to defeat third-place finisher - Goshen's Max Winkler – to take his state berth.

Futia and Pennell are the lone representatives from their teams. Futia's younger brother, Marco had his own opportunity to wrestle for a state berth at 102 pounds, but he lost his true second match to Newburgh's Cooper Merli.

"Marco will be there, anyway."

"I was hoping he'd get through," Futia said. "Him and Cooper have wrestled a bunch. Cooper's had the better of him the last few years, but I'm glad they got to wrestle again."

The tournament will begin at 10 a.m. with Friday's first three rounds, ending in the quarterfinals. The consolation Wrestlingbacks will begin after the quarterfinals end.

Semifinalists and consolation finalists will make it to Saturday.

"We know it's going to be tough," Vidacovich said. "There's a lot of kids that are going up there from all around New York State, but we all know that we have the ability to wrestle good. We're just going up there and we're going to wrestle as tough as we can to try and win."

Pine Bush finished second in the 200-yard freestyle relay on their way to a third-place finish at the Section 9 boys' swimming and diving championships on Saturday at Valley Central High School.

The Valley Central Vikings, who have been coached by Scott Warner for the past three decades, finished seventh with 157 points. Warner is retiring at the end of the year and was presented with a plaque in recognition of his service to the sport.

Warner also was named Coach of the Year for the second straight season by Section 9 swim officials. He received the same honor in November at the girls' swimming sectional meet.

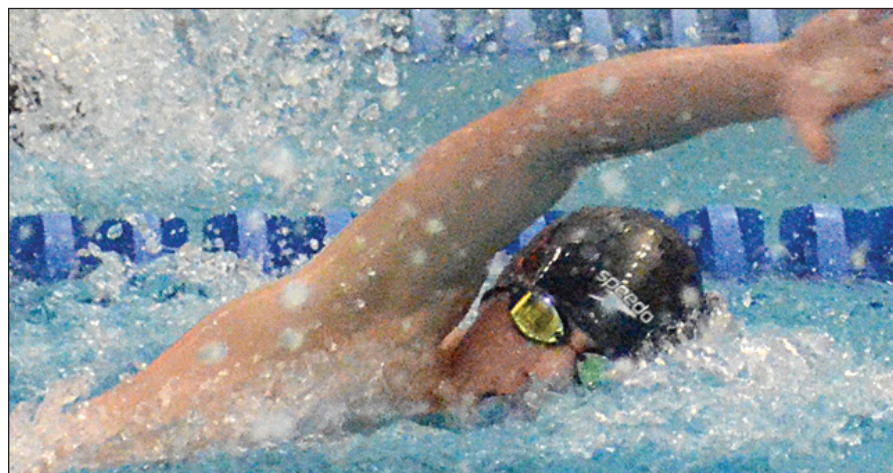

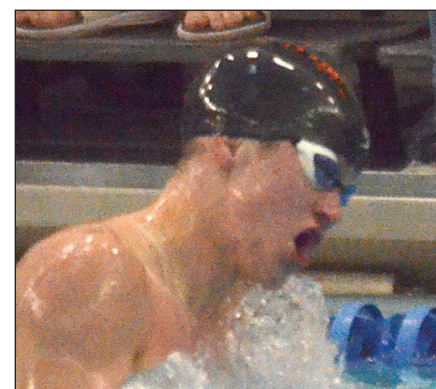

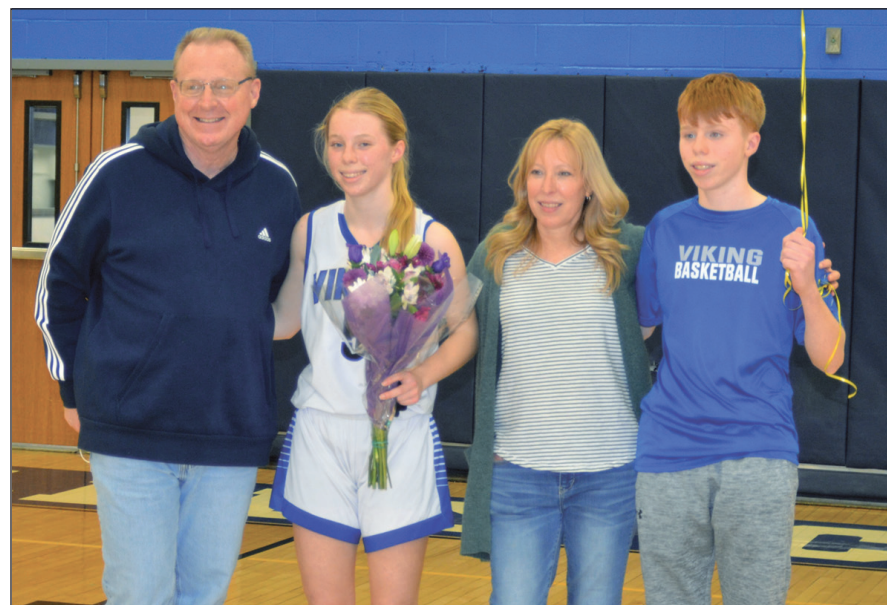
"It was just great," Watson said. "I mean it's great with the end of the season and it was a great way to remember my senior year."
