## Shawangunk road woes persist

Two Town of Shawangunk residents complained that their roads were not up to snuff at the May 5 Town Board meeting.

Valiant Jones of 56 Pleasant Ave. told the Town Board that road flooding has forced him to make over \$6,000 worth of repairs to his home in the past four years.

Jones stated that he felt the town's highway system "has done me and my family a disservice. My home constantly floods every time it rains since that road has been put in."

Jones said he has been in constant contact with first-year Highway Superintendent Richard Blazeski about the flooding caused by the road being higher than his driveway.

"He's been working hard trying to get a solution, but he has no solution for me because the people who built the road have no solution for him," Jones said. "The drainage system over there is a disaster. It does not work. My garage floods which leads to my master bedroom. My living room floods every time there's a downpour."

Blazeski, who attended the meeting, said he has discussed two solutions to the flooding problem with Jones.

Jones wasn't satisfied with that answer.

"Listen guys, I'm here because nothing is getting done," Jones said. "I'm a taxpayer. I own the home. Me and my wife worked hard to purchase

## Support gathers for VC educator

Long-time Valley Central School District employee Tammy Coleman had supporters showing up on her behalf at the recent Board of Education Meeting after reports surfaced that district officials are seeking to fire her with only three years remaining until she retires. With more than 23 years in the Valley Central School District, Coleman has worked her way up the

ranks having numerous roles over the past two decades.

Her career with the Valley Central School District began in 1999, when she was hired as a middle school computer teacher. She was a tenured teacher prior to moving over to working in administration after earning her administrator degree at the urging of colleagues and former supervisors. Coleman's responsibilities with the district are no small feat, she is

currently the Director of APPR, the Director of Data and Testing, and the Director of the Universal Pre-K program. In 2021, Coleman applied for a UPK Expansion Grant and the VCSD was awarded \$400,000 in Expansion Grant Funding.

Coleman asked the status of her tenure two years ago and she was denied the opportunity at the time

# Pine Bush prepares for 75th Memorial Day Parade

The 75th annual Memorial Day Parade is set for Monday, May 30 in Pine Bush.

The parade kicks off at 9 a.m. at two different launch locations. All marches and on-foot participants will start at Chrispell Middle School, and all wheeled vehicles will launch at Pine Bush High School.

All floats and people involved will be honoring the men and women who bravely fought, and continue to fight for the United States of America. Three organizations got together and planned the parade, and they include the Pine Bush American Legion Post 1308, the Catholic War Veterans Post 1937, and the Veterans of Foreign Wars Post 5492.

“This is going to be one of the biggest parades we’ve had in many years, and all of us are glad to be a part of it,” said Veteran Don Bruyn, member of the Pine Bush American Legion.

Each launch location will be packed with participants for the parade. The lineup at the middle school includes

line dancers, Pine Bush little league baseball teams, the Boy Scouts of America, the Pine Bush Community Band, local young athletes, including all-star cheerleaders. Leading the way will be the Color Guard, formed with the fire department and police department. At the high school, onlookers will see army corps engineers driving military humvees, horses, tractors, and firetrucks.

There will also be refreshments with hotdogs and hamburgers throughout the day.

The proceeds gained throughout the day will go to a new monument at the town park in Pine Bush. All three organizations are involved with the construction of this new monument, which will honor veterans from around the area. Along with the monument, the organizations are also involved with the hometown hero banners on the light poles lining Main Street in Pine Bush. There will be 53 banners now in the Town of Crawford, all thanks to the support and donations by the community.

“We thought we were going to have maybe 20 banners by memorial day. Now we have 53 and we couldn’t have done it without the amazing community rallying together and helping us get these banners, honoring our heroes from the area,” explained Dan Brozio, commander of the VFW post 1937.

Memorial Day T-shirts are currently for sale, also benefiting the new monument. Every Saturday from 9am to 1 pm, a few members from each Veteran organization will be outside of Valley Supreme Liquors on Rt. 52 selling these T-shirts. They will be available in gray and red colors and sizes for everyone.

“This parade, and the whole day in general, is so important for us Veterans,” said Bruyn. “Seeing everyone come together and working towards a special goal is really great to see. Our community is also a real help, and it’s amazing that they’re involved. I wouldn’t want it any other way.” said Don Bruyn.

The parade will take place rain or shine.

# “Skip” Chambers honored for 70 years of fire service

In front of a room filled with friends and grateful residents, the Montgomery Village Board, last week, honored a pillar of the community.

Norbury “Skip” Chambers, recently recognized by the Montgomery Fire Department for 70 years of service, received a plaque from the village board to commemorate that milestone.

“We can’t say enough about Skip,” said Mayor Steve Brescia. “He’s one of the premier cornerstones of the Village of Montgomery.”

“Your father and I joined together on the same day,” said Chambers in reply to the mayor.

Chambers, who turned 89 on March 1, is the third generation of his family to operate a business in the village. He currently operates Chambers Ford Tractors on Route 17K, next to the Montgomery Firehouse. At one time, he was recognized as the number one Ford tractor dealer in New York State.

In a recent interview with Village Historian Brian Fitzpatrick, Chambers said his grandfather had bought that

property in 1865, moving there from Coldenham. His grandfather conducted horse and wagon sales on the property until his death in 1947. His father was born in Montgomery in 1909.

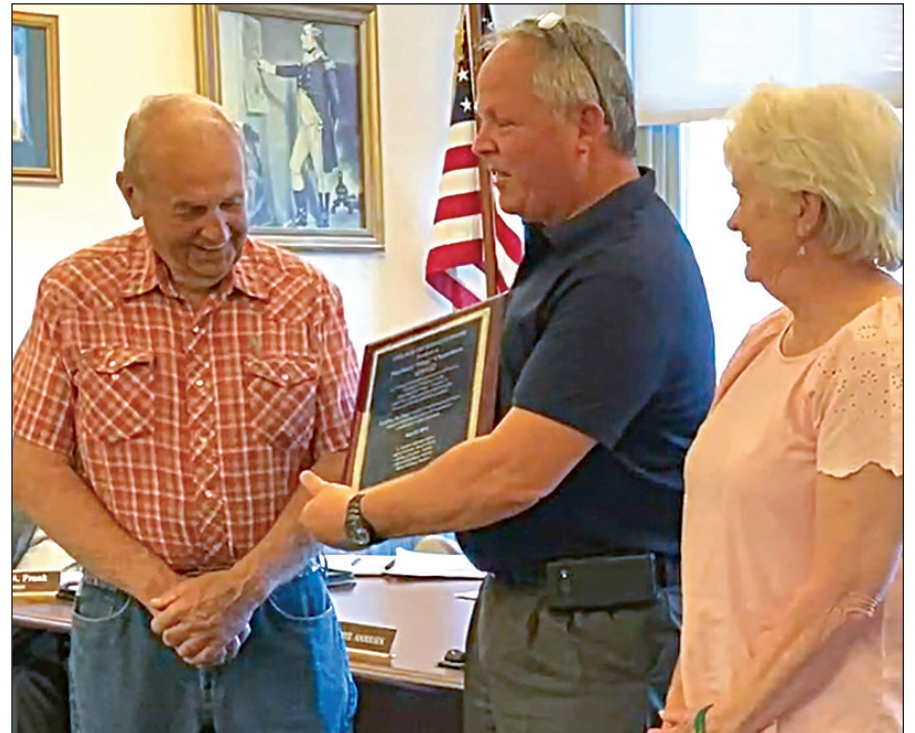
As a child, Skip milked cows before going to school in the morning.

“I remember my father saying when I was 10 years old, you’re old enough to get up and milk in the morning,” Skip said in the interview that can be seen on the Facebook page of the Village of Montgomery Museum.

His father sold work horses to farmers, until after World War II when tractors became plentiful. Skip had offers from three tractor manufacturers, and ultimately settled on Ford.

As a volunteer firefighter, there have been many memorable experiences, including the 1960 NASCAR race at Orange County Airport.

“I sat there on the fire truck with Richard Petty,” he recalled. “I was there with the pit crew.”

# Crawford sees need for affordable housing

The current lack of affordable housing is taking its toll on residents of New York State. The circumstances of the current market is hurting people in the workforce, seniors, veterans, and people with special needs, more than others. Developer Jonah Mandelbaum has been creating affordable housing projects for several years, many for the groups mentioned previously. He has over 3,000 developments to date, and the Town of Montgomery might be next on the list.

Mandelbaum went before the Montgomery Town Board with the idea, and is currently waiting to get the final overlay zone. Once that is approved, it will then go on to the planning board.

The Town of Crawford is also considering a project very similar to Montgomery, but nothing is in motion yet.

“There is a big need for affordable housing for vets and those in the workforce. We also need to support local businesses and this would help them out as well. There are very few lots or homes available in Crawford

and Pine Bush, and most if they are even available, are at a very high price that those groups cannot afford,” said Town of Crawford Supervisor Charles Carnes.

Developer Mandelbaum, a Veteran himself, realizes the lack of affordable housing is a county wide issue. He met a woman in the Town of Montgomery a few years ago whose grandfather was a veteran, and also on a 2 year waiting list for a housing unit. Unfortunately, he passed away before he was able to get into his new home.

“It’s really an issue in this area. The rentals in Montgomery are getting too expensive, and people, especially veterans living on a pension just can’t afford it. The key is affordability, and once the town creates the zoning, then we go to the planning board and go from there,” said Mandelbaum.

Developer Jonah Mandelbaum does own property in the Town of Crawford, and he said if and when the town creates the zoning, he’d be happy to apply, since there is such a desperate need for affordable housing.

“The Town of Crawford is considering, and it would be a unit very

similar to the one in Montgomery. Rents ranging from \$300 to \$1000 a month. The plan for the unit in Montgomery

is 73 one bedroom apartments, 6 two bedroom apartments, and 1 three bedroom unit,” explained Mandelbaum.

## Gardiner weighs Community Preservation Plan

Jean McGrane, chair of the Gardiner Open Space Commission, and former Town Board member David Dukler, made a presentation to the board on the proposed Community Preservation Plan (CPP) at the board's May 3 meeting, Dukler is a CPP volunteer.

Work is currently underway to create a CPP for Gardiner with a public hearing expected in June. If the Town Board adopts the plan, a referendum could go before the voters in November with the question of whether or not to establish a Real Estate Transfer Tax.

If the referendum passes, the transfer tax would go into effect in February 2023 with the revenue accumulating in a Community Preservation Fund. The objective of the fund would be to protect farmland, natural areas and historic structures.

The real estate transfer tax is a levy on property sales representing a small percentage of the purchase price to be paid by the buyer. The Town Board will set the percentage and it will not exceed two percent.

Properties that are below the previous year's median sale price for Ulster County (\$320,000) would be exempt from the tax. The tax would apply only to the amount of the sale price above that median.

For example, if a property sold for \$420,000, the tax would apply to the remaining \$100,000. At a rate of two percent, the tax on the sale would be a fee of \$2,000 to be paid at the closing by the buyer. These fees are eligible to be financed as part of closing costs, spreading that cost over 30 years.

The board also voted 5-0 to approve Bruce Terwilliger as the full-time Building Inspector and Code Enforcement Officer at \$39.05 per hour.

## Village of Montgomery approves water rate increase

Village of Montgomery residents can expect to see an increase in their water bills starting in June. Village officials say it's long overdue.

The village board held a public hearing last week to outline the new rates, noting that the water department has run at a deficit in recent year. Rates for users within the village water district will see an increase from \$3.85 per 1000 gallons to \$4.45 per 1000 gallons for consumers of under 50,000 gallons. Consumers who use more than 50,000 gallons will see an increase from \$4.45 to \$5.15 per 1000 gallons

Outside users will see an increase from \$9.62 to \$11.15 per 1000 gallons.

There will also be an increase in connection fees.

"These rates are still very modest, compared to Ulster County," said Mayor Steve Brescia.

## Montgomery renews Spectrum franchise agreement

Following a brief public hearing, the Montgomery Village Board, last week, renewed its cable television franchise agreement with Spectrum Northeast, LLC, an indirect subsidiary of Charter Communications.

Village Attorney Will Frank reminded residents that the franchise agreement is non-exclusive, meaning that if another company (such as Verizon Fios) wanted to come into the village, it would be permitted.

Frank said that with the approval, Spectrum would still need to file for any price increases with the Public Service Commission

## Town still seeking a new seal

Nearly a year after issuing a call for ideas for a new town seal, the Town of Montgomery is ready to look for outside help.

Town Supervisor Brian Maher said that a call for ideas had produced little to no feedback. It was now time to go to plan B.

"We are going to hire a firm," Maher said. "It's been too long a period of time."

Maher said the plan was to adopt a new seal, replacing one that dates back to the 1970s. And would unveil it at a ceremony to rename the town hall building after former Town Supervisor Carl Helstrom. Delaying the re-design also delays the tribute to the former town supervisor.

A new town seal was recommended in the town's recently adopted comprehensive plan.

"The Town is no longer served by rail and wishes to promote economic development beyond freight transportation," the recommendation states. "Survey results indicated a moderate preference to redesign the Town Seal to better reflect the current community."

In addition to a new seal, Maher said the town is also looking to develop "Welcome to Coldenham" signs to mark the entrances of the unincorporated hamlet.



## Morgan Duke Conservation Society adopts Route 52 Walden

Through the New York State Department of Transportation's Adopt-A-Highway Program, Morgan Duke Conservation Society has adopted State Route 52 in Walden from in front of Dollar General to before the intersection at Berea Rd.

Morgan Duke Conservation Society collaborates with many state and national parks across the country and has numerous Volunteer Stewardship Agreements with the New York State Department of Environmental Conservation to protect state lands' environment and natural resources.

James Sullivan, president of the Morgan Duke Conservation Society, said when he was walking up the road past the Wallkill Valley Cemetery after the snow melted this year, he was shocked to see a large amount of trash, including pocket-sized vodka bottles, soda cans rolling into residents' yards, and fast-food bags. Throwing trash from a vehicle is not only unlawful but also harmful to wildlife, as it increases the risk of disease, causes malnutrition in wildlife, and attracts more animals such as deer and bears to the neighborhood.

The Society will announce planned public community clean up events on [morganduke.ngo](http://morganduke.ngo) and on its Facebook page throughout the year. In addition, the Society is looking for a place where volunteers can sign in and park their cars at every event, and if a business would like to partner and donate their parking lot for every clean-up, please email James Sullivan at [Jsullivan@morgandukecs.ngo](mailto:Jsullivan@morgandukecs.ngo). Typically, public cleanup programs will occur on Saturdays or Sundays.

## Seeking forgiveness from Central Hudson

Many of us have seen a sharp increase in utility bills that border on ridiculous. Last week, representatives of various Hudson Valley Community Organizations gathered in Kingston to propose a solution.

“If you are one of the 630,000 single parents in New York, our state’s energy crisis is an inescapable reality,” said Leanna Zilles of the Planned Parenthood of Greater NY Action Fund. “Skyrocketing utility bills are an attack on all of our communities.”

The solution proposed Friday was two-fold: legislation that would make large utilities absorb the cost of debt relief, a call to stop the Central Hudson delivery rate increase, scheduled and approved for this July.

Communities for Local Power (CLP), formerly Citizens for Local power hosted the event. Other organizations represented at the rally included For the Many, Habitat for Humanity of Greater Newburgh, Renewable Newburgh, Planned Parenthood of Greater NY and Ulster Immigrant Defense Network.

It makes sense. The state moratorium preventing New Yorker’s electricity from being shut off due to non-payment expired in December, 2021. More than 48,000 of Central Hudson’s residential customers and 7,000 businesses face power shutoffs. (A Central Hudson representative said in February, that no shutoffs had occurred.)

The utility company is currently under various investigations for their billing, rate hikes, unresolved customer service issues and handling of the winter storm that led to power outages in February 2022. And utility companies throughout the state are under scrutiny for exploitative practices.

Central Hudson has blamed some of the problem on a new computer system that estimates usage. As far as we know, the system is still broken.

Petitioners have urged that shareholders of Central Hudson’s parent company, the highly-profitable Canadian company Fortis be the ones to absorb these high costs. If you agree, you can sign their petition at [communitiesforlocalpower.org](http://communitiesforlocalpower.org).

# Walking up a dirt lane

“Just drop me off here,” I said.

The car pulled off the state road and left me standing on the dirt entrance.

It was mid-afternoon. The air was sweet, the sun in and out, a grey and looming thunderhead to the west. I could make it up the lane just in time to avoid the rain. As I took the mail from the mailbox -- bills, junk, and a postcard to my wife, Doctor Nancy Esquire (her brother, such a joker) – I noticed the tulips had faded and the shriveled petals were on the grass. Time moves so fast. Mother’s Day gone and with it early spring.

Oh gosh, there’s the tire marks in the grass where the uninitiated tried to turn around on the narrow lawn and got stuck, really stuck, tractor-pull stuck, and now they are repaired, and I need to get some grass seed on the brown parallels. People are funny. They just don’t know the ground is soft in the spring. Country knowledge is a vanishing encyclopedia, so worthless as to be given away at yard sales like an uncracked Britannica or Collier’s.

Patches of dark green daises are forming their heads, getting prepared for their June debutante ball.

I like the crunch of the gravel under my feet, and I am entering a wooded area and here on my right is the big Norway spruce my father once planted, full boughs to the ground, a “specimen” tree he would call it, it’s shape so perfect and specific. And around its base, more daises I have not mown and a bluebird house with a tree swallow nest.

To my left is the end water of the Great Beamer Swamp and the edge bushes are now in full, lush

bloom and the first one I come to is the stag bush viburnum with its brilliant round blossoms like hand-carved ivory broaches pinned to an old lady’s white lace blouse.

And in a little bit, a few steps from the lane, hanging like Japanese lanterns are the chokecherry flowers, also a beautiful ivory, delicate and fleeting. How lucky I am to walk this way? To see brief moments of bloom. Can you love life so much you can’t help but be sad?

I am on the stone bridge now. I will take a moment to look at the date stone. 1995. It was a nice project. It’s holding up well. Better than me. The stones, recycled from a doomed eighteenth-century barn, I won’t tell you where. I like that little orange begonia in the purple/blue pot. How long before the deer discover it?

Now on the corner, around the base of a swamp maple, a healthy honeysuckle (invasive?). Flowers galore and yes, my bees will be on it as soon as they wake up. Their flowers are as complex as orchids.

Have walked past the wild crab apple which distinguished itself so brilliantly last week, humbled now without the pink blush. I will make a mental note not to cut it down when doing brush cleanup. It was a nice surprise and was welcoming on the ride into home.

On the edge of the swamp is a rogue Rose of Sharon that came I know not how, and it will burst open in the coming weeks. And in the water, feet wet, a stand of native blue-flag iris planted years ago from the stock of Nano Bienstock, now dead, bless her. More honeysuckles and a pussy willow and a black willow and a struggling spruce tree shaded out by expanding red dogwood, whose bark might be good for fever if I only knew how to prepare it.

I am walking by the tulip tree, planted when my wife started teaching because I think she brought it home in a bucket from school somehow that year, and here it is. She is such a late bloomer, both the tree and my wife, but it has begun to bloom, and as the name implies, the flowers are huge for a

tree, and tulip-like, and a major attraction for the honeybees.

Further, a small patch of good-looking garlic in need of weeding and now a big project, unfinished, I will not mention until it is operational.

The bee yard is now on my left, behind the solar electric bear fence, and the eye cannot help but be drawn to the entrance of the hives, judging the health of the colonies by the action on the landing board. On my right is a gigantic white conglomerate Shawangunk Mountain stone, left as an erratic by the glacier, and on it I have a swarm trap which has drawn in a swarm of bees and this afternoon I will transfer the colony into a regular brood box and in the evening move it to another bee yard. Or, well, one of these days I will.

The thunderstorm dispersed as if it dried out, and I am entering at the wood line now and hearing birdsongs I cannot place, and from further in, in the cool darkness of the woods, I must have been dallying, or been waylaid, or laid down on the grass for nap, because I hear the wood thrush now, and that means late afternoon, almost evening, and all is well in the world if you can hear the thrush on a summer evening and if you can breathe the new oxygen of the ten thousand trees in leaf.

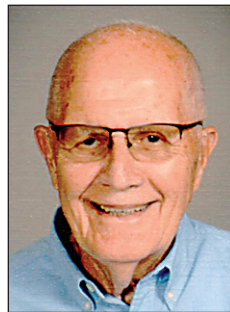

with the district saying she would not be awarded tenure because officials wanted another year to evaluate her performance. Now in her fifth year, she is being asked to resign or she will be terminated with no explanation given or deficiencies in her performance being discussed according to those close to Coleman.

In a phone call with the Wallkill Valley Times, Coleman's sister Kimberly Lopez, also a teacher in the district, shared, "She has always done her job and done it well. This is very upsetting and everyone is just shocked."

Lopez went on to say that her sister has had reviews and evaluations over her 23 years that have all been glowing. "She was basically approached by administrators over the years to move

into these other roles because she did a good job and was efficient. That's why this is so surprising to anyone

who knows her. It is deplorable and outrageous that this district is moving to terminate her. Tammy has three

years left until she can retire. This has caused her great stress and suffering. She has been nothing but an exemplary employee her entire career," said Lopez.

Lopez also started a petition on Change.org to seek signatures of support for her sister.

"This is 100% a wrongful termination! I ask that you sign this petition on behalf of Tammy Coleman so it can be submitted to the Board of Education and they will see how many people support Tammy," Lopez wrote.

As of Monday night, the petition had received 434 signatures.

The Wallkill Valley Times reached out to the Valley Central School District and School Board officials for comment but both declined to discuss personnel matters at this time. The Board is expected to vote on Coleman's fate during the meeting on May 23.

# Martucci to seek re-election in newly-drawn district

Senator Mike Martucci (R,C-New Hampton) Tuesday confirmed that he will be running for re-election in the newly drawn Orange County Senate District. The new district is wholly contained in Orange County and represents the vast majority of the county's population and localities. The map was published by Dr. Jonathan Cervas, a court-appointed Special Master charged with re-drawing New York's state Senate and congressional districts after the Court of Appeals ruled maps drawn by the state Legislature were unconstitutional.

"I am thrilled that the new Orange County Senate District includes my hometown, all of the communities I currently represent, and many that I have gotten to know well over the past several years," said Senator Mike Martucci. "I am well-positioned to continue representing Orange County families in Albany and look forward to earning their support once again."

Martucci seeks to be the first Senator to represent an exclusively Orange County district in the New York State Senate in over 30 years. The proposed senate district includes the cities of Middletown and Port Jervis and the towns of Blooming Grove, Chester, Cornwall, Crawford, Deerpark, Goshen, Greenville, Hamptonburgh, Highlands, Minisink, Monroe, Mount Hope, New Windsor, Palm Tree, Tuxedo, Wallkill, Warwick, Wawayanda and Woodbury.

this home. Something has to give. I'm losing money constantly. It's been four or five months now. Nothing

is getting done."

Supervisor John Valk said it was the first time he had heard there was an issue with the flooding of Jones' residence. Valk said he had visited Pleasant Avenue recently to discuss putting in a street light.

"But nobody mentioned to me about a water problem," Valk said.

Valk said the board would talk to Blazeski about possible remedies to the problem.

Once Jones sat down, Jeanmarie Zawojski took the floor to complain about road conditions on Brimstone Hill Road. She lives at 192 Brimstone Hill Road.

She said Brimstone Hill Road is in desperate need of repair. Zawojski gave the Town Board photos of the road, which she said needed to be repaved.

"There are many spots on Brimstone where it's down to a one-lane road," she said. "The sides are disintegrating. It's starting to look like a road in Ukraine. What I don't understand is how did this road get this bad? Why hasn't this been addressed many years ago. At this point, the whole road needs to be dug up, reshaped and put back to a two-lane road."

Blazeski said he had targeted three roads in the same area, including Brimstone Hill Road, for repair work next year.

Zawojski, who said she had complained to Valk about the road conditions last year, thought it was the Town Board's job to deal with road conditions.

"You're wrong," Councilman Robert Miller said. "The Highway Supervisor is elected by the citizens of the town. He's an elected official. He runs the highway department. The only thing the Town Board does is approve his budget. That's all we do. We have no control over what roads he does."

In other news, the board voted 5-0 to appoint Patricia Williams as the assistant camp director following the recommendation of Recreation Committee chairman and Councilman Adrian DeWitt.

# Bloop hit lifts Bushmen past Newburgh

It wasn't always pretty, but it got the job done.

"He was spotting his fastball well

That was more than Miranowicz needed as he continued cruising.

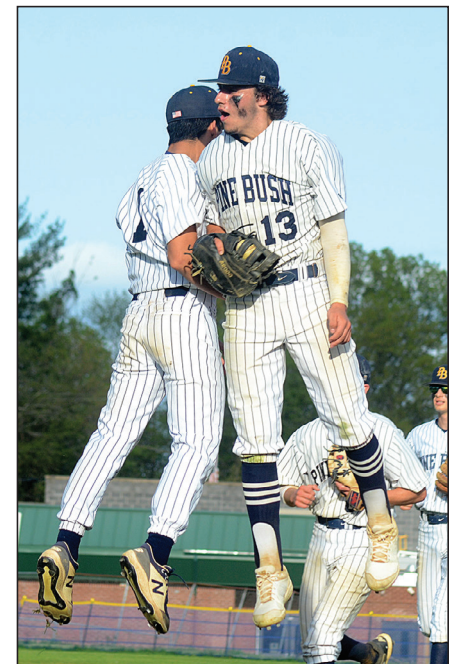
"I was just relaxed," he said. "Their chirping didn't really get to me at all. I was just really relaxed."

The Panthers had won seven straight until they ran into Valley Central's Cam Stevens on Thursday afternoon at Wallkill High School.

Stevens kept the Wallkill bats quiet for most of six innings, took advantage of some Panther misplays in the field and tagged out the tying run between third base and home plate in the bottom of the seventh to escape with a 5-4 victory.

Stevens had been out most of the season with an arm injury and gave the Vikings some length when they needed it going 6+ innings for the win.

"I love being back," Stevens said. "It was fantastic to be back. That's a real good team. But we did really good offensively and defensively."

It didn't help that the Vikings entered the non-league contest out of pitchers, having already played three games this week, losing to Beacon and Newburgh Free Academy on May 9 and 10, before rebounding to beat Middletown, 4-1, on Wednesday.

Thursday's game was the Vikings last game of the week, giving them an opportunity to rest their pitching staff before they were scheduled to take the field against the Monroe-Woodbury Crusaders on Monday.

Stevens and William Treco, who threw the seventh inning for the save, were the only pitchers the Vikings had left.

"Cam was pretty much at his pitch limit and that's why he came out," Valley Central coach Robert Leonard said. "We were out of pitchers for the week. Treco was it and he got the job done."

Stevens had a rough start, walking Bryce DeGroat to start the game and a single by Kyle DeGroat put runners on first and second with nobody out.

However, Bryce DeGroat was hit by a

ball by James Lee that may have been ticketed for left field for a hit. He was out and runners remained on first and second.

"Bryce gets hit with that ball and that would have been 1-0 and we still would have had first and second with no outs," Wallkill coach T.D. Mills said. "So that changed the inning a little bit. But that's not why we lost the game. We lost the game because we didn't make plays in the field defensively and a lot of bad plate approaches."

The Panthers got their 1-0 lead when Hermance singled home Kyle DeGroat, but Brandon Vesely bounced back to Stevens to end the first.

After Stevens walked Spencer Freer to start the second inning, Freer set down the next 10 Wallkill batters before Jacob Quiles singled with one out in the fifth inning.

"He just got ahead in the count and then he was able to mix up his pitches a little and he hit his spots and he's always composed," Leonard said. "He doesn't get rattled easy."

Stevens helped himself by hitting a run scoring single off Wallkill's Bryce

DeGroat, who left the game after two innings due to some back discomfort. James Lee relieved him, pitching a perfect third inning before running into trouble in the fourth.

The Vikings loaded the bases on a single, an error and a bunt base hit over the mound, and took the lead when third baseman Christian Shorey, who replaced DeGroat in the lineup, threw wide to home plate on Treco's ground ball.

Stevens walked with the bases loaded to send home William Quinn and Treco scored on a wild pitch.

That gave Stevens some room to maneuver.

"That gave me a lot of confidence on the mound," Stevens said. "I was more relaxed and able to mix up the ball speeds, focus better. I was more relaxed, overall."

The Vikings tacked on another run in the seventh inning when Sebastian Lockwood singled and scored on an error.

"That's baseball," Mills said. "You don't make the plays and teams are going to take advantage of it regardless

of their record. You've got to make the plays, or it comes back and bites you in the butt."

In the bottom of the seventh, it was the Vikings not making the plays, as the Panthers mounted a comeback. Jacob Maraday, Quiles and Shorey singled to start the inning. Maraday and Quiles came around to score on an error by Valley Central shortstop Keldrin Rodriguez.

Kyle DeGroat came around to score on a fielder's choice to pull the Panthers within one. However, after Hermance reached on an error, Jack Rauschenbach got hung up between third and home plate and was tagged out by Valley Central catcher Colin Quinn to end the game.

The Panthers finished the week on Saturday, finishing a suspended road game against Red Hook. The Panthers were leading 9-1 in the bottom of the second and beat the Red Raiders, 17-1 in five innings.

They edged New Paltz, 2-1, on May 9 and routed Saugerties, 13-0 on May 10 to win the Mid-Hudson Athletic league Division I championship and a spot in Tuesday's MHAL tournament.
