



## Highland FD considers 'Bunk-in' program for recruits

Commissioners of the Highland Fire District, concerned about a potential shortage of first responders in the near future, are considering an

option that's catching on elsewhere: free room and board for college students who join the fire department.

Known as the bunk-in program, it is becoming popular throughout the state.

The program, according to the New York State Conference of Mayors, has been around since the mid-1990s. In Onondaga County, where the local

## Marlborough community center is officially open

In a ceremony marked by the well-wishes of elected state officials, the Town of Marlborough cut the ribbon on its reborn Community Center on Wednesday afternoon, June 12.

Town Supervisor Scott Corcoran noted that the ribbon cutting marked the culmination of a 16-year process, which began when the Town of Marlborough Volunteer Ambulance Corps (TOMVAC) ceased operations in 2008 and donated its headquarters to the town for a dollar. While town leaders initially debated its use, a townwide referendum determined, by a 60 to 40 vote, its future as the Marlborough Community Center.

"A lot of people in our community participated in building this facility,"

The event took place at Marlboro Middle School last week and drew several hundred attendees.

# Highland FD considers 'Bunk-in' program

community college offers an associate degree program in Fire Protection Technology, students are eligible to apply for internships as bunk-ins with local host fire departments.

Being a bunk-in provides a unique community-service opportunity to serve as a volunteer firefighter. In return, the fire department provides living accommodations. Bunk-ins live at the firehouse, attend classes and respond to emergency calls with the host fire department. The fire department gains volunteers who are active and involved and can be available at times when other volunteers cannot, such as daytime and heavy commuting hours. The man hours they provide are invaluable to volunteer organizations. This program affords the students real-time application of the things that they are learning in the classroom. They handle the equipment, maintain apparatus, interact with the community, work as a team with department members, follow the rules and regulations, and respond to calls.

But critics say the program moves the volunteer fire department one step closer to a paid service, and that has some residents concerned. An unveiling of the program was met with a mix of support and criticism from Highland residents, last week at the Tuesday night fire district meeting in Highland.

Kevin Rizzo, a member of the Bunk-In committee and a commissioner for the fire district, gave the presentation detailing the program, answering some questions and providing an overview for those attending the meeting. As a committee, now made up of five people, they traveled to four departments in western New York with bunk-in programs — Solvay Fire, Myers Corners, Elsmere and Fayetteville. The trip allowed them to decide what aspects of their arrangements they believed would work for their own department, as well as what they thought would not fit their needs.

"You're increasing our service, the service that we provide to the community," Rizzo said. "It is just one

tier of a multi-approached attack to recruit members, to retain members, to attract new members and to keep the volunteer fire service alive."

The Highland department is increasingly getting older, Rizzo said. Most of their members are in the 30-40 age range, but inactive members fall primarily between 21 and 39. He said that this means that although their department is healthy now, it could be in trouble in the future, pushing forth their need to expand recruitment and retention programs.

Each of the four departments they visited had different programs — the only similarity between them all was that they had a specific place for the bunk-in to lodge. Solvay Fire and Myers Corners provided more of a base model for Highland, with Rizzo adding that their version of the bunk-in program would be highly structured.

Hailing it as a "symbiotic relationship between the fire district and student," Rizzo emphasized that the program would provide local college students with a place to stay in exchange for their services to the fire district. They would commute between the district and their college.

"A bunk-in program is just one of many ways to diversify participation," Rizzo said.

Investments should be minimal after the initial payments for the necessary renovations, Rizzo added. They would have to discuss the cost for living renovations and convert the work-out space into a bunk room. A refrigerator, washing machine and dryer would also have to be installed for those living there.

Chairman Steve DiLorenzo said that due to the program's innovative quality, he cannot be certain as to what its impact would be just yet. There would be some modifications made, as the idea is still not fully fleshed out.

"Obviously it is something very brand new," DiLorenzo said. "It is brand new to our county and our whole area. There are no other bunk-in programs around that we are aware of. It is promising if it all comes together."

Many members of the local community expressed their displeasure with the potential program, for a few different reasons, including what they view as a lack of alternative efforts to promote recruitment that do not require money to be invested into a completely new program.

Town of Lloyd councilman John Fraino questioned how much time it would take for new recruits to actually become active members, especially if they do not have any prior training. The consensus was that it would take a few months if a recruit was joining without any experience.

Robert L. Pardy, a past commissioner for the department, also emphasized a lack of transparency between the fire district and the community, as well as insufficient diversity overall in the department, saying that they do not have any minority representation among members and only one female.

"These guys are in crisis, and I give them credit, at least they understand they are in crisis," Pardy said. "But they are in crisis because of the culture they have here."

said Corcoran. “Without them it wouldn’t have happened. Our town Highway Department probably saved you, the taxpayers, \$300,000 to \$500,000 through the work they did. They do it because they love our community. Give these guys a round of applause.”

State Assemblyman Jonathan Jacobson pointed out that in addition to being the result of funding from a variety of government sources, the project represented the power of bipartisan cooperation. “You had two different administrations [in Marlborough] – a Democrat and a Republican,” said Jacobson, who presented Corcoran with a state Certificate of Merit to mark the occasion. “But it didn’t make any difference. They got the job done. That shows what kind of town Marlborough is. This is a great occasion. I’m looking forward to coming to a lot of events here, and I am sure it’s going to get a lot of use.”

“You can tell that this building was put together with love, so to everyone who had a hand in it, every family member of everyone who had a hand in it, thank you,” said State Senator Michelle Hinchey, who also presented Corcoran with a certificate to mark the occasion. “Every community needs a central hub where people can come together – for the seniors’ groups, the Boy Scouts troops, whatever it might be, this is what makes our small towns so special. Seeing everyone come together over the many years to get this done is a really inspiring, beautiful thing. Thank you for your commitment to your work, to your town, and to your neighbors.”

Ulster County Executive Jen Metzger was unable to attend the ribbon cutting and was represented by her Chief of Staff, Johanna Contreras. “I want to congratulate you all for a job well done,” said Contreras. “It really is a beautiful Community Center and I understand it’s been a long time coming. I look forward to being part of many events here in the future. I understand it’s going to be the hub of the senior citizens group: We’ve spoken

to our director of aging, and we really hope to be able to bring some events here for you all. So, thank you and congratulations.”

Quite a few of the attendees at the ceremony were residents who had fond memories of the building’s service to the town’s ambulance corps during the 40 years it was in existence. In fact, both residents and elected officials often, by habit, refer to the structure as the “TOMVAC building,” employing a long-used acronym for Town of Marlborough Volunteer Ambulance Corps.

Local accountant Ralph Walters helped to launch the organization in 1968, when he first returned home after college. “Milo Hepworth [a local farmer and landowner] had left the town \$4,000 on the condition that it start a volunteer ambulance company,” Walters recalled. “We then formed a large enough group to form the corps. I went on my first ambulance call in 1969.”

“Our first ambulance was parked in the driveway of my parents, Thomas and Bernadette Polizzi,” recalled Mici Simonofsky, a former Town Board member who now chairs the town’s Conservation Advisory Committee

(CAC). “I was on the Town Board when we had to make the difficult decision on what to do with the Volunteer Ambulance Corps and the TOMVAC building.”

Simonofsky pointed out that the numbers of volunteers had dwindled in the later years, particularly during nights and weekends when it received most of its calls. As a result, the town began hiring paid ambulance services to fill in the gaps in coverage. There were also changes in insurance mandates and certification requirements that made it difficult for the organization to remain in operation.

Once TOMVAC was disbanded, both Simonofsky and Walters were active in the petition drive to get a referendum on the local ballot, in which Marlborough

voters favored turning the TOMVAC building into the town’s Community Center.

“The people of Marlborough decided to keep the building because it had good bones,” noted former Town Supervisor Al Lanzetta. Scott’s done a wonderful job – this place looks beautiful!”

## How to Rent a Room

The Community Center has two large meeting rooms – a North Room and a South Room. The first is 3,250 square feet in size, has an adjacent kitchen, and has the capacity for 215 people seated at tables (or 400 people in just chairs). The South Room seats 155 people at tables, or 280 people in just chairs. The kitchen is available only for those who use the North Room; the South Room is equipped with a dry bar.

The resident rate for rentals is \$650 for either room. Both smoking and alcohol consumption are prohibited. Both rooms are ADA (Americans with Disabilities Act) accessible, and audiovisual hookups are available in both rooms. The exterior can be used for recreational activities such as cornhole and frisbee. Go to the Town website or contact (845) 332-4270 for more details.

### Man faces drug charges after collision with police car

On June 11, at approximately 12:14 p.m., members of the Troop F Community Stabilization Unit (CSU) attempted to stop a 2017 Honda Civic traveling south on Route 9W in the town of Lloyd. The operator of the vehicle, later identified as Christopher Melvin, age 33, from Poughkeepsie, failed to stop. Troopers pursued the vehicle for approximately 13 miles before the pursuit was terminated by State Police.

The vehicle collided with a Town of Marlborough Police vehicle on 9W in the town of Newburgh, causing the Civic to become inoperable. Melvin opened the door of the vehicle to flee on foot. In doing so he damaged a Town of Newburgh Police vehicle. He was taken into custody after a short foot pursuit. Melvin was found to be in possession of fentanyl, amphetamines, and crack-cocaine.

### Former Wallkill firefighter sentenced for arson crime

Robert Cromie, 56, of Wallkill, was sentenced in Ulster County Court to 1.25 to five years in State Prison by County Court Judge James Farrell. Cromie was convicted of Arson in the Third Degree, a Class C Felony, on March 7, 2024. Cromie was a member of the Wallkill Fire Department at the time he committed the crime.

Cromie intentionally started a fire on December 7, 2021 inside a garage attached to his apartment located at 18 Bona Venture Avenue in the Town of Shawangunk. The ensuing fire consumed the entire apartment. Although no one was injured, the defendant ended up carrying his wife, who was sleeping at the time, out of the apartment after starting the fire.

The case was investigated by the Ulster County Sheriff's Office with the assistance of the Ulster County Department of Emergency Services. "I want to stress that arson is treated as a serious crime, especially when committed by firefighters who are entrusted with protecting our community. It's unacceptable to put our public and those that protect our public at risk through such reckless acts," said Ulster County Director of Emergency Services Everett Erichsen. "I commend the District Attorney's Office for taking this case seriously, sending a clear message that such actions will face consequences. Furthermore, I applaud the collaborative efforts of our County Fire Investigation Unit and the Ulster County Sheriff's Office for their dedicated work in investigating this case. Their partnership underscores our commitment to ensuring public safety and holding perpetrators accountable."

"Arson is a grave offense, particularly when perpetrated by firefighters entrusted with safeguarding our community. It is intolerable to endanger both the public and those sworn to protect them through such reckless acts," emphasized Sheriff Juan Figueroa. "I commend the

District Attorney's Office for its earnest pursuit of justice in this matter, sending a resolute message that such crime will be met with consequences. Additionally, I extend my appreciation to the collaborative endeavors of our County Fire

Investigation Unit and the Ulster County Sheriff's Office for their unwavering commitment investigating crimes of this nature. Their coordinated efforts underscore our dedication to upholding public safety and ensuring that wrongdoers are held accountable."

"Our public officials who are duty-bound to protect the public from emergencies including fire, like this defendant, must be held accountable when they betray the trust of the community, in addition to facing the consequences of their criminal acts," said Ulster County District Attorney Emmanuel C. Nneji. "I commend the collaborative effort undertaken by our law enforcement and first responders to support a successful prosecution in this case, and hope public officials are on notice that they must be held to the highest standard."

This case was prosecuted by General Felonies Bureau Chief Robert Knapp. Robert Cromie was represented by the Ulster County Public Defender's Office.

# Pascale chosen as Republican candidate for Marlborough Town Justice

vacated by Dan Jackson is the only open position in the town thus far and was the only one for which the Republican caucus held a nominating vote. However, in addition to remarks from candidates Pascale and Kraiza, attendees heard from Allison Esposito, who is running on the Republican ticket to represent New York's 18th congressional district in the U.S. House of Representatives. That seat is currently held by Congressman Pat Ryan, the Gardiner Democrat elected in 2022.

Pascale is a lifelong Marlboro resident and has been a registered Republican since age 18. His grandmother, Daisy Pascale, was the Town of Marlborough's first female police officer. In addition, Pascale's father, Michael, previously served as a Town Justice as well.

Pascale's service to the town began in 1997, when he joined the town's Volunteer Ambulance Corps. Shortly thereafter, he was hired as a dispatcher for the Marlborough Police. He later rose through the ranks to become a police sergeant and also served with the Ulster County Crisis Intervention Team. He retired from fulltime service with the Marlborough Police in February, 2023 and has served as a part-time school resource officer (SRO) since that time.

Candidates for Town Justice aren't obligated to secure political endorsements. At the Republican caucus meeting, Pascale noted that his own beliefs and values align with the Republican Party. Nonetheless, earlier this year Pascale sought a cross-party endorsement from the Democratic Party for his bid to become the Town Justice. He later circulated a petition and garnered more than the target number of signatories required to secure the Democratic line.

"A judge should be concerned with the facts of the matter, not political affiliations," said Pascale, "in the same fashion that baseball umpires should not be concerned with the views nor the opinions of the players but should call balls and strikes as they see them..."

The town justice represents everyone in this town despite party affiliation or race, creed, gender, and beliefs – hence, the notion that justice is blind."

Pascale said that serving the town for almost three decades has given him a good sense of the pulse of the community. He also said he takes pride in aiming to solve problems, to engage with everyone, and to strike compromises whenever possible.

"I'm guided by integrity good principles, fairness and common sense," said Pascale. "My goal is to be firm, fair and empathetic."

Esposito announced her bid to challenge Ryan for the 18th district congressional seat last October, and this winter earned the endorsements of the Republican committees for Dutchess, Orange, and Ulster Counties. The district encompasses all of Orange, and most of Dutchess and Ulster.

Esposito is a native of Monroe and a 25-year veteran of the New York City Police Department. She said her work and that of her fellow officers had become increasingly dangerous, leading many to fear job loss just for doing the job society demanded of them.

"The world we knew had turned upside down," Esposito recalled. "We were told that everything we know to be good is actually bad is not only good but somehow virtuous... I took a look at the seat I was sitting in and the hat I was wearing and I realized I had to do more to effect the change that New York so desperately needs."

She first ran as then-Congressman Lee Zeldin's running mate in the 2022 gubernatorial campaign. While the pair lost that election, it was close, Esposito pointed out – and Ryan's margin of victory was slim. That puts the 18th district into play, she said.

Esposito strongly emphasized her law-enforcement background in her remarks. She recalled an incident when while on patrol she was hit with a kitchen cabinet that had been tossed off a rooftop, and another where she had to take scissors to a colleague's pants leg – which was burning because of an incendiary device that had been thrown at him.

Esposito urged everyone to vote in November. "Voting is not a right," she proclaimed. "It is a responsibility and an obligation."

# Lloyd Civilian Police Academy returns

After a five-year hiatus, in part due to the Covid 19 pandemic, the Town of Lloyd Police Department is again sponsoring a Civilian Police Academy, which is being held on Wednesday evenings from 6 to 9 p.m. at the Highland Fire House and will run through July 3.

The academy gives residents an insight into what the police force does and how they approach their jobs. The six-week course covers a wide variety of topics in depth: a history of the Lloyd Police department; a tour of the police station and their equipment;

community policies and traffic stops; Reality Based Training [RBT] scenarios; Presentation of a Mock DWI Accident; Bail Reform/Discovery and Court Protocols and Domestic Violence; Civilian Response to Active Shooter incidents with an emphasis on how to help protect oneself and how to assist Law Enforcement; and a graduation at the end of the program.

Police Chief James Janso said, “the goal of the Academy is to show our community what police do by giving them a first-hand experience of our station, our equipment, why we do certain things on car stops, why we carry equipment and what the purpose

is.”

Janso said the Academy means to “pull back the curtain” on Law Enforcement.

“They get to see who we are and they take away from it a whole new perspective on Law Enforcement and it shows honestly that we are people first and they understand who we are and what our job entails,” he said.

Janso said each week there are new class activities that are, “eye opening for people because they get to actually see and be like a police officer. They walk away with a little more respect and understanding of our job and that’s our goal. I want the community to

know who we are and what we do.”

Janso said they will show the participants a few “live” scenarios where an officer, “in a split second must make a decision on what we see, what we perceive and how we are going to react to an issue, where months or weeks later they can be challenged by judges, lawyers or people where it’s not that easy to be a Monday night quarterback if they’re watching or doing what we do to still see it.”

Janso said people were “amazed” when New York State came to review their departments policies.

“We in our department were exceptional; we were ahead of a

lot of agencies in our training, our equipment and it reiterated that we are a good police department," he said. "We're always looking forward, you have to, and need to know the laws, the equipment and the technologies that are always changing and you have to progress with it; you have to keep up, you can't catch up."

Chief Janso said the Academy is a good experience for those in attendance as well as for his department, "to interact with the students and for them to interact with us and the best part is the question and answer periods and it is well worth the time we put into it."

## What comes after the congestion pricing reversal?

**G**ov. Kathy Hochul's abrupt reversal of New York City's congestion pricing plan has sent ripple effects throughout the region and the state and raised eyebrows among the students of mass transit in other cities across the country.

While the plan itself had come under fire, especially from upstate commuters, the move to abandon a plan that was decades in the making jolted lawmakers, real estate leaders, transit advocates and other stakeholders. Instead, the Governor announced an indefinite pause on congestion pricing on cars entering Manhattan below and including 60th Street.

The plan was approved in March. The decision to pause was announced just weeks before the plan was expected to go into effect, and all of the tolling equipment was already in place.

The governor said she was reluctant to deter people from driving to New York City when its economic recovery was still fragile. Her critics suggested it an election year ploy to help Democrats in suburban districts where congestion pricing is notably unpopular.

The Metropolitan Transportation Authority, tasked with raising revenue and relieving potential gridlock, now finds itself without the \$15 billion earmarked as funding from the congestion pricing program. It had plans to use that revenue for assorted capital projects, some of which had been years in the planning. Help from Albany is not on the way, however, since the legislature has recessed for the summer.

The City of Newburgh paid for airfare, accommodations and expenses for multiple city staffers to attend the conference and receive a practically empty award, all for the self-preservation of the ego of our city manager.

So, let me get this straight: The city recently spent more than \$37K to send executive staff and Council members to an off-site retreat – yet another boondoggle for which the public has yet to see any download or debrief. We have no indication that our so-called leaders learned anything at all during their expensive weekend getaway. And now, we're spending even more money to send crucial members of our executive staff to pick up an award. While Todd is partying, Newburgh is paralyzed.

At the time of this writing (Friday, June 14), four days have passed since the initial cyberattack and we know virtually nothing. No extensive details have been released by the city, which makes an ironic mockery of the "transparency" award that Todd was picking up in Orlando while this happened. Orange County and Executive Steve Neuhaus have been more transparent about this incident than the City of Newburgh!

That's the most frustrating part of this whole incident. While cyberattacks happen with unfortunate regularity, Newburgh City Hall's abject lack of communication and transparency with the public is

appalling. Having more insight into what's happening would go miles towards securing residents' trust in city operations.

Seems Todd Venning was too busy jet-setting to get this memo – which is unfortunate, because despite the performative, vacuous gesture of accepting an award that recognizes transparency, our City Manager has led an unprecedented lockdown of civic discourse and information-sharing.

The time is now! This city needs an enema. Let's flush out City Hall – starting at the top. We need a fresh start. Clear out the executive office, remove the egomaniac of a mayor as well as the completely useless and feckless City Council. This catastrophic failure of leadership should be a catalyst to major change: Newburgh residents need to unite and demand reforms that will create lasting change once and for all.

# The cutting of the scapes

If you follow garlic groups on the internet as I do, you will see a string of growers posting photos of their harvested scapes as summer moves north, their location getting closer and closer to home, to here. And then, suddenly, it is time for us to cut our scapes.

Not all garlic grows scapes. The scape of a garlic plant is the extension of the stem which, if left uncut, “escapes” to develop a pod of clones on the end of it, on the tip, a little white sac filled with miniature garlic bulbs. Not all garlic grows scapes, only the “hardneck” varieties; and the hardneck grow better in the north, in the cold climes, where we live right here in the Hudson Valley. The soft-necks don’t grow scapes and are better suited for southern, hotter winters, and farmers with the accents of Gomer Pyle and with the Virginia Battle Flag on the sides of their reconstituted tobacco barns, open slats on the sides, rusted FORD by a whiskey rain barrel.

Back in my Fordham days, when I walked across Fordham Road to Arthur Avenue, to the Little Italy of the Bronx, over there with the Italian restaurants and Italian Delis where I would get an Italian sub for my daily bread, passing the old men playing dominoes on wooden card tables on the stone sidewalk, I would run into some of the younger Italian boys from the hood, and they loved to wear a gold garlic scape piece of jewelry around their bare necks, and you could see this icon down below Greenwich Village too, on Mott Street, and it is odd because most Italian garlic does not have a scape. But if you research it, which, of course, I had to do, you will find that the garlic from the

Abruzzo Region of Italy (that section of Italy east of Rome in the Apennine Mountains down to the Adriatic coastline) is famous for its red garlic and this garlic does have a scape, so wearing a scape around the neck might be more of a statement of hometown male Italian regionalism than anything I could have imagined as an upstate farmer boy without clan connections, or gang affiliation. I mean, who knew? Did they know?

It is strongly advised to cut the scapes or pull them (they slip right out of the stem if conditions are right), as this allows much more energy to go to the garlic bulb underground which does not mature, or size up, until the end of the growing cycle. So, even if the scapes are not going to be used, they should be cut off and thrown on the ground, or into a corner of the field where they will continue to develop even without the mother plant, as long as they are not in direct sunlight which would dry them out.

We use our scapes for many things. They are great just as they are, rolled in olive oil and grilled right next to the burgers and franks. They can be stir-fried with beef cubes or chopped right on top of a steak in the frying pan. We like to make a garlic scape pesto of the younger ones, mixing them with olive oil, parmesan cheese, pine nuts and a dash of salt. The pesto can be frozen and gives you that taste of summer all winter long.

Some farmers with dehydrators dry out the garlic scapes, crush them, grind them, dry them some more and mix them with pink Himalayan salt to concoct a garlic salt which sells very well at farmers’ markets.

Another favorite of ours is to use the scapes to make a special pickle – pickled garlic scapes, very peppery and crisp and delicious, very low in calories for an all-night munch snack. The scapes are washed and sorted and put tightly into Bell jars and then salt and a pickling mixture is added and the jars are cooked in a canner for 15 minutes to give the scapes the perfect texture and snappy tenderness.

It is an important task to get the scapes off. This year that task has been accomplished. Many steps to growing garlic remain. There are four more steps to go: pulling the garlic from the ground at the most opportune time; hanging the garlic in the shed with fans to cure the garlic; cleaning, sorting, weighing and bagging and labeling the garlic; finally, the selling of the garlic.

On that last point, we have the first garlic on the stand today, green, uncured but juicy and bright. Also, I am registered in three garlic festivals—first the Bennington, Vermont Festival; then, the Hudson Valley Garlic Festival, formerly known as the Saugerties Garlic Festival (just about the oldest garlic festival in the country); and, finally, the Bethlehem Connecticut Garlic Festival in October. Wish me luck. See you at the stand. Gosh, what a beautiful day today.

Get your scape on!

The pause has prompted some upstate lawmakers to call for an audit of MTA finances. State Senator Rob Rolison (R-Poughkeepsie) co-sponsors S.4190, legislation which would require a public accounting firm to report its findings on or before January 2026.

“The congestion tax was a mistake. Let’s not double down on that error by handing the MTA a blank check,” said Rolison. “We can provide modern public transit – a government function I support – while offering commuters and taxpayers assurances that their money is being wisely spent.”

It’s a valid point. For all we know, congestion pricing in some form or another could re-appear after Election Day. Before it does, we may want to come up with a stronger accounting of just how much the MTA needs, and how it can raise funds in a way that’s fair to the rest of us.



# Hospice of Orange and Sullivan honors local veterans

#### 7. Do *The Christians Servants of Jehovah* have publications?

# Great American Race returning to Montgomery

The Hemmings Motor News Great Race, a national automobile rally over 40 years old, will make its second-ever pit stop in the Village of Montgomery next Thursday, June 27 at 11:30 a.m. on Clinton Street, where residents can marvel at 120 vehicles spanning several decades and meet their drivers.

The Great Race, started in 1983 by Tom McRae and Norman Miller, is a nine-day, 2,300-mile trek in which dozens of drivers from across the globe will cruise through a long stretch of states. This year, contestants will begin in Owensboro, Kentucky, and pass by 19 cities along the Eastern United States until they reach Gardiner, Maine. Judges will score drivers based on how well they keep pace between checkpoints and will penalize them if they reach a checkpoint too early or late. The team with the lowest score will win \$50,000 from a \$160,000 purse, and the remaining \$110,000 will be divided across other teams, based on various criteria.

The event is known for showcasing antique cars, the oldest ones dating back to 1912. This year's race will feature a 1912 Haynes, a 1913 Chevrolet, and a 1916 Hudson.

Previously, the Village of Montgomery hosted a stop during the 2022 Great Race, impressing Hemmings Motor News so much that the company offered the community another opportunity to host this year. Considering that each Great Race features a different course from the last, drivers will rarely visit the same stops between years, making the village an exceptional case.

"The Great Race rarely travels back to a city stop, and when it does it's usually been 10 years or more," said Jeff Stumb, director of the event. "Once we knew we'd be taking the race through southeast New York we immediately called the Village of Montgomery to see if we could come back for a second time in three years because of the fantastic job they did in 2022."

Once the contestants reach Clinton Street, they will take a break, enjoy lunch, and engage with residents for several hours. The event will be free and everyone is encouraged to visit and say hi to the racers; children may also have the chance to hop into the cars and check them out in the front seat.

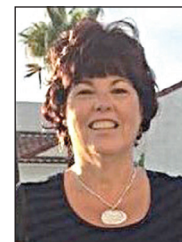

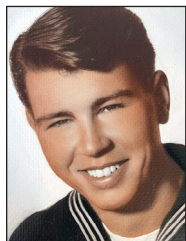

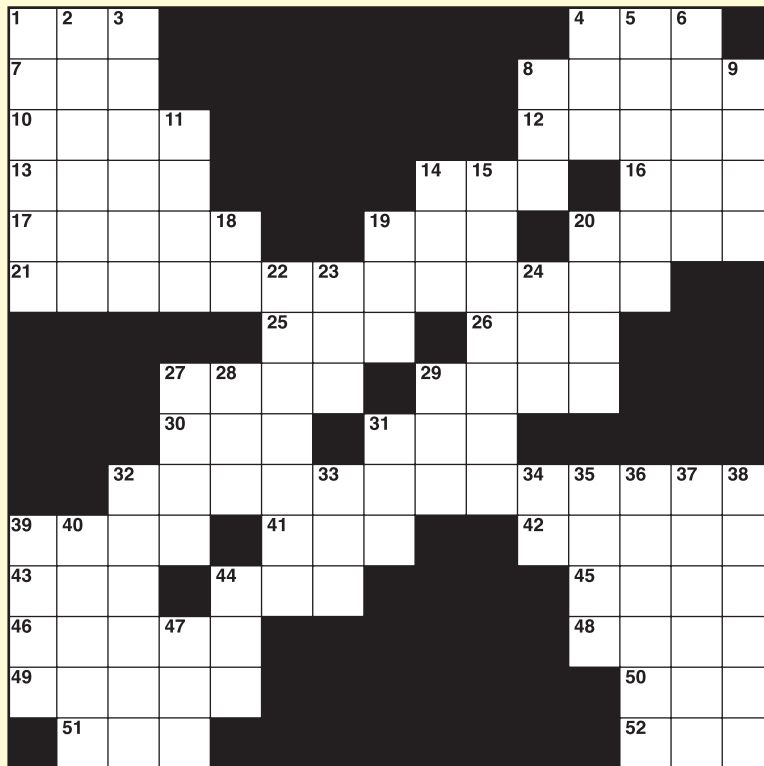

WHEREAS, to date New York City (hereinafter the "City") has transported 186 homeless persons to Orange County (hereinafter the "County") and has caused two hotels/motels within the County to be converted into illegal homeless shelters; and

WHEREAS, the City has previously represented that it will only pay for such shelter up to a limited date and has no long-term solution for housing their homeless within the County, which is in violation of New York State Social Services Law and related Administrative Orders pertaining thereto; and

WHEREAS, the City has repeatedly failed and refused to adequately address the needs of the homeless population in New York City, and has decided by its actions and inactions to abdicate its duty and responsibility to those homeless persons, necessarily transferring said duties and responsibilities to the County of Orange

County Government, in violation of state law; and

WHEREAS, on May 9, 2023, the State of New York declared a state of emergency as to New York City's homeless population and its inability to adequately house and provide for such persons; and

WHEREAS, there is no reason to believe that the homeless persons presently here will leave Orange County after the City ceases to pay for the short-term housing and any services they are presently receiving; and

WHEREAS, local zoning codes do not allow use of temporary residence hotels or other temporary residence facilities for use as long term residential housing and therefore the City's transportation of homeless persons to the County for that purpose is illegal; and

WHEREAS, through enforcement of local zoning codes, said homeless persons will face refusal, or eviction from the illegal hotels and short-term residential facilities, resulting in an imminent large-scale housing crisis in the County; and

WHEREAS, as all temporary housing shelter beds in Orange County are currently at maximum capacity and cannot accommodate additional homeless individuals; and

WHEREAS, there is a reasonable apprehension of immediate danger of public emergency of potentially thousands of persons being transported to Orange County in violation of state law as referred above, resulting in Orange County being

responsible for the public safety of these persons and all others affected in Orange County; and

WHEREAS, the County is not capable of receiving and sustaining such volume of homeless persons that the City has, intends to, or hereafter does transport to the County, whose presence will gravely increase the number of people in need of government services across various sectors in the County; and

WHEREAS, the locations to which New York City Mayor Adams has previously transported said homeless persons have inadequate infrastructure to meet the needs of said individuals, including but not limited to transportation to work, food, medical care, and pharmaceutical opportunities; and

WHEREAS, the County anticipates potential civil disobedience and protesting on this issue both for and against the transportation of homeless persons to Orange County; and

WHEREAS, that due to the above circumstances, I find reasonable apprehension of immediate danger thereof that public safety is imperiled thereby, for not only the New York City homeless persons illegally transported to Orange County by New York City, but also to the other affected residents of Orange County; and

WHEREAS, all of the underlying conditions and reasoning for issuing the Emergency Declarations on June 7, 2023, July 6, 2023, August 5, 2023, September 4, 2023, October 3, 2023, November 2, 2023,

December 1, 2023, December 31, 2023, January 30, 2024, February 29, 2024, March 30, 2024 and April 29, 2024 which Emergency Declarations and Executive Order No. 3 of 2023, No. 4 of 2023, No. 8 of 2023, No. 9 of 2023, No. 10 of 2023, No. 12 of 2023, No. 14 of 2023, No. 16 of 2023, No. 1 of 2024, No. 2 of 2024, No. 3 of 2024 and No. 5 of 2024 are incorporated herein by reference, remain as imminent threats to the County of Orange and the reissuance of an Emergency Declaration is necessary in order to protect life and property.

NOW, THEREFORE, I hereby declare, in order to protect life and property, or to bring the emergency situation under control, a State of Emergency in the County of Orange and make the following ORDER:

I Order that all hotels, motels and/or any facilities allowing short term rentals do not accept individuals transported to Orange County in violation of Social Services Law § 62 and related Administrative Directives of the New York State Office of Temporary and Disability Assistance, including, but not limited to, 06-ADM-07.

This proclamation/declaration and the orders in relation thereto are pursuant to my powers contained within the Orange County Charter (Section 3.02-q) and Administrative Code (Section 3-2-q) and Section 24 of the Executive Law of the State of New York.

I FURTHER FIND that this State of Emergency does not in any way impact travel or County employees or County operations, is not weather related, and does not suspend County operations. This Executive Order and all portions thereof shall take effect immediately, be filed and published as required by law, and individually expire as required by law.

# Safe Harbors plans a 'Pride on the Green' celebration

In honor of Pride Month, the Safe Harbors green will turn rainbow on June 23 as Safe Harbors of the Hudson hosts its first annual Pride on the Green celebration.

To begin the day's festivities, there will be a sidewalk procession starting at 11:30 a.m. from the Newburgh Brewing Company to Safe Harbors Green. Live music performances, DJs and dancing will then take place on the Safe Harbors Green from 12-6 p.m. The festival is designed to be inclusive for all people wishing to partake in the day's fun and entertainment, catering to local families and children as well.

"We are packing it with lots of vendors and sponsors," said Ken Martinez, the director of performing arts and community programming for Safe Harbors. "You will be able to do anything from get gelato to make a doctor's appointment. So it is going to be a very interesting event with lots to do."

Martinez said he hopes next year they will be able to have a parade through the streets, adding that they tried to focus greatly on selecting local talent and LGBTQ+ performers. The main stage performances, which will go from 12-2 p.m. are going to be hosted by Victoria Bohmore and include music from DJ Pete Pop, also spotlighting other artists like Juliza Alezae, Katarina Mirage and Memphis Divine.

The day's itinerary will also include a Drag Story Hour — a nonprofit fostering inclusive spaces where storytellers read books to kids through the art of drag. At 1 p.m. there will be readings with Angel Elektra & Shay D'Pines for all kids. According to their website, Drag Story Hour provides children

with queer role models to look up to and creates an environment for them to imagine a world that tears down the traditionally accepted gender binary.

From 4 - 6 p.m. there will be a dance party with DJ Meetchka, and after 6 p.m. until late into the night, an after party will be held at Spirits Lab featuring musical hits from the 80s and 90s. Although Martinez said there have been pride events in Newburgh before, this is the first of this event hosted by Safe Harbors specifically.

Pride Month first began in 1994, originally designated to the month of October by a group of educational organizations based in the United States. It was initially federally recognized by President Bill Clinton in 1999 as Gay and Lesbian Pride Month. A decade later, in 2009 President Barack Obama declared June LGBT Pride Month and in 2021, President Joe Biden altered the official title to LGBTQ Pride

Month. Throughout the month, pride celebrations and other pride-centered events are taking place not just throughout the Hudson Valley, but across the state and the country.

Events like these are what make places desirable for people to live, Martinez said. Pride gatherings have the ability to incite engagement within the community, as they draw a diverse crowd from different groups and socio-economic backgrounds.

Pride on the Green's sponsors and partners include the City of Newburgh, Chronogram, Friends of the Newburgh Free Library, Planned Parenthood, Newburgh Illuminated, Ally Realty, RicRac by Hendley & Co and Newburgh Brewing Company.

"It has been quite an experience to put this together and realize this is actually the beginning of a very long, amazing event," Martinez said.

# The Water Level Route

How trains once crossed the Hudson by ferry from Newburgh to Fishkill Landing



Following its completion in 1889, the Poughkeepsie Railway Bridge was a crucial link between New England and the United States' elaborate railroad network. It continued as such for over eighty years until its fiery demise in 1974, but prior to trains traveling by rail, a vastly different method of transportation was used to cross the Hudson River.

Join author and historian Alex Prizgintas at the Marlboro Free Library on Thursday, June 20th at 7 p.m. as he explores the early history of the Erie and West Shore railroads in Newburgh, as well as the service of the William T. Hart—a steam-powered barge that transported railroad cars from the late nineteenth century until the turn of the twentieth century from Newburgh to Fishkill Landing en route to New England.

A Marist College graduate with degrees

in Hudson River Valley Studies and Public Administration, Alex Prizgintas has been published in several journals such as the peer-reviewed Hudson River Valley Review and New York Archives Magazine as well as the Orange County Historical Society Journal and the Antique Bottle & Glass Collector Magazine. Serving as president of the Woodbury Historical Society in Orange County, Alex performs and lectures around 130 times each year across the Hudson Valley.

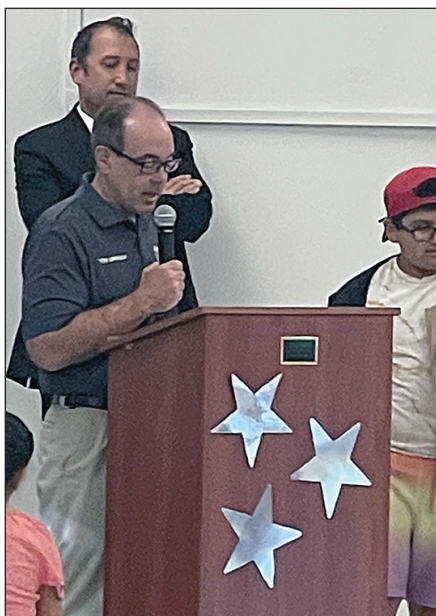

She's already had some college interest as one of the coaches from the University of West Virginia came and watched practice to express interest.

She's also been in contact with Penn State, North Carolina State, the University of Illinois, Yale, and Washington University, among others.

She knows exactly what she's looking for.

"The culture of the program is a very important thing," Ryan said. "If I'm going to go away and perform for the college, I want to enjoy the coaches and enjoy the girls, so that's a very important factor."

Even with nationals behind her, she trains five days per week at ENA Gymnastics in Paramus, N.J., for about 20 hours per week. That doesn't include the 10 hours per week she spends in the car driving between Paramus and Highland.

"This sport has taught me a lot of things," Ryan said. "I think that's why I enjoy it so much, not because of the fact that I get to go and do flips and

## Highland's Lizzy Ryan 24th at gymnastics championship

Lizzy Ryan, or at the very least her hands, had a terrible gymnastics season.

It didn't affect her performance, however, as she finished 24th at the Level 10 Senior A Women's Development Program National championships on May 11 and 12 at the Volusia County Ocean Center in Daytona Beach, Fla.

"I had ripped my hands open numerous times," said Ryan, a junior at Highland High School. "So, I was only able to do, instead of the 50-bar routines that everybody else did going into nationals, I probably only did 15. My coach says they were like hamburger meat. That was very painful."

Her highest score came on the balance beam where she tied for 18th with a score of 9.450. Her second highest finish came on the uneven bars, which despite her injured hands, she scored a 9.4.

"They weren't tiny rips that I was just being a baby about," Ryan said. "They were bloody to the point where my blood was on the bar. If they used a UV light, they would definitely find my blood all over."

She had a higher score on the floor with a 9.425, but she finished tied for 29th there and was tied for 39th on the vault with a score of 9.325. She finished with an all-around score of 37.600.

Ryan is a Level 10 gymnast, the highest level in the USA Gymnastics Junior Olympics program. About 1,800 Level 10 gymnasts compete in the U.S. during the season and 900 make it to their respective state championships. Another 300 make it to regionals, and out of those 300, only 56 go to nationals.

"It definitely means a lot of college

exposure," Ryan said. "In the (Division I) world, that's what they're looking for. People who choose the Elite (path) have to make it through nationals first. Those girls are the ones trying to go to the Olympics right now but being one of those 56 is a very difficult thing to do because you have to be able to do our very best one day."

This year wasn't the first time Ryan

had qualified for nationals. She would have gone two years ago, but she hurt herself at the regional meet. She was more nervous at this year's regional meet because success there meant a trip to nationals.

"It was definitely less nerve-racking than regionals because in the back of your mind, there is nothing else after this," Ryan said. "This is the

grand finale. This is where you want to make it, but obviously you want to do good because you want to make it into a college, so I was pretty nervous going into it because it was such a big meet."

And she calmed herself down and did fine, showing that the work pays off.
