Solar project eyed for Plattekill

The community is becoming greener as the Plattekill Planning Board continues to make progress on developing a solar project in Highland.

Carson Power — a company building solar and storage power plants — is making strides to develop this project as part of its progress in building out widespread distributed generation solar work across New York state. An eight MWac (megawatts of alternating currents) community solar project, Ohioville Solar A & B LLC will be located at 139 Crow Hill Road. According to Nicholas Cunha, a senior project developer at Carson Power, the Highland undertaking marks a significant element of New York's 2019 Climate Leadership and Community Protection Act in order to achieve an emissions-free electrical system by 2040.

Carson Power has been working with the Plattekill planning board to evaluate

certain criteria in order to ensure the development will not have an adverse environmental impact, called the Seqr process.

"Endangered species, stormwater management, visual impact, historical resource impact — those are all the things we have to kind of prove we aren't having a negative impact on," Cunha said.

Solar farms generally consist of large chunks of land holding solar panels that harness energy from the sun and convert it into electricity.

This project has been in the works for a little over a year, as the previous landowner was hoping to transition the use of his land and had approached Carson Power with interest. Cunha expressed gratitude towards planning board chairman Richard Gorres and MHE engineering, as well as other members of the board who have contributed to making this development possible, especially in ensuring it complies with the town's zoning codes and regulations as well as addresses the needs of the broader community.

In New York, whenever over an acre of land if disturbed, a planning board or similar jurisdictional body must review. At Tuesday night's meeting, the engineering firm had looked over the stormwater plan and some of the site plan adjustments made, which they walked through with Cunha.

"What did come out of it is they referred the project to the county for review, so that was kind of the major outcome of that meeting." Cunha said.

At the meeting, the board was also discussing diversifying the tree species in the location in order to prevent all of the trees from dying out should they fall victim to any kind of invasive bug or other issue. The Ohioville Solar plans also state that the project is located in a New York agricultural district, so contractors must comply with guidelines set forth for solar energy work, like taking soil samples to a laboratory per Cornell University soil testing guidelines before removing any topsoil from the location.

The project plans also included some more general notes like mandating the contractor restore "lawns, driveways, culverts, signs and other public or private property damaged or removed to at least as good a condition as before." They must additionally be held accountable for dewatering and upholding the maintenance of surface drainage and groundwater throughout


the course of construction, among other responsibilities.

Increased local, distributed generation makes the grid more resilient while also providing discounted electricity toward locals who decide to subscribe to the project upon its completion and operation. Residents would likely get a letter in the mail asking if they would like to subscribe and opt into having their electricity be contrived from a renewable resource, as it is a shared asset.

"If you opt in, then you usually get some benefits from that," Cunha said. "Every utility is different. Usually it is a discount off your bill. In essence, that is how community solar works, and that is what would come out of this project."

While the team is still developing several projects across the Hudson Valley, Cunha highlighted their recently received conditional approval for the Fair Oaks Solar project from the Wallkill Planning Board.

There is no set date for a public hearing as of now, but Cunha said they are looking at possibly scheduling one for some time in August if everything goes well.



Metzger announces launch of 'Safe Start to Summer 2024' road safety campaign

Ulster County Executive Jen Metzger announced Monday the launch of "Safe Start to Summer 2024," a three-week road safety campaign to raise awareness about the dangers of speeding and distracted driving, promote a culture of safety and respect on roadways, and help save lives.

The campaign is a collaboration among the Ulster County Executive. Ulster County Transportation Council, Ulster County Traffic Safety Board, Office of the Ulster County Sheriff, local governments, and state and local law enforcement. It involves both public education and enhanced enforcement of traffic laws at specific locations around Ulster County. The enforcement program will take place from July 1 to 14 at locations identified by local governments and law enforcement, or based on data from the Ulster County Transportation Council indicating a higher-thanaverage risk of traffic incidents. The public education campaign will begin this week and continue through mid-

County initiatives aim to address growing problems on roadways with distracted driving and aggressive driving, which has been on the rise since the pandemic. In her State of the County address, Metzger announced plans for road safety initiatives in the wake of several tragic motor vehicle incidents, including a crash on Route 28 in Shandaken and hit-and-run incidents in Saugerties and New Paltz that claimed four young lives. A third hit-and-run incident occurred several weeks later in Marlborough, resulting in two more deaths.

"Every life is valuable, and we have to work together to make our roads in Ulster County safer for drivers. cyclists, and pedestrians alike," said Metzger. "With the school year ending and more young people out enjoying the summer, and with the influx of summer tourists we typically see, this is a good time to raise awareness and encourage safe and responsible behaviors on our roads. I want to thank all of our partners, including the Ulster County Sheriff's Office, the Ulster County Transportation Council and Traffic Safety Board, State Police. and the many local governments and law enforcement agencies for their enthusiastic support and participation in the 'Safe Start to Summer' campaign. This is the first of a number of road safety initiatives we are planning for the coming year."

"The last few years have seen the

disregard of traffic laws causing preventable deaths," said Ulster County Sheriff Juan Figueroa. "Traffic safety is the responsibility of all on the road, whether driving, walking, on a bicycle or motorcycle. Pay attention to traffic laws, don't be distracted by cellphones, and save lives."



Lloyd moving forward with streetscape project

At last week's meeting Lloyd Supervisor Dave Plavchak updated the board and the public on the status of the Highland Hamlet Streetscape project. He noted that the town has received a grant from the Federal Emergency Management Agency [FEMA] to bury utility cables underground in the hamlet that is slated to be done just after the sidewalks are torn up and prior to installing new sidewalks.

"We did get a contact from Central Hudson who will work with [engineering firm] Barton & Loguidice. I'm sure, as with everything with utilities it will be a little longer process than we all like, but we'll work through that. The other thing we did this week was about an old grant of \$777,000 from 2017. We had cut some scope out [of the project] from Commercial Avenue doing some right-of-way work that we knew with the costs rising we weren't going to do it. At the same time this week there was some additional money available to communities from the Carbon Reduction Program and we were able to get \$200,000 of that, so our budget went from \$777,000 to \$977,000 so that should help us with all of the increasing costs that we've had prior, so we'll start moving forward."

Playchak said they had discussed splitting the project into phases, beginning with the sidewalks on Eltings Place from the Library to the Middle School crossing and down to the parking lot followed by a second phase in the area that will be affected by the utilities.

Pavilion work

Councilman John Fraino said the Water Department, with help from the Highway Department and their equipment, have installed sewer lines to the



new pavilion at the town field.

"They finalized that today and got past the laundromat and the water line is in, so all the utilities are now to that pump station. The electrician finished up from the transformer to the electrical panel, which is also in, and now the pump station is wired in. We quickly got a J number that is required for an electrical inspection and are waiting for the inspector to come look at the entire job."

Fraino said once that is completed, Central Hudson will hook up the transformer, "on the one end by the charging stations and then turn that panel live. We ran the utilities up into the building and stopped there."

Fraino said the architect is working on the final design of the restrooms and storage areas in the pavilion. A preliminary review will be done in early July, at which time bids will be sent out to contractors to do the work. Once that is done the final utility work can be completed. He noted that the process is taking a little more time but town employees are being used, "and we have to work around their normal duties. We're saving a considerable amount of money, but we're doing it when the Highway and Water Department crews are available...and hopefully finish it up in the fall."

At the Privilege of the Floor, resident Karen Angel returned to address the Town Board, stating there is bullying in Highland and also touched upon the sexual hazing incident at the Middle School last year

"It's not a question whether there is a problem with the culture in Highland, it's a foregone conclusion; it is obvious, so you need to deal with it one way or another," she said.

Angel said the Town Supervisor ranted about the fact that she did not stand for the Pledge of Allegiance, "which is my First Amendment right. I'm not going to stand with people who I don't believe are following the same moral code; I'm not gong to lump myself in with you. A few minutes after I left [previous meeting] Dave Plavchak lied about several things, which I have proof of and documentation."

Angel said the Supervisor lied when he said he had no knowledge about a flier that was distributed showing an X through her neighbor's head as well as an accompanying email.

Councilman Lenny Auchmoody was about to interrupt, but Plavchak and Angel urged him to let the discussion continue and remain professional.

Angel said at her previous appearance before the board, a former Town Supervisor [Fred Pizzuto] said, "Get that dog away from me," referring to her small fox terrier, and that he added, "Don't let the door hit you on your way out." She said his comments implied threats of violence. She added that she did

not say she wanted cameras installed all along North Eltings Corners Road at the last board meeting. When Plavchak said her time was up, Angel said she will continue coming to further Town Board meetings to finish her comments.

As Angel was leaving the meeting, Councilman Auchmoody told Angel in a raised voice, "Before you leave, listen to me, you don't stand for the Pledge of Allegiance, I will never do a thing, not a thing, to help you out even if you have a real problem."

The meeting deteriorated into a shouting match, with Plavchak urging Auchmoody to stop, saying it is not necessary, but he continued, saying Angel is a "zero."

Plavchak countered Angel's accusations.

"She was offended because I used a single-use plastic [water] container and I said I am offended that you didn't stand for the Pledge of Allegiance, that's what I said and personally we're not going to stoop to that same level on this board."

Auchmoody said, "Evidently it means more to me than it does to her. She just comes in here and complains about everything that we do; she needs to move away."

Councilman Mike Guerriero reminded the board that Angel is a resident of the community and has a right to voice her opinions to the Town Board.

"I just don't want to discourage anybody else out there that ever wants to come to a Town Board meeting to express themselves to say they're going to be yelled at; I don't think that's right," he said.

Playchak agreed, adding that he was not going to spend more time on the matter.

"It's her opinion and she's entitled to it," he said.

Councilman John Fraino said he wished Angel would "make a point of something we could address to work on. She calls people names and I find that distasteful."

Police Hire

The board approved hiring Matthew Dubois as a part-time Dispatcher at the rate of \$19.82/hr at the recommendation of Chief James Janso. He started on June 27.

Janso said Dubois is a native of Highland and is "looking for an opportunity so we're going to see how he works out with us." Supervisor Plavchak wished Dubois good luck, adding that "you're on a great [police] force and you're with a great team and we wish you all the best."

The board noted that the town's Independence Day celebration along with a fireworks display is scheduled for Saturday, July 6, rain or shine.


Highland honors the Class of 2024


Superintendent Joel Freer said the Class of 2024 has, "grown so much since their first days in kindergarten

Class President Fallon Carolyn Grace led in the Pledge of Allegiance followed by National Anthem sung by the Marlboro High School Select Chorus.

Marlboro Superintendent Michael Rydell said it is an honor to open the ceremony, starting off by saying he is "proud of being your Superintendent and honored and proud of being the smallest of slivers in each of your lives."

A call for sensible policy on charging stations

he recent situation involving Thomas Costa, owner of North Plank Road Tavern in the Town of Newburgh, highlights the pressing need for municipalities to adopt clear and supportive policies for electric vehicle (EV) charging stations. Pulling the garlic

t's a little tricky. I don't want to be too early, but being late is worse. Harvesting garlic, like most things we grow, it's all about timing. Ideally, garlic is harvested when the meat of the cloves begins to separate from the tissue of the paper surrounding the cloves. Even if the roots look deep and strong,

it is not going to grow anymore. Scientifically, you can tell this by slicing a head of garlic in half, equator-wise, and looking at what is going on inside the garlic head. I was taught this by a Cornell University Ag School vegetable expert. In a more in-field observational anecdotal way, my old Jamaican friend, Rupert, would call this stage of the garlic, "ripe." "It is ripe," he would declare, or "It is

full." "Richie, they are full," he would say with pride, the head of garlic lying, uncut, in the flat of his smooth palm.

One of the variables in predicting the harvest date is the planting dating. Because we planted 15,000 cloves by hand, some garlic was planted two to three weeks earlier than others. Plants, even garlic, have a limited life span. They mature of their own accord, at their own rate. We have planted six varieties of garlic in two different field environments and certain varieties, as another variable, mature earlier in their life cycle. Some types just don't live as long.

One of our varieties this year is Spanish Roja. I tried growing some this year in both our upland "hill" soil and some in our "black dirt" field. The demand for Roja was very high last year at the garlic festivals and few growers seemed to have

any. One main Roja grower from upstate was missing and this created a panic, not quite a Tulip Panic, but a panic nonetheless! All of our Spanish Roja, in both fields, is ready to pull. Obviously, it is an "early" maturing variety. It can't stay in the ground through another rain cycle. It will begin to burst. When a garlic head is past its ideal harvest date, it can begin to grow outside of itself, to expand to the point where, if left alone, it will just begin growing again for next year, one big pod of garlic.

We are pulling the Spanish Roja on the hill today, trying to beat the rain. We pulled the Spanish Roja from the black dirt on Wednesday and it is hanging in the shed, sorted, tied, and drying, with a fan circulating air around the bundles to cure the heads.

When I say "pulling," that is aspirational. The quickest and easiest way to harvest garlic is to grab it by the stalk with both hands and pull it out of the ground - hence, "pulling" the garlic. Unfortunately, many times the garlic will not release from the soil, and in the black dirt we found the roots were so deep it was necessary to dig most of the heads. I took a shovel and sank it in next to two heads as close as I could get without the blade of the shovel damaging the bulbs and lifted the soil, bulbs, and whatever weeds were nearby, while my helper, Elhadji, pulled the heads out of the ground by their stalks. We brushed the lingering soil off the roots by hand, and carefully stacked the garlic plants, gently, in a plastic crate. or bushel basket, for transport to the back of the Tacoma. Any roughhousing can create bruises on the green, uncured garlic. Handle them like you would peaches!

We are just small timers. Some farmers use a blade attached by three-point-hitch to a tractor and drive down the whole row, four or five heads wide, and undercut the entire strip with the blade underground like a flat broad knife, plowing

it, lifting the entire row from the ground, and loosening the garlic for pick up by a field helper. Oddly, the garlic in the brown dirt of the hill is easier to pull. We were able to harvest two of the three rows of Roja before the rain today. The Roja is stacked on tables on the edge of the field, the roots all in one direction and covered with tarp until I get there to sort, tie, and transport the graded bundles to the drying sheds.

Any ill-formed, diseased, or damage bulbs must also be harvested to help keep the soil free of pathogens, and these damaged bulbs must be dug by hand and set aside from the general crop. Good to eat, but not to sell or plant, this is the farmer's bounty, and I love garlic and cook with it almost every time I cook.

We have a long way to go but have a great start to the "pulling of the garlic." Just wait 'til we get to that "Giant Russian Purple." Oh baby. They need another week or two to reach full maturity, which is great because that gives me time to get in the bees and spin out some honey.

Listen Up!

I live within a one-block radius of four churches. While I respect everyone's right to worship whoever, whatever and wherever they choose, but at the same time it should not infringe upon those who don't follow that faith. Churchs' impact on the neighborhood goes beyond just the influx of parishioners and resulting traffic congestion, lack of parking and overabundance of double-parking. While I'll spare you my own opinions on the overwhelming number of "churches" in Newburgh and their impact on the city; rather I'd like to discuss how one church who egregiously impacts the neighborhood. We need to address an issue with a specific church: Life Restoration Church, Inc. Located on the corner of 1st and Chambers Streets, its battered building occupies half the block on both streets: a scale that has an outsized impact on its neighborhood.

The specific situation happens EVERY Sunday morning when services start at 9:00 am and the neighborhood is forced to listen to an amplified version of the sermon. It should be understood that the church purposely puts a professional-grade amplifier speaker outside the building on Chambers Street. If you live within a multi-block radius of the church, you are forced to endure the sermon, music and noise for three hours every Sunday.

It is the congregation's prerogative to worship

as boisterously and exuberantly as they want but this noise level goes beyond simple ambient noise emitting from inside the building. Higher than any noise level we're accustomed to being a part of the urban fabric with the regular block parties and backyard barbecues. It's more than mere ambient noise, reaching levels that prevent neighbors from being able to experience a tranquil Sunday morning in their own homes. I am fortunate to have a patio, but for those three hours, it's impossible to work, read or simply enjoy a cup of coffee.

Even with the windows closed in your home, the decibel level exceeds what one would reasonably expect to emanate from a home or business and while muffled can still be heard. This church purposely broadcasts the service across the entire neighborhood, exhibiting a callous disregard for the community's personal religious beliefs or a simple desire to work, relax or sleep without interruption. Only on the colder or wetter Sundays does the neighborhood get any reprieve when it's prohibitive to have the amp outside. Otherwise, neighbors have no other recourse than to hope for rain for any respite.

It is inappropriate to broadcast the service weekly so loudly that neighbors who are obligated to listen and are forced to worship-by-proxy. This is hardly the example of tolerance and inclusivity one would hope to experience in a city that prides itself on upholding these virtues. Additionally, it's arrogant to think this represents being a good civic citizen in the larger community. What's more astounding is that the preacher and owner of the church is our esteemed City Councilmember Robert McLymore. More astoundingly is that a city leader and police officer would purposely flaunt civic responsibility and laws concerning excessive noise in Newburgh.

Several attempts to address the issue have been made; registering multiple requests on the SeeClickFix app which suspiciously disappear after being logged. Emails to the Codes Department go unanswered and unreturned. I've considered reporting this to the police on Sundays but I recognize that they have more important matters to handle and if I did they would follow the same pattern of dismissal as previous requests. With a city already dealing with perceived corruption — whether accurate or not — you would think a city leader would conduct themselves in a manner befitting their role.

With this letter, I am hoping that Councilmember McLymore addresses the issues and concerns of the citizens he represents. From speaking with neighbors, I am not alone in this frustration and want change. Sunday mornings in Newburgh, especially in the summer, have always been amazing; with little to no traffic, it offers a quiet and peaceful opportunity to revel in the sunshine.





I, Steven M. Neuhaus, County Executive of the County of Orange, State of New York, do hereby declare as an EXECUTIVE ORDER the following:

WHEREAS, to date New York City (hereinafter the "City") has transported 186 homeless persons to Orange County (hereinafter the "County") and has caused two hotels/motels within the County to be converted into illegal homeless shelters; and

WHEREAS, the City has previously represented that it will only pay for such shelter up to a limited date and has no long-term solution for housing their homeless within the County, which is in violation of New York State Social Services Law and related Administrative Orders pertaining thereto: and

WHEREAS, the City has repeatedly failed and refused to adequately address the needs of the homeless population in New York City, and has decided by its actions and inactions to abdicate its duty and responsibility to those homeless persons, necessarily transferring said duties and responsibilities to the County of Orange County Government, in violation of state law: and

WHEREAS, on May 9, 2023, the State of New York declared a state of emergency as to New York City's homeless population and its inability to adequately house and provide for such persons; and

WHEREAS, there is no reason to believe that the homeless persons presently here will leave Orange County after the City ceases to pay for the short-term housing and any services they are presently receiving; and

WHEREAS, local zoning codes do not allow use of temporary residence hotels or other temporary residence facilities for use as long term residential housing and therefore the City's transportation of homeless persons to the County for that purpose is illegal; and

WHEREAS, through enforcement of local zoning codes, said homeless persons will face refusal, or eviction from the illegal hotels and short-term residential facilities, resulting in an imminent large-scale housing crisis in the County and

WHEREAS, as all temporary housing shelter beds in Orange County are currently at maximum capacity and cannot accommodate additional homeless individuals: and

WHEREAS, there is a reasonable apprehension of immediate danger of public emergency of potentially thousands of persons being transported to Orange County in violation of state law as referred above, resulting in Orange County being responsible for the public safety of these persons and all others affected in Orange County; and

WHEREAS, the County is not capable of receiving and sustaining such volume of homeless persons that the City has, intends to, or hereafter does transport to the County, whose presence will gravely increase the number of people in need of government services across various sectors in the County; and

WHEREAS, the locations to which New York City Mayor Adams has previously transported said homeless persons have inadequate infrastructure to meet the needs of said individuals, including but not limited to transportation to work, food, medical care, and pharmaceutical opportunities; and

WHEREAS, the County anticipates potential civil disobedience and protesting on this issue both for and against the transportation of homeless persons to Orange County, and

WHEREAS, that due to the above circumstances, I find reasonable apprehension of immediate danger thereof that public safety is imperiled thereby, for not only the New York City homeless persons illegally transported to Orange County by New York City, but also to the other affected residents of Orange County; and



Town of Lloyd raises escrow fees

By MARK REYNOLDS mreynolds@tcnewspapers.com

The board approved a resolution that raised a number of fees in the fee schedule for escrow accounts: the initial deposit per lot for a Lot Line realignment/revision from \$250 to \$350; the initial deposit per lot for a subdivision from \$250 to \$350; the initial deposit per lot for Special Use permits from \$200 to \$300; the initial deposit for a WBOD Site Plan Review for residential and non-residential accessory structures that would not trigger full site plan review from \$200 to \$300; and the initial deposit for Short Term Rentals is \$400. All categories have a provision for \$100 minimums.

Supervisor David Plavchak said the reason for the increases is because of the costs of mailing all notices has gone up significantly and the cost for the town's engineer and attorney fees have also gone up significantly.

Councilman Mike Guerriero noted the fees have gone up by one third for the escrow money.

"I think that's kind of steep because applicants come and the things they have to do and they have to put money out upfront; that's my opinion," he

Guerriero said when applicants are asked for more, do they get a bill?

Playchak said applicants can ask to view all of the invoices and if money is left over at the end they will get it back.

Councilman Guerriero voted no and the rest of the board voted yes, resulting in a 4-1 tally.

Sojourner Truth statue to be displayed in Kingston, Newburgh

SUNY New Paltz President Darrell P. Wheeler and Kingston Mayor Steve Noble have announced that "Sojourner Truth: First Step to Freedom, 1826," a bronze statue of the 19th century civil rights activist with deep Hudson Valley roots, will be temporarily exhibited at Kingston City Hall later this year, and then a site in Newburgh that will be named at a later date, before being installed permanently on the

The statue, created by Ulster County artist Trina Greene, depicts Truth in the year during which she escaped enslavement, a key pivot point in a life devoted to historic and effective advocacy for abolition, temperance and women's rights.





The Naturals scored seven runs in the fourth inning, but the Marlboro Marlins came back for a walk-off win on Thursday at Young's Field in Milton.


