

CITY OF MINNEAPOLIS LANDSCAPE REQUIREMENTS:

NOT LESS THAN 20% OF THE SITE NOT OCCUPIED BY BUILDINGS INCLUDING ALL REQUIRED LANDSCAPED YARDS SHALL BE LANDSCAPED:

SITE SF NOT OCCUPIED BY BUILDINGS = 62,834

LANDSCAPE AREAS:

A LANDSCAPED YARD OF AT LEAST 7 FT WIDE SHALL BE PROVIDED ALONG THE PUBLIC STREET, PROPERTY LINE, SIDEWALK OR PATHWAY EXCEPT WHERE A GREATER YARD IS REQUIRED.

PARKING LOT SCREENING CONSISTING OF EITHER A MASONRY WALL, FENCE, BERM OR HEDGE OR COMBINATION THEREOF THAT FORMS A SCREEN 3 FT IN HEIGHT AND NOT LESS THAN 60% OPAQUE SHALL BE PROVIDED.

NOT LESS THAN (1) TREE SHALL BE PROVIDED FOR EACH 25 LINEAR FT OR FRACTION THEREOF OF PARKING OR LOADING AREA LOT FRONTAGE.

IN PARKING LOTS OF (10) SPACES OR MORE, NO PARKING SPACE SHALL BE LOCATED MORE THAN 50 FT FROM THE CENTER OF AN ON-SITE DECIDUOUS TREE. TREE ISLANDS LOCATED WITHIN THE INTERIOR OF A PARKING LOT SHALL HAVE A MINIMUM WIDTH OF 7 FT IN ANY DIRECTION.

SCREENING IS REQUIRED IN ALL PARKING AREAS FRONTING ALONG A PUBLIC STREET, PUBLIC SIDEWALK OR PUBLIC PATHWAY. SCREENING SHALL BE SIX (6) FEET IN HEIGHT UNLESS AND AT LEAST NINETY-FIVE (95) PERCENT OPAQUE


